

DIRECTOR'S MESSAGE

I don't recall offhand any time since I have become involved in UFOlogy that rumors and tales have been occurring on so many fronts and at such speed at which events are currently happening!

On the one hand, we have the Hale-Bopp Comet, discovered only a few months ago. The size alone of this comet seems to be outstanding. It also appears to have changed direction several times, and its closest approach to Earth is scheduled to be sometime in March of 1997.

Only a few weeks ago a companion object has been detected close to this comet; it's existence seems to have been confirmed by at least three observatories at the present time. This object is larger than Earth and is said to be sending radio waves which have been picked up by several radio telescopes.

The additional rumor is that a noted astronomer will soon step forward, perhaps by the time you read this Newsletter, to verify this story . . .

CURRENT EVENTS

Many of us clinicians who work with experiencers frequently get asked by our experiencer clients whether we think they are crazy. Some of us occasionally lapse into such moments of self-doubt ourselves. Solace comes from the establishment press. According to a poll released by Newsweek magazine dated June 30, 1996, over 48% of those interviewed believed that the Unidentified Flying Objects reportedly witnessed are actually real. Nearly half (49%) of all Americans think that the government is hiding proof of the existence of UFOs from the general One in eight said they public. personably had seen objects they thought were UFOs. These figures concur with a Scripps-Howard Newspapers poll taken last year, which asked similar questions.

As long as we're on the clinical topic of reality testing, UFOs and extraterrestrial encounters are not the only anomalous activities currently receiving worldwide attention. A report by Peter Sorensen states that on June 17, 1996, in England's ancient Alton Barnes site, a spectacular crop circle appeared. This enormous crop design was 648

feet in length, consisted of "double helix," DNA-type twin strands made from 89 circles of varying sizes. Three weeks later, on July 8, south of the famous Stonehenge monolithic monument, an elaborate crop circle appeared which was comprised of a series of Julia sets. the crop design was 900 feet in length and 300 feet The Julia set is a pictorial depiction of fractal mathematical relationships within a Mandlebrot set, related to Chaos Theory. This crop design appeared during the 15-minute period between two fly-overs by planes in the area.

Many ET-contact specialist clinicians are finding that intermixed with their cases of extraterrestrial encounters are a few other cases of a most disturbing nature. other reports involve experiencers (and other civilians) who have been forcibly kidnapped by military and other governmental personnel, taken to remote installations, interrogated, often abused or raped, drugged, and had their memories hypnotically reprogrammed to misremember the kidnapping as an "alien abduction" or to forget it altogether. sometimes the victim was hypnotized to misremember aliens as being involved in the kidnapping. While these reports are often difficult to verify, the following information obtained from Freedom of Information Act documents may offer some insight. Among documents recently obtained from the White House is interesting correspondence between Naval Intelligence Commander/Human Potential Foundation director scott Jones, Ph.D. and White House Presidential Science Advisor John Gibbons, Ph.D. In a February 17, 1994 letter, following up on a White House meeting between Laurance Rockefeller, Dr. Jones, and Dr. Gibbons on February 4, Scott Jones "Whatever Roswell [UFO crash revelation] turns out to be, it is only the opening round. I urge you to take another look at the UFO Matrix of Belief that I provided you last year. My mention of mind-control technology at the February 4 [White House] meeting was quite deliberate. Please be careful about this. there are reasons to believe that some governmental group has interwoven research about this [mind control] UFO technology with alleged phenomena. If that is correct, you can expect to run into early resistance when inquiring about UFOs, not because of the UFO subject, but because that has been used to cloak research and applications of mind-control activity."

SETBACK FOR SAGAN

Ailing astronomer Carl Sagan, who underwent a bone-marrow transplant 15 months ago, is back in the hospital for diagnosis and treatment of a blood disease. Tests in Syracuse, NY revealed abnormalities that could indicate a recurrence of myelodysplasia, a condition that can lead to leukemia, a Cornell University spokesman said. The 61-year-old Sagan returned to the Fred Hutchinson Cancer Research Center in Seattle last week.

"The contention seems, to me, extremely improbable, because the Air Force is fighting budget reductions. If we were in the midst of an alien invasion, what a

wonderful opportunity for the Air Force to increase its budget."

For a guy who's done so much for our understanding of the cosmos, Sagan is a real stick-in-the-mud when it comes to popular culture's preoccupation with the paranormal.

SAN PEDRO RIVER CASE

Subject: Preliminary Sighting Report
Cochise Case #830612A(CE3)
Investigator: E.C. (Whitey) Reese
Type: Missing time, craft, humanoids
Date/Time of Sighting: 11 or 12
June 1983, approx. 2300 hrs.
Place of Sighting: Route 90 crossing
San Pedro River near Sierra Vista,
AZ.
Local Evaluation: To be determined.

Background: After local publicity in newspapers and radio about MUFON organizing in Cochise County, a male witness [who insists that he remain anonymous] called me on the phone on the morning of 13 October 1996. He reported that during June of 1983 he and a girlfriend had a "missing time" incident during which he recalled seeing a landed UFO with several humanoids around it. I made appointments for personal interviews.

Sighting Account: On a household moving trip from Lordsburg, NM to Sierra Vista, AZ (left Lordsburg at 2100 hrs MST sharp and arrived at Sierra Vista at 0030 hrs MST the following morning) during June of 1983, the witness's girlfriend, who was driving, saw a large humanoid standing by the roadside somewhere west of Texas Canyon on I-10. the prime witness (riding as a passenger) did not see it. Shortly a bright "starlike" light paced their vehicle. A little while later the vehicle seemed to "drive itself" with no control by the girlfriend. After they turned off I-10 onto Arizona Route 90 the witness saw a bright light flash high in the sky to his right. Still later and farther down the highway, the witness found that he was in the driver's seat, his companion was riding in the passenger seat, and they appeared to be on a different highway unknown to him at the time. When he turned off onto a gravel trail to the left in

preparation for turning around, he saw a large disc-shaped craft in front of the vehicle with eight or nine short humanoids milling around it. three of them started to approach the vehicle. and the witness remembers nothing else until they appeared to be traveling on the proper highway again, with the witness still driving. The trip from Lordsburg to Sierra Vista took 3-1/2 hours without any planned stops. the witness stated that the vehicle had been traveling continuously at 65 mph or more. After undergoing a personal interview lasting about 2-1/2 hours and a planned interview, second witness believes he has found the location where the craft and small were seen. interview lasting about one hour and 15 minutes followed, and this second interview was recorded transcribed. the witness and this investigator have made plans to visit the suspected site of the craft sighting, but plans have been delayed due to road and bridge construction in the area. A gentleman's agreement between the two of us prevents the investigator attempting to locate the witness's girlfriend for a specified length of time, as the witness is planning a relocation in about five months. Upon the witness's relation, attempts to interview the girlfriend will be made, provided she has been located by then. A MUFON Field Investigator from another state and/or section will more than likely be recruited to aid in the investigation, depending on where the girlfriend is located.

Present Status of Investigation: Interviews totaling roughly four hours have been accomplished thus far with the witness. His recall has improved somewhat with the interviews, but the possibility that the witness is also gradually building the case tighter as we move along is still a good possibility. He still recalls nothing about an actual abduction, but I rather suspect at some point he will start recalling something about that, also. A quite thorough investigation into the witness's credibility is planned.

It is projected that this investigation will cover a rather long time span, possibly another seven to eight months. I will keep you informed.

BOOK REVIEW Encounter at Buff Ledge, A UFO Case History

CUFOS, Chicago 1994; \$19.95 in Trade Paper; Extensive footnotes, diagrams, photographs, bibliography, and index. 306 pages.

Those who suggest that no serious scientific methodology has ever been applied to the study of UFOs are invited to peruse Encounter at Buff Ledge. Regrettably, this is also the book to read if you really want to fall asleep in a hurry! And it seems unlikely that it will show up as an inexpensive paperback reprint, for it lacks the dramatic tension that one finds in the near-fiction accounts of Whitley Strieber, Raymond Fowler, and other authors of the UFO genre. This is a classic encounter tale. We have read about similar events in numerous anecdotal abduction accounts.

Nevertheless, because this work stands as one of the most thoroughly researched and documented UFO abduction episodes ever reported, it illustrates very clearly the painstaking methods which must be used in UFO research if scientific credibility is to be obtained for these persistent and perplexing events which are so easily dismissed by those who will not listen to the messenger unless he or she is wearing the royal robes of scientific methodology.

The August 1968 abduction involves two young camp counsellors, "Michael and Janet," at a summer camp on Lake Champlain near Burlington, Vermont. Separated by circumstances for 11 years immediately after their twilight encounter, the abductees were extensively and separately interviewed and tested over a five-year period during which numerous other witnesses and corroborative detail emerged. What is unique

about the treatment Webb offers is the lesson he furnishes in how to conduct a credible investigation. Here are only a few gleanings, reminders, and recommendations from his effort:

- Malleable memory which allows events to be reconstructed with each retelling demands that investigations begin as soon as possible after the event and that the subjects be allowed initially to completely tell their story using a tape recorder without interruption and without questions.
- A UFO designation should be assigned to a case only after a persistent and dedicated effort has filed to turn up a conventional answer for the observation.
- It is almost impossible to avoid leading questions in sessions of hypnotic recall. Abductee regression stories no doubt contain some mixture -- and the proportions are critical -- of fact, fantasy, and creative imagination.
- 4. Abductee experiences tend to be more reliable than contactee experiences. The latter are anxious to share and often embellish their stories while the former are reluctant to draw attention to themselves and the trauma they experienced.
- Psychic interpretations of abduction events, e.g. birth trauma imagery, Jungian archetypal symbols, and seismically generated hallucinations, fail to account for multiple witness close encounters, physical traces and physiological injuries detailed in studies such as Webb's.

Quoting MIT Professor Philip Morrison, Webb reminds us that "... a witness's statement should be regarded in much the same light as the reading of a barometer or the printout of a computer. A large number of judgments, inferences, assumptions, and hypotheses are necessary to interpret it. The analysis of that chain is the essential feature of scientific evidence."

One wonders if the shear weight of the contemporary chair, of anecdotal evidence and some future major media event will not render all such scientific "analysis" somewhat inconsequential. Most of us do not need to know why our computers work, or phone calls go through, our lights come on, and why sex and religion work. We merely accept that they do and proceed to use them. So may it be with some future mass acceptance of these anomalous phenomena.

For thirty years (since Webb's first research into the "Interrupted Journeys" of Barney and Betty Hill) we have found UFOs intriguingly titillating and intellectually interesting. Now they are fast becoming a working, some would say mythic, fact of everyday life. A fact which may never be fully understood.

Kind of like Life, the Universe, and Everything, 42!

AN EVENING WITH ZECHARIA SITCHIN

Zecharia Sitchin spoke at the Mesa Community and Conference Center on November 6th to introduce his latest book, Divine Encounters, the seventh in a series which began with the 12th Planet, published in 1977. There was an attentive audience of about 400-450 people out to hear him. His talk included extensive slides to illustrate key points. There were no questions and answers after the talk, which is unfortunate.

Is it possible that intelligent extraterrestrial life visited this planet some 400,000 years ago and had a lot to do with the development of the species we now know as humans through biogenetic engineering? This is a basic premise of Sitchin's writing and research. He says these visitors to Earth bio-engineered a human species, using hominid types that were already here to create a more intelligent work animal which they could use in their mining operations on this planet. He talks about this in his first book, the Twelfth Planet.

Sitchin defines himself in one word as a reporter. He reports today what people in antiquity knew. By

dealing with the past he believes he is dealing with the future.

On his various tours/expeditions. participants have asked him how he happened to be on this trip and be involved in this research. He said it all started as a school boy in Palestine. He studied the Bible in its original Hebrew. He referenced Genesis, Chapter 6--the Great Flood. He asked his teacher why he used the term "giants of the earth." His teacher criticized him for questioning the Bible.

He was further led to study ancient mythology. His study of all these mythologies (Greek, etc.) really stemmed from one source--the Sumerian civilization. It appeared between the Tigris and Euphrates Rivers" now known as Iraq about 6,000 years ago. This highly developed civilization appeared suddenly and it aroused Sitchin's curiosity as why it appeared in this

His talk this evening would take us on a journey--beginning 6,000 vears ago-with Sumerian civilization. They are credited with 100 firsts which have survived to our times. including the invention of the wheel, development of cuneiform writing, and use of clay tablets among many others. They used writing to record mythological tales, contracts, laws, and proverbs. They created music and instruments to play it. They had very sophisticated mathematical knowledge.

Most amazing, he said was Sumerian knowledge in the field of They had accurately astronomy. measured the distances between the planets. They could predict lunar eclipses 50 years in advance, for example. The Sumerians were the first to describe the earth's progression through the twelve constellations. Zodiac descriptions came from them.

Sitchin asked how the Sumerians could know these things 6,000 years ago. They claimed they were taught by the Annunati--ancient astronauts from another planet. How did communication take place between the Sumerians and these visitors? Dreams were a very important method of communicating between the visitors Sumerians. An example

he used was the Sumerian who dreamed of a tablet with a building's architectural rendering. When he awakened, he found that tablet near

The Sumerians also had a knowledge of DNA and genetic engineering.

In his slide show, Sitchin showed a number of slides depicting objects of clay showing what looked like ancient astronauts. Perhaps they are of the Sumerians source advanced knowledge of astronomy. He showed a slide depicting the Sun and twelve planets in our solar system lined up in proper perspective. (There are nine known planets and astronomers believe there may be a tenth.) The Sumerians referred to the Earth as the 7th planet, not the third. This would be counting from the outside in. An astronomer who had read one of Sitchin's books said if the Sumerians referred to earth this way (7th planet) "everything else must be true in your book.'

Sitchin's theory is that a planet he called "Marduk" collided with another planet in orbit between Jupiter and Mars, splitting it in half. One part changed orbit and became what is now known as Earth. The other part became the twelfth planet with a long elliptical orbit, coming near our planet every 3,600 years.

Ancient maps depict South America near the continent of Antarctica" without an ice cap. These maps come from Mesopotamia --possibly Sumeria. Part of Sitchin's theory is that the ice cap was caused to slip into the ocean by the gravity exerted by the orbit of The Twelfth Planet which passed near to earth on its 3,600 year elliptical orbit. It is part of Sitchin's theory that this other planet periodically swings by our planet potentially wreaking great havoc and earth changes in its close passes to the Earth. Are we due for another close pass soon?

Sitchin further theorized that, before the Jews lived there in ancient Jerusalem served as a command/control space center. He showed a slide showing an aerial view of the area. Mars then served as a "way station" between the twelfth planet and the Earth.

All in all, Sitchin's talk was a fascinating 2-1/2 hours and this brief summary does not really do it justice. I saw a number of MUFON members there and I'm sure they found it as stimulating and thought-provoking as I did.

Scientists hope to catch 'the face' again

One of the strangest images the Viking mission ever sent to Earth 20 years ago was that of "the face," a mile-long humanlike visage on the surface of Mars.

NASA says the face is natural rock rising 1,500 feet, eroded by wind and enhanced by light and shadow. But there are plenty of others who insist the rock and nearby formations were carved by aliens as some kind of message to Earth.

Scientists for the Mars Global Surveyor mission say they'll try to photograph the region to resolve the controversy. From orbit 234 miles above Mars, Surveyor's cameras can see

objects as small as 6½ feet across.

But the scientists can't guarantee the craft will have its high resolution camera on when it's over that area.

For one thing, there are 4,000 high-priority science targets to shoot elsewhere on Mars during the 687-day mission. And Surveyor must alternate its sharpness settings to achieve its goal of mapping the entire planet.

But if the spacecraft is in a position to see the face on a given day, "rest assured, I'm going to try to take a picture," said camera designer Michael Malin, of Malin Space Science Systems in San Diego.

When he can, Malin plans to

announce in advance on the Internet when the spacecraft will pass over the face, and he'll post the images.

Richard Hoagland, author of The Monuments of Mars, says NASA is "doing everything they can to leave themselves a legal loophole" to withhold the images if they show signs of alien handiwork.

Malin, who says he believes the face is natural, says he has no reason to hide anything.

"Either way I win," he said.
"If it turns out to be artificial, I'm the guy who took the picture. If it turns out to be natural, then the images will go a long way to providing the confirming evidence on something I've done the research on."

Launch windows

A "launch window" of favorable planetary positions for sending spacecraft to Mars opens for about two months every two years. Three launches are planned when the window opens this fall:

MARS GLOBAL SURVEVER (NASA):

- · Earliest launch: Nov. 6.
- Reaches Mars:

September 1997.

- Mission: Orbit Mars for two years or more, carrying instruments to map surface shapes and minerals and to monitor weather.
- Arizona involvement: Mineral-mapping experiment is headquartered at Arizona State University.

MARS 96 (Russia):

- · Earliest launch: Nov. 16.
- · Reaches Mars:

December 1997.

- Mission: Study Mars with 12 instruments aboard an orbiter. Drop two soft-impact landers and two "penetrators" for ground-level studies.
- Arizona involvement:
 Researchers at U.S. Geological
 Survey, Flagstaff, and at ASU are on mission's science teams.

MARS PATHFINDER (NASA):

- · Earliest launch: Dec. 2.
- Reaches Mars: July 1997.
- Mission: Land on Mars and deploy a small rover to study a site that appears to have been flooded in the past.
- Arizona involvement:
 Rover's camera is headquartered at University of Arizona. ASU researchers developed wind-measurement experiment.
