ART BELL MAY BE RETURNING

This has just been posted by Keith Rowland to Art's site. Apparently, the show will resume live Monday, October 19th, with a guest host and the same format. Art will come on during the first hour, probably to better explain his reasons and current situation. I think he will state that he just needs a little time, and hopes to return. Here's the announcement:

Premiere Radio Network's Statement to the Press Coast to Coast AM with Art Bell Dreamland with Art Bell October 16, 1998

Kraig T. Kitchen, President/COO of Premiere Radio Networks today announced, "Pre-miere Radio Networks will continue to distribute both Art Bell's Coast to Coast and Dreamland programs in the regularly scheduled time slots. For a short duration, Art has requested special guest hosts to do his show. On October 19, veteran talk radio broadcaster Hilly Rose will be the first of several potential guest hosts. The program's tradition of including knowledgeable guests will continue during this period. Art Bell will make a statement to his listeners during the first hour of his broadcast on Monday October 19 on Coast to Coast with Art Bell "

(Stefan Duncan note: Here is the story before the announcement was posted.)

Art Bell stunned his 15 million listeners Oct. 13 with an announcement that he is calling it quits on his night talk show. Rumors rippled through the net on the mysterious departure, leaving a void in the night of his listeners and a great loss for ufologists and those who study the paranormal. But Bell may be coming back. The message came across the net saying: Art WILL BE BACK in 2 or 3 weeks!!!!

According to Richard Hoagland in the KFYI bit at 8:30 pst, Art should be re-

turning to broadcast in 2 to 3 weeks. He stated that Art sounded in better spirits and there is no connection to government or contractual matters, just a "dramatic, private, personal problem." He added that Art sounded "focused and spoke with clarity" and that the problem was a "manageable one" but that "..he just needed time to resolve it."

Hoagland also mentioned that he was to appear on "Reliable Sources" on CNN but didn't give any details as to when that would be on. The sheriff didn't offer any new info but said that it was the same problem that has been ongoing for about a

This is the best news I have heard so far! Three wee s is so much better than

With such a mysterious departure speculation and rumors abound. Those that have listened to Bell's show are no stranger to dramatic revelations, gloom and doom predictions, news-as-it-happens reports ... Is Bell's mysterious resignation a cinema ploy or is this sincere business? Has his family been threatened? Until he tells the world what has happened there is only speculation and opinion ... just as ominous as the themes he covers on his talk show.

Whatever the situation, his voice that once filled the nights has left a void. I for one listened to Bell nightly. When I worked the night shift making my rounds, he was like a friend you could count on always appearing. The topics were the kind that lived in the night like a vampire to darkness. He offered the ufologists the top breaking news and interviewed the people on the cutting edge who were making a difference. He left it up to us to believe what we heard. He asked the challenging questions but reserved judgment and gave others the opportunity to express their beliefs.

You can tell when a person loves their job and people. Bell seemed such a person. He answered the calls without staff. We could watch him on his website as his video cameras updated pictures of him while he

was on air.

Months ago, Art said his wife had opened a package mailed to them that contained a powder and note that said it was Anthrax.. Could his resignation be related to threats of physical harm to him and his family, was it a fall out with his new owners of the radio shows? All we can do is wait and see.

Reruns are being played. The present voice is now silent. All we can do is wait and hope that once again the void will be

filled again.

OFF THE AIR AND INTO THE ETHER? THE STRANGE CASE OF ART BELL By Fran Ahrens and Joel Achenbach, Washington Post Staff Writers Wednesday, October 14, 1998

Consider it a real-life "X-Files" on radio. Bell quit on Oct. 13. "10-13 Productions" is (coincidentally?) the name of the company that produces the Fox television show "The X-Files," which deals with paranormal and extraterrestrial activity.

Adding to Bell's mystique was his geographical proximity to Area 51, the super-secret inilitary facility north of Las Vegas that is the ultimate destination for alien hunters, many of whom believe it houses the remains of aliens killed in crash landings of flying saucers.

Adding to the mystery, Bell's home

telephone has been disconnected.

Bell's true followers believed that he trod dangerous ground in his attempts to expose government coverups about aliens and dark conspiracies. It was only a matter of time, they believed, until some government black-op crept into Bell's desert bunker and pulled his plug, literally figuratively.

His many listeners, however, can take solace in the fact that Bell is fine, reports Nye County Sheriff Wade Lieseke Jr. "He is not in danger," Lieseke said. "This is a personal event with him that occurred a year ago. It is not an immediate law-enforcement

issue."

Bell told the sheriff what the "threatening terrible event" was, but Lieseke said he is not at liberty to disclose it. The sheriff did say, however, that the event was the cause of Tuesday's sign-off.

The theories on Bell's disappearance ranged from the prosaic to the fantastical. Steve Chaconas, program director at WWRC, said he spoke yesterday with officials at Chancellor Broadcasting, which owns the station, who said that Bell was "totally exhausted" and "just needed some time off.'

Other speculation was more colorful Was a deranged listener stalking him? Was it a stunt? Or has Bell been muted by a

coverup-minded government?

"I cannot believe this is trivial. I cannot believe it's a hoax or hype. I think it's something very serious," said Richard Hoagland, a frequent guest on Bell's show who has specialized in research on the "Face on Mars," the notorious mesa on the Martian surface that some people think resembles a human face (a resemblance that has not born up well with sharper images from the latest NASA spacecraft).

Hoagland said he suspected that Bell faced some kind of pressure to quit because of the subjects he put on the air - UFO

sightings, government coverups and time travel among them.

Millions of people "are depending on him to be at the helm of a ship that's going

somewhere," Hoagland said.

"I'm inclined to think it's some nutty person who's maybe jealous of him," said Frances Barwood, a candidate for Arizona Secretary of State, who has pushed for further government investigation of what she believes may have been a giant UFO about 1.5 miles in diameter that flew over the state last year.

Steve Bassett, a lobbyist for UFO groups who has been a guest on the show, said he had spoken with Bell about what he saw as the mysterious deaths and illnesses of people associated with the extraterrestrial issue. "There's a lot of people in this field who seem to have a very short life expectancy. There's a lot of people who are coming down with cancer. We're concerned about it, we're tracking it," Bassett said.

The creepiness of Bell's announcement

seemed a bit too perfect to some observers. "It's some exquisite timing in that it's right on the eve of the National Association of Broadcasters convention," said Jim Bohannon, whose nighttime talk show is heard on about 400 stations. The annual convenion begins today in Seattle and runs through Saturday. "This will be Topic One for the whole next week.

"To the best of my knowledge, this is not a publicity stunt," said Amir Henrickson, Premiere spokeswoman.

Regardless of the explanation, worried listeners began sending e-mails to Bell's Web site at www.artbell.com minutes a er his show went silent.... The following is the text of Bell's

resignation announcement:

"You may recall about a year ago... I told you that there was an event, a threatening terrible event occurred to my family, which I could not tell you about. Because of that event, and a succession of other events, what you're listening to right now, is my final broadcast on the air. This is it folks, I'm going off the air and will not return. And what I will tell you now is what I told you then. When the time comes when I can tell you what occurred, I will tell you, through the press, through the media, of one sort or the other. I will explain to you the entire thing, it's not that I want to hold anything back from my audience, however, for the protection of my family, until it is otherwise revealed, I can't discuss it, I won't discuss it. And if you were in my position, you would do exactly the same thing. And when you finally hear whatever it is, what it is, whenever you hear it, I

think you will then understand.

"At any rate, I wanted to tell you, I didn't want to go without saying a word, so I'm telling you now. What you are listening to, is MY FINAL BROADCAST. It's been a good run, and you've been a great audience, and it's been an absolutely incredible forum. And my presumption is, that the forum will continue. At any rate, it certainly is my hope, that the forum will continue.

"And again when the time comes, when this information can be released, you can be sure that I will release it, and I would assume because of the magnitude of the forum that I have held, at that time, you'll get the whole story. But the time will come when I will tell it.

"So for now and the foreseeable future, that's it! That is the end of this man's broadcast career. So, thank you, and goodbye... (Art Bell, 2:55 AM [Pacific Time], Oct 13, 1998)

RELATED ITEM:

"Skywatch International" posted this message from a "Diana" who says the message is supposedly from Art. You decide for yourself:

To my loyal fans: I want you to be the first to know what is going on, and I'm sorry I can't go into more detail, but I will

give you what I can.

About a year ago I was contacted by a person claiming to be from the future. He called himself Single Seven. He said that he had come back on a mission to find certain species of fruits and vegetables that can grow in hotter climates. To make the long story short, Single Seven told me that he had gone back and researched me and that there had been a terrible tragedy that happened to Ramona [Art's wife] and me. I lived, but Ramona did not. Let me tell you, there have been threats on my life in the past, and not just empty threats. There are some leaders of this country who find my program to be of great danger to their agenda. The only way that, hopefully, I can change this situation is to do the complete opposite of what I would have done that would lead to Ramona's demise.

About a year ago, on my first contact with Single Seven, he told me some things that would take place within this year, and every one of them has happened exactly as he said. He called me about a week ago and told me it is time for me to do what I have to do. He gave me one sign that would show me he was telling the truth. I took last week off, as you now, and the sign came exactly as Single Seven had said. Now that I am off the air, there are some things that should happen, including one big event. If that event happens, as Single

Seven says it will, I will be able to be back

on the air in a few weeks.

You people have been fantastic. I'm sorry I can't tell you more right now, but you will find out soon enough. Please pray for me and Ramona; our safety depends on

FILING A FREEDOM OF INFORMATION ACT (FOIA) REQUEST

The Freedom of Information Act (FOIA) provides anyone the right to request access to records maintained by the Executive Branch of the United States government. The Freedom of Information Act (more often referred to as FOIA) established a presumption that records of the Executive Branch of the United States government are accessible to the people. This was not always the policy regarding federal information disclosure. Before the FOIA in 1966, the burden was on the individual to establish a right to examine these government records. With the passage of the FOIA, the burden of proof shifted from the individual to the government. Those seeking information are no longer required to show a need for information. Instead, the "need to know" standard has now been replaced by a "right to know" standard. The government now has to justify its need for secrecy.

The FOIA is one of the researcher's most valuable tools. However, as with any tool, knowing how to use it properly is almost as important as having it in the first

place.

Making A Request

The request has to meet the following criteria before the government will take action:

 It must be in writing and signed by the person making the request

It must state that the request is being made pursuant to the FOIA

It must reasonably describe the records

being requested

It must state the category of the request

 It must state the category of the requester for fee purposes (i.e., commercial, media, educational, all others)

 It must contain an agreement to pay all fees that might be incurred (place a specific limit on your liability)

Your request for records should be addressed to:

FOIA Disclosure Officer [Government Agency] [Address]

Both the envelope and the top and bottom of each page of your request should be legibly marked "Freedom of Information Act Request."

The more general your description is (e.g., "any and all letters, correspondence, memoranda, notes, or other written media") and the more specific the particular record

(e.g., "from, to, or between General Ramey and Colonel Blanchard") the more likely you are to achieve favorable results.

The act requires that the agency respond within 10 days, yet it is normal to not receive a response within the allotted time.

Whatever your experience, whether you are a grizzled old veteran with hundreds of FO!As under your belt or a novice, the most important part of the FOIA is that it's there for all of us to use.

HOLOGRAPHIC BATTLEGROUND

The U.S. Congress has just approved funding for the Army to perfect a laser that projects life-sized hologram decoys of troops and tanks, designed to fool enemies on the battlefield. Dubbed the "Ghost Gun," the hologram projector could also be used to display virtual images of religious or political leaders in order to create calm or panic amongst the public.

US Army scientist Dr. Gary Wood, who is leading the project at the Armky Research Laboratory in Adelphi, Maryland, said: "One of the scenarios was Saddam Hussein standing on a balcony spouting pro-American messages or telling troops to lay down their arms. We are will on the way to

perfecting it."

It is predicted that within 10 years many of the troops seen by enemy units on the battlefield may be no more than 3D, lasergenerated images. U.S. Defense consultant Dr. Brenda Mark said, "Anyone looking at the target area will think the U.S. Army has a major presence there when, in fact, there will be nothing but empty space."

LEONID METEOR SHOWERS

by "Mark LeCuyer"

What is a shower of meteors (or

shooting stars)?

Most people have at some time seen a meteor, or shooting star as they are popularly known. A meteor shower occurs when the Earth, in its annual journey around the Sun, passes through a stream of dust particles, debris strewn along the path of a comet. Dust particles are drawn into the Earth's upper atmos-phere by gravity at speeds of up to 72 kilometres per second (160,000 m.p.h.), and they are rapidly vaporised at heights of between 80 and 110 kilometres (50 to 70 miles) above the ground, producing the brief streaks of light that we call a meteor shower.

The November Leonid meteor shower. A particularly interesting meteor shower is seen every November. It is called the Leonids, because all the meteors from the shower appear to emanate from one particular region of the sky within the constellation of Leo, the Lion. This small region is called the 'radiant' of the shower. In fact, all the Leonid meteors are moving along parallel paths; it is perspective which makes them appear to radiate out in all directions. Note that Leonid meteors may first appear some distance from the radiant, and you do not have to look in the direction

of Leo to see them.

Some Leonid meteors are observed between about November 14th and 20th every year. This year the peak occurs on about November 16th-17th. Normally at this time, between 5 and 20 Leonids are visible every hour. However, the shower is most famous for the periods of much greater activity that have, with a few exceptions, occurred at intervals of about 33 years. These are normally linked to the returns of the parent comet of the Leonid meteors -

periodic comet Tempel-Tunle, which returns every 33 years or so. The enhanced activity is caused by a dense swarm of dust particles close to the parent comet. The comet is due to return early in 1998, so we may see much stronger Leonid showers each November from 1995 to the year 2002. This years display (1998) may be particularly strong, but we cannot be sure. The purpose of Leonid Watch '98 is to find out exactly what happens this year.

What you need to observe meteors.

Meteor observing requires no special equipment and is simple and relaxing, even if you do have to stay up until well after midnight! You can observe by yourself or in a group; meteor observing makes a great family or club activity. If observing in a each observer must work independently of the o hers in the group. The best way to observe a meteor shower is simply to lie back and look up with your eyes alone; you should NOT use binoculars or a telescope.

A lawn chair, deck chair or sun-lounger will allow you to observe comfortably. Wear plenty of warm clothing - several thinner layers are better than one thick layer - and a hat and gloves. It can get very cold late at night in November. You will also need a torch with a red light - a cycle rear lamp is best - so that you are able to write down details of the meteors you see on the report form provided. Do not use a torch with a bright white or yellow light as this will ruin your night-vis on, and it will take some time for your eyes to become readjusted to the dark.

Make sure that your watch is set accurately to Greenwich Mean Time, by checking it against the Speaking Clock, radio time pips, or the clock on Ceefax. Use a clip-board to hold your papers; you may find that a pencil writes more easily if the paper becomes damp, and don't forget

an eraser!

Finding an observing site and set ing

The fainter meteors will only be visible if the sky is clear and dark. The weather in November is notoriously changeable, so just because it is cloudy in the evening, DON'T give up hope; it could well clear up after midnight! Write down the weather conditions in the space on the repor form, particularly if it varies during the course of your watch.

The lights of towns and cities give an orange glow to the sky (called light pollution) and this will make it difficult to see faint meteors. Try to find an observing site away from any streetlights, and remember to indicate on the report form just how dark it is at your chosen observing

Set up your chair so that you are facing roughly south-east, and adjust the position so that you can comfortably look at an angle

roughly halfway between the horizon and overhead. To help you find south-east, remember that the Sun rises roughly in the east, and sets roughly in the west, m early November. If your view is obscured by trees, buildings, etc. then make sure you tell us on the report form, if you cannot find a better observing site. If there are several observers in a group, have one looking south-east, one north-east, one south-west, one north-west, etc.

Making your observations.

The Leonid radiant rises in the late evening, so there is little point in beginning your observing until after 11 o'clock at night (2300 hours). The radiant rises higher in the sky after midnight, and by dawn is high up towards the south. The number of Leonid meteors visible increases as the radiant moves higher in the sky, so you will see more after 2 o'clock in the morning (0200 hours) than before. Morning twilight begins at about 0630 hours.

Please observe on as many nights as you can between Saturday, 14th November and Friday, 20th November. Observations are particularly impo ant on Monday, 16th and Tuesday, 17th November. You should see the greatest number of Leonid meteors on these dates. Please make additional photocopies of the report forms if you need

them. It is VERY important to remember that the date changes at midnight. For example, the evening of Saturday, November 14th becomes the morning of Sunday, November 15th after midnight. So if you observe on Saturday night into Sunday morning, write Sat. 14th/Sun. 15th' in the space provided after 'DATE OF OBSERVATION'. For the next night (Fri./Sat.), you would write 'Sun. 15th/Mon. 16th', and so on.

We have provided you with a map of the brighter stars and constellations to help you get your bearings, and a sample report form showing you how to fill it in. The map shows the night sky as it will appear at about 0230 hours during the period of activity of the Leonid shower. North (N), south (S), east (E) and west (W) are shown; Leo is over to the south-east. Leonid meteors will appear to emanate from the head of Leo, wherein the shower radiant (R) lies. The stars in the head of Leo make up a pattern rather like a 'backwards question mark'. Some examples of typical Leonid meteor paths are drawn on the map.

Not all of the meteors that you see will be Leonids. It is most impo ant that you distinguish the Leonids from the non-Leonids. As soon as you see a meteor, hold a ruler up to the sky along the path that the meteor has just traced. Then extend this path backwards across the sky, and see if it passes close to the radiant in the head of Leo, then record it as a Leonid; otherwise it is a non-Leonid. Leonid meteors are typically very swift, and the brighter ones

may leave a faint 'wake' behind them which can remain visible for a second or two. The Observers data form has spaces for recording the total number of Leonid and non-Leonid meteors seen during each 30-minute interval of the watch. Please do not begin or end your watch part way through a 30-minute interval. Spaces are provided for 30-minute watches beginning and ending between 2300 and 0630 hours. Note on each form used the times when you started and finished observing and the date of observation. REMEMBER THE DATE CHANGES AT M DNIGHT. Please also fill in the other details requested.

Please return your forms to Leonid Watch '98, as soon as possible after Friday, November 20th, 1998, or use the on line result form.

ET Base On Earth Sanctioned By Officials Since 1954 Confirmed; Secret U.S.-USSR Manned Space Station, Positioned In Orbit For Past 30 Years, Disclosed by Richard Boylan, Ph.D.

In July of 1952 the world was electrified by large newspaper headlines and photos of squadrons of UFOs flying repeatedly over the nation's Capital in Washington, DC. Four months later WW II General Dwight Eisenhower was elected President. The same month President Eisenhower took office (January, 1953), the CIA's Office of Scientific Intelligence (OSI) was ordered to determine if UFOs were interstellar vehicles. OSI convened the Robertson Panel of scientists, which recommended that the Air Force study of UFOs, Project Blue Book, be expanded. A year later, in April, 1954, as documented

by Gerald Light, President Eisenhower made a secret trip to Muroc Field (now Edwards Air Force Base), in the California desert, accompanied by generals, reporter Franklin Allen of the Hearst Newspapers Group, Los Angeles Catholic Bishop James McIntyre, and others. The President had previously arranged to be in nearby Palm Springs, CA, purportedly for a golfing vacation. He "was spirited over

to Muroc one night," while reporters were fed the cover story that the President had a toothache and needed to see a dentist. While at Muroc Air Field, Eisenhower was present while an extraterrestrial disc landed. Several Star Visitors emerged to converse with the President and the generals. The extraterrestrials requested that Eisenhower make the public aware of extraterrestrial contact with Earth forthwith. The President protested that humans were not ready, and needed time to be prepared for adjusting to this stupendous reality.

By the end of the following month, May, 1954, President Eisenhower's CIA Director, Walter Bedell Smith, Prince Bernhard of Netherlands, David Rockefeller and other top world financiers, later-Secretary of State Dean Rusk, later-British Minister of Defense Denis Healey, and other Western power leaders convened the inaugural meeting of the Bilderberg Group, "a means of Western collective management of the world order". (Sklar, H., ed., 1981. Tri-lateral-ism. Boston: South End Press.) One of the early items on the agenda of this world board management policy extraterrestrial contact.

The following information was disclosed to me by a confidential reliable informant, who previously worked on contract for the National Security Agency, and maintains Intelligence connections within the community. This information has been confirmed by a second source, Dr. Michael Wolf of the National Security Council's unacknowledged subcommittee, the MJ-12 Special Studies Group. The report which follows is not "leaks". The release of this information is pa of the Acclimation Program, an official though unacknowledged U.S. Government policy of processed release of information", as Dr. Wolf describes it. (Any information presented in this report which I have developed independent of these two governmental informants will appear in

parentheses.)

Shortly after establishing itself, the Bilderberg Group collaborated with the Council on Foreign Relations (CFR), another international policy body devoted to world management, concerning the problem of adjusting humankind to extraterrestrial presence. Bilderberg and CFR decided jointly in the mid-1950s to enter into an arrange-ment with the extraterrestrials: The ETs were given an island in French Polynesia as a base on Earth. This arrangement afforded them an the opportunity to monitor closely Earth cultures and behavior; and it permitted Earth governments a way to monitor extraterrestrial culture and behavior. "It became an on-going experiment," as my former NSA informant put it. He adds that when official public announcement of the extraterrestrial presence occurs, "they will be the ones introduced to Earthlings; 'Oh,

by the way, we want to welcome our neighbors from the Pleiades, who by the way have been here since [the beginning of Earth] time, but [are] actually living in our place, date, space and time." The informant adds, "They are the diplomatic corps."

My ex-NSA informant reported that the U.S. particularly held out for many concessions before agreeing to the arrangement. (He did not specify what those concessions were, but history subsequent to 1954 suggests that what the U.S. obtained was the lion's share of extraterrestrial scientist consultants, to assist American scientists in under-standing and adapting exotic ET technologies into such devices we now know as the computer chip, fibre optics, lasers, gene-splicing therapy, cloning, night vision equipment, super-tenacity fibers (such as Kevlar lightweight armor), aerospace ceramics, Stealth technology, particle-beam devices, and gravity-control flight.)

NCCs Dr. Michael Wolf has previously revealed in his book The Catchers of Heaven that he worked with ETs as part of his governmental duties. "I met with extraterrestrial individuals every day in my work, and shared living quarters with them," while doing research at extremely classified underground government research laboratories. He added, "Zetas work in underground facilities, as requested by the U.S. Government. The ETs are not breaking the U.S. Government-Zeta t eaties, but the Government has broken treaties by mistreating ETs, and trying to fire on UFOs." Dr. Wolf also described working with very human-appearing races dubbed the Nordics and Semitics. He said, "The Semitics and Nordics come from Altair 4 and 5 and from the Pleiades [star sys-tems]." Wolf also disclosed that in 1954 the U.S. had four extraterrestrial corpses in the "Blue Room", Hanger 18 at Wright-Patterson Air Force Base, Dayton, Ohio. These bodies came from a series of retrievals of downed UFOs. "The first UFO came down in 1941 into the ocean west of San Diego and was retrieved by the Navy. (The Navy has held a leadership position in UFO matters ever since.) Between that and the first publicly-announced UFO crash in 1947, northwest of Roswell, New Mexico, Wolf says there was another crash in 1946, as well as two other crashes in 1947 besides

SECRET U.S.-USSR MANNED SPACE STATION, POSITIONED IN ORBIT FOR PAST 30 YEARS, DISCLOSED.

In a report earlier this year, I wrote that in 1969, Apollo 10 astronauts Stafford, Cernan and Young were the first to approach an extraterrestrial beacon (dubbed The Monolith) and film it. Now, with additional information, I can add that they were not, however, the first astronauts to spot this ET beacon. That Monolith was

first sighted by Russian cosmonaut Yuri Gagarin, the first man in space, in 1961. He was followed that same year by American astronaut Alan Shephard, who also sighted the beacon. It turns out that sighting the beacon was not that unlikely. My NSA informant says, "There are billions of them floating all over." Dr. Michael Wolf shed additional light on the beacons. "They are postcards from the rim'. They emit both tone signals, sending a mathematical language. There may be five or more ET civilizations involved in setting up these beacons.

Ignore those Boeing conunercials and the NASA press releases about how America "soon" will have its own first manned space station. My ex-NSA informant revealed that there has been a manned "deep space platform" in orbit above Earth for over thirty years! "It [has] had three-manned [American] crews as well as Russians 'on' since '68!" He further states that since 1973, the space station received additional extremely high technolo y, "and has had upgrades since." His disclosures confirms reports I had heard previously from former military officers about a secret space platform in

This disclosure makes clear, as does my earlier report about a secret military astronaut program ret ieving the "Apollo 10" Monolith in 1972 for study, that the Cape Canaveral Space Shuttles launches and the "first American" space station on NASA's drawing boards are just government "cover" programs. Such programs have served to deflect the public from becoming aware before now of the existence of a black-project military space station and classified mintary craft which can go well past orbit into deep space.

anything that was said.


