A few weeks ago I had the opportunity to investigate two sighting cases that were both recorded by a camcorder. The details of my findings are elsewhere in the newsletter. After looking at the evidence, I can say that these sightings were illumination flares at the bombing range. Unfortunately, the military doesn't inform the public when these activities are conducted, but the people who see them are still curious about what they are seeing. When we receive reports of sightings, they still need to be checked out. If you are a field investigator or trainee, keep in mind that if you are called, you must follow up on the case immediately. I realize that we all have personal lives, but if you want to be an investigator, you must be available when you are called for a case assignment.

Notice to <u>all</u> field investigators: If 1 don't already have your name, address and telephone number, please contact me so i can put you on my list to receive future cases.

### \$31.52 AND COUNTING ...

Going into the November meeting, your MUFON-AZ checking account had a whopping \$31.52 in it, and we owed Alan Morey \$77.82 for printing the November newsletter as well as \$60.80 for postage to mail it out, which he paid out of his own pocket. Another \$99 was due for the rental of the Armory auditorium for the meeting.

In the past few months, MUFON-AZ has been lent money by Jim Ossipov, Alan Morey's father, Richard Motzer, and me so we could continue operation. An informal meeting was held at a restaurant in November just before the MUFON-AZ meeting to discuss what we could possibly do to get money in the treasury to continue. We could not continue operation without any funds.

Most of you don't realize the expenses involved in bringing in outof-town speakers. They usually charge an honorarium of \$300 to \$500, in addition to their travel expenses and hotel expenses. We have been pretty lucky on this account recently since summer hotel rates were quite low. But we still ended up with expenses of \$600 to \$700 just to get a speaker for our meetings. That's why we sometimes have to increase the admission cost to meetings involving one of these speakers. Most of the time we were just hoping to meet our expenses of the speaker in addition to the newsletter production and postage for that month and the auditorium rental. The thought of making a profit above and beyond that amount were far from our minds.

At several meetings this summer we lost money big time by scheduling big-name speakers (Michael Lindemann among them) and then having an unbelievably low turnout. We learned a very expensive lesson. No more speakers will be brought in during the summer months when people are on vacation or just don't come to the meetings for whatever reason.

So that night at our little restaurant meeting we formulated a plan to bring our plight to the members attending the MUFON-AZ meeting. After our situation was explained, a donation cup was passed around the auditorium. You came to our aid ... a total of \$312 was raised by the 58 members and visitors attending the MUFON-AZ meeting! And two people. Cynthia Holt and Eric Levinson, made contributions far above and beyond our wildest expectation. A big THANK YOU goes out to everyone who was there that night and helped out. Unbelievably, an additional \$254 was taken in from memberships, book sales, and admission prices.

If you were not present at our November meeting but feel you'd like to help out by giving a donation, we'd certainly appreciate it. Please make checks to Tom Taylor and mail them to 1433 W. A special thanks also goes to our speaker that night, Terry Warneke, for donating his honorarium to the cause, and I think everyone attending the meeting thoroughly enjoyed his presentation. Now the bills are paid (for November, anyway) and people are paid back for their loans to the organization, we have a comfortable \$360.72 in our account. We will make the monthly financial statement (one month behind) part of our newsletter, and we trust you will all continue to help us support our great group. Thanks again to everyone.

## MILITARY ACTIVITY IN ARIZONA CONTINUES

#### Excerpt from UFO ROUNDUP Volume 3, Number 46

... Ryter also reported that witnesses had seen two U.S. Army tank transporters stop at the intersection of a Nantahala Forest road and Highway 129 and offload two M1 Abrams tanks.

On Thursday, November 12, 1998, an eyewitness, Robert C., reported, "Definite increase of military activity north of the San Francisco Peaks" west of Highway 89, about 15 miles (25 kilometers) north of Flagstaff, Arizona. He described a convoy of heavy cargo trucks guarded by black helicopters and an antiaircraft vehicle "up near Deadman's Pass. What is going on?" "Railroad cars loaded with Military Vehicles" – asked in the Time Bomb 2000 (Y2000) Q&A Forum

"This morning I went to the train depot to pick up a visitor. While waiting, there were other trains passing through. One was a freight train with all the cars loaded with military type vehicles: Tanks, troop carriers, variety of support types transports, and box cars loaded with what looked liked old time jeeps (partially hid by box car slats). What was interesting was they were all painted a desert tan (not AND ALL THE camouflage), MARKINGS WERE PAINTED OUT. If I had not been reading recently about strange movements of military vehicles in different parts of the USA, I would not have given this experience another thought. And that there were no military identifications also startled me. First thought that I had was, "look for UN markings." I saw none, but wondered what was going on. Trains were moving through southern part of AZ also. I am not paranoid, but it is interesting when you read and listen your consciousness is sharpened, and you notice things like military equipment that others folks (or me, one year ago) would never think to question."

#### **MESA SIGHTINGS**

Two videotapes of strange "lights" were shot by different people of the same event. While investigating the situation, I came up with five key points that lead me to believe that without a doubt, these were flares being deployed at the bombing range.

1. The date was November 19, 1998, and the tapes were both shot at around 8:30 to 10:00 p.m. On one videotape the lights stop at exactly 10 p.m, according to the testimony of the other witnesses.

2. The direction, from the vantage point of the observers, was southwest, and range of distance was 30 to 40 miles.

3. The objects first appear as a bright white, hen change to orange. This is consistent with what flares do. The magnesium in the flares start out white and change to orange as they complete the burn.

4. The tapes both show a bright round light that appears to be symmetrical. When the camera zooms in, the top and bottom of the image becomes flat due to the optics in the lens. The witnesses claimed that the objects seemed to move close, then move away. This can be explained by the camera being in an auto-zoom mode. The camera reacts to changes in light brilliance and gives the illusion of movement.

5. When I con acted Luke Air Force Base, I asked if they had any activities going on in November regarding aircraft. The answer was yes, they had conducted exercises at the bombing range on November 19 and that all activities ceased at exactly 10 p.m.

Channel 3 had done a story on this sighting and had come to the same conclusion. Dr. Paul Scowen and an astronomer gave additional input to confirm the findings.
