# RESPONSE TO JOHN SCHUESSLER'S ARTICLE CONCERNING UFO ON GUN CAMERA FILM

The following article appeared in last month's newsletter. Below that article we are printing Tom Taylor's response.

## ANOTHER UFO ON GUN CAMERA FILM

Peter B. Davenport, Director of the National UFO Reporting Center in Seattle, received a telephone report at 3:20 a.m. on March 14, 1997, relating to the UFO sightings over Phoenix. The test of the caller's report is as follows:

"That's correct. Uh, the, Luke Air Force Base is actually in Litchfield. I'm, I'm, all ... I got off shift about 30 minutes ago. At, uh, 8:15, ah, the F-... "Ready Alert" at Luke Air Force Base, which is the F-15 ... two F15s that we keep on "Ready Alert" ... they're part of the Air Force One and Air Force Two "Protection Group" ... to protect 'em when they come west of the Rockies, whenever the President or any dignitary is on board.

"They were launched because ... all hell broke loose, basically. Apparently, we got a call from, ah, Prescott Valley Airport, a small airport, um, north of us ... I'm sorry, northwest. And reporting an object that had

a near miss with a small Cessna ... aircraft.

The call came up once: "Ready Alert." Approximately 8:32, uh, from my understanding, that they encountered something over the sky ... over Phoenix, Arizona, over the area of Seventh Avenue and Indian School Road.

"They don't know what it was. The description that the pilot ... one of the pilots stated that they had a visual on it, they've got gun camera film of it, they have no radar tape of it. It scared the hell out of them. I've never seen ... this [name deleted] I'm talking about, he, uh ... the command pilot of this particular flight, he'll never talk to you. He's a real professional. I've never seen this man, oh ... I've never seen this man scared.

"Are you familiar with the term "white noise" ... blanking out radar? My understanding is, that's what they got, was strictly white noise.

The caller concluded the report by saying the pilot was scared to death. "He's not sure what it was. After they landed, the base was ... we had a complete 'lock down.' The facility was closed."

Peter Davenport made this report on one of our radio talk shows here in Phoenix and on Art Bell's radio program. I phoned Peter after I heard the report and said I thought it was a rather misleading report to give, since nothing could be confirmed. Anyone could have phoned him making the same claim. Without some sort of confirmation, it is simply misinformation — and because there was plenty of that going around at the time — and now, with the publication of your article, the misinformation continues!

## ONE MYSTERY SOLVED

They might have been UFOs, the startingly bright flashes of light that began appearing in the sky in 1997. But sky-watchers traced the flares to a constellation of low Earth-orbit satellites launches by Iridium, a telecommunications company. Sunlight striking the silver-plated Teflon coating of the satellites' main antennas causes reflections visible to the naked eye, "like a distant plane with its landing lights on," said one observer. Experts monitoring the 485-mile-high orbits of Iridium's satellites - now numbering more than 80 - devised computer programs to predict where flares would occur. They posted the programs on the internet, to the joy of satellite buffs everywhere.

#### RESPONSE TO DAN WRIGHT'S CASE OF THE MONTH (MUFON JOURNAL, 12/98)

In the December issue of the MUFON Journal, Dan Wright's column entitled "Case of the Month" concerned a sighting in Yuma. Mr. Wright is being presumptuous concerning a lot of the surrounding events - he never even called Doris Barley, the MUFON Section Director at that time who handled the investigation and reporting of the case, to get first-hand information concerning the sighting. He made assumptions and statements through hearsay only, and had he contacted Ms. Barley directly, he would have found her a very responsible and conscientious individual and an excellent investigator. We wonder: if he botched this particular article so badly, how can we believe the rest of what he writes? Even his letters to Ms. Barley (and Mr. Murek, her successor as Section Director) in response to her letter to him upon seeing this column contained errors, typos misspellings - they were apparently not even proofread.

Mr. Wright's letter follows:

Dear Ms. Barley & Mr. Murek:

Walt Andrus asked that I reply to you concerning my "Case of the Month" article in the January 1999 issue of the Journal and your e-mails in reaction to that article.

First, 1 apologize for misstating the Yuma sightings as occurring in August 1998 rather than August 1993. By way of explanation (not excuse), soon after resuming the deputy directorship, in December 1998 I received two boxes of case reports from the outgoing deputy which had not yet been evaluated and encoded. It was my early

impression that these were all from 1998, as the first several above the Yuma report and more below it indeed were. When I reached that report, I mistook 1993 as 1998. Obviously, this report should have been reviewed long ago, but misreading the date was my oversight.

I discovered the error recently in a phone conversation with the current State Director for Arizona, Alan Morey. As I indicated to him, I plan to include a correction in my next case-of-the-month submittal for the March issue of the Journal. Based on the content of your e-mail, Ms. Barley, I will likewise mention the inquiries you had made to police and airport officials and to the then State Director to correct that misimpression.

Certainly you were in an untenable position at that time, not having MUFON sighting forms, a Field Investigator's Manual of procedures, or investigative training – then being politely rebuffed when you asked for help. "Do the best you can" – without inquiring as to what materials you might need or offering advice and assistance – is just not sufficient.

Please understand that a case is only as strong as the documentation in the report. Inexperienced investigators, especially those without a manual, very often assume that accepting and recording the assertions made by a witness is sufficient.

In assessing a report, I make the assumption that the investigator has included all contacts initiated and other actions taken, that anything not mentioned was not done. That is, I adopt a skeptical attitude and decide, based on the materials present, the likelihood of a possible misidentification. After all, when a Phil Klass or other UFO debunker looks into an event, we do not expect him to accept undocumented claims.

In the report, you did paraphrase the statements from an impressive number of callers. However, as illustrated by the secondary event in the recent "Phoenix Lights" case, large

numbers of people can be fooled – in that instance, by what may well have been an effort by the military to cover up an actual UFO flyover earlier that evening.

As you point out, your case report did not include completed MUFON forms. In their absence, it was essential to have. at a mini-mum. handwritten statements drawings signed by witnesses. Personal interviews with some might have shed light on variations in their descriptions. A log of your investigative efforts, most import-antly the checks you made to rule out natural and man-made objects, would also have instructive. (As to the absence of documented follow-up, in the article I used "apparently" and "presumably", for that was the appearance in the report. Finally, a complete case report should have a section evaluating the event, detailing how and why you concluded that the incident described was not likely something prosaic.

These factors are not things I have conjured up. They are presented in the chapter "Writing the Report" by Ray Fowler, which has been in our manual for many years. Had your then State Director helped in the report preparation, this likely would be a very strong case. It is frustrating to assess such a promising event as incomplete as repotted.

When doing evaluations, I contact the State Director to request additional input if an incomplete report is both (a) of considerable substance; and (b) submitted within a month or two of the event (while witness memories are still fairly fresh). past From experience, recollection of details after that can do more to cloud than clarify actual circumstances. reviewing and assessing the hundreds of reports in those two boxes, my obligation is to enter into our computer catalog only those reports that would hold up under scrutiny.

The article's intent was to briefly offer an example of a missed opportunity without embarrassing anyone. To that end, I purposely did not include your name or that of any other Arizona MUFON member. I do wish you to understand, though, that the purpose of my articles is not to celebrate phenomenal claims, but rather to emphasize groundwork investigative objectively pursued as essential to sorting out events as either IFO UFO occurrences. Or Indeed, the article for February will feature a case in which the investigator's careful examination site raised doubts of the concerning the witnesses' claim.

Investigative legwork and documentation can strengthen a sighting account. I hope you will both reconsider your decision to leave MUFON. Alan Morey assures me that he will be doing all he can to improve the network in your state and afford you and all members the assistance you need.

### IS SOMEONE RINGING YOUR BELL?

I recently re-joined the millions of people who study the UFO phenomena. It is at a much highertech yet no more credible level than say, 12 years ago, with one noticeable caveat: there is a certain talk show host who, for all intents and purposes, we could refer to as "P.T .Barnum." This individual hosts a show that, in my opinion, is the only international forum relating to this subject. Its audience is somewhere between 5 through 15 million worldwide. The host has had well over 12 years of broadcast experience; he has transmitted hundreds of stories, experiences, alleged sightings and prophecies to his millions of listeners, now worldwide.

Why, then, bas he never thought to use his vast experience in order to form his own, well-educated opinions? Need I refer back to the notorious P.T. Barnum? I must discuss the topic of "Prophecies."

On Thanksgiving Day, November 26, 1998, the latter portion of his show addressed the subject of the "Third Prophesy of Fatima," a cataclysmic event to occur on or around November 30, 1999. Our host was virtually certain this event would happen based upon prior prophecies of two of his other "regular guests." One, I believe, had predicted November 19, 1999; the other November 30, 1999. Apparently Fatima's prophesy also alluded to that same November 30<sup>th</sup> date.

What type of effect might that discussion have had on his worldwide audience? In my opinion, this is pretty heavy stuff. The host need be aware that in his audience there are believers! There are also zealots, depressed and religious persons, and perhaps a young and impressionable segment. Mr. Host, you must have a conscience! Do you not remember the "Heaven's Gate" prophecies that were aired on your show? Shouldn't that have guided you in handling your November 26th broadcast?

The host posts all pertinent documents, photos, etc. on his web site for the audience to view while the show is being aired. He even mentions that documents and/or film were "analyzed," not hrough his resources, but those of the guests! I view this as being most strange and unprofessional. I recently was able to view some film and photos from a show relating to an alien supposedly killed by the guest and kept in his garage, in a cooler, for several days.

Well, it seems that MUFON's Arizona inves igators were able to quickly analyze and classify this incident as a hoax, a very poor one at that. I can confirm this, since I have personally seen the evidence. Why would a man with so much experience allow such hoaxes to be aired on his show? One might ask if our talk show host has an agenda. Is he on more than one payroll (a cut-out), is he gullible, is he of good conscience, or is he simply a modern day "P.T. Barnum"? In my opinion, this show does not lend itself towards credibility, not at all. It does not help our quest for the tru h. Is this show entertainment, or a sabotage of our cause? In closing, I predict that I will be listening to his show on the night of December 1, 1999!

#### **UFO SIGHTING REPORT**

November 24, 1998:

A young (sounding) woman called and asked for Ruth. I told her that Ruth was not available, but that I was her husband and could take a message. She declined to give her name or telephone number, but related the following message:

She said she had just seen the Channel 12 News at 6:00p.m. that evening, and she and her grandson had seen a similar object to the one shown as the "Fountain Hills UFO".

On the prior Sunday afternoon, November 22,1998 she and her grandson were driving from the Pinetop area (south) towards Fountain Hills on the Beeline Highway (Hwy.87), approximately 2:00-2:30p.m., when observed the object to their left (east) as they approached Shea She did not judge the distance, but it was beyond the first low hills along Highway 87. She estimated the size as "as big as a football field," and her grandson said it was as big as "two football fields". It remained visible for a short period of time, and then she lost visibility behind one of he low hills. She said that there also was what looked like a small cloud where it disappeared.

She said she felt funny about saying anything and still preferred not giving her name or phone number when I suggested that Ru h would be happy to talk to her. I asked her to call back tomorrow.

She apparently called Channel 12 to get Ruth's phone number and asked that group was Ruth with. I told her that Ruth was a psychologist and a consultant for the AZ Mutual UFO Network, which is interested in and investiga es the phenomena of UFO's. I then encouraged her to call back.

Confirming the above report, the following is added: The specific location was south of Saguaro Lake, southbound along Highway 87. The object appeared to be "hovering, not flying," at an altitude below 3,000 ft., as this is the elevation of the mountains at this point, according to a pilot friend of hers. The grandson, 11 years old, also saw the object and added that it was "...very large" and "had no lights or windows."

#### Reported Discovery of a 'Buried UFO' in Estonia

In the very first issue (1994) of his review EVIDENCIA OVNI, our and Puerto Rican friend Consultant Jorge Martin published a translation of the following weird story, which he had received from the American (Russian-born) investigator Paul Stonehill who runs the RUSSIAN UFOLOGY RESEARCH CENTRE (5700 Etiwanda St., Tarzana, California 91356).

The report concerns Estonia, one of the three small Baltic States that had a brief taste of independence after the Russian Revolution in 1917, only to be temporarily gobbled up again by Stalin when he saw his opportunity at the outbreak of World War II. (Today they are all free again and anxiously waiting to join the European Union).

As you study this very queer account, which seems to date from the 1980's, when still ru ed Soviets Estonia, remember the equally weird report about strange metallic globe-shaped cauldron-or objects, buried or half-buried in the snow bound wastes of (Far North-Eastern Yakutia Siberia), which I published last year (Mysterious "Power-Plants" Siberia).(See FSR 42/1). **EDITOR** 

The report indicates that at about a depth of 3m. below the surface of the ground, on a collective farm near Tallin, the Capitol of Estonia, workmen were digging out a shaft for a well had struck a mysterious great metallic body which was believed to be of "alien origin" possibly a "flying saucer", or "some sort of device for interstellar communications" [sic] The report said that individ-uals who had tried to dig the thing out had shortly afterwards died in mysterious circumstances, and that others who had gone to Moscow carrying some samples of water from the site of the excavation had "suffered paralysis". Also, that a piece of alleged UFO had been pried off and then confiscated by the Russian Military "because they knew that it was part of an object from another world".

Paul Stonehill had reported that, as far as could be ascertained, the truth was that in 1984, Soviet academician Nikolai Nikolayevich Sochevanov, a specialist in geology and mineralogy, was visited by a friend of his - an Estonian inventor - who brought a piece of dense silvery metallic material, and the following story"

"On a collective farm just outside Tallin, a well was being dug and at a depth of some 3 meters or so, the workers hit upon something metallic and very solid, and on digging deeper, they came upon the rim of a metallic plate sticking out from the wall of the well. The thickness of the metal at that spot was only 2 cms, but even so the drill could not penetrate the metal.

"A compressor was brought along and, using a pneumatic drill, the workers were able to break off a piece of the metal plate, and the piece was sent off to Tallin, where two institutions both made an analysis of it - but arrived at contradicting results! One institute said the metal was a complicated alloy, while the other one said it was simply cast iron!

"The Estonians requested Sochevanov have it analyzed in the leading laboratories of Moscow, so a number of smaller fragments were cut from the piece with diamond saws (two of which were damaged in the process). According to the V.1.A.M. (United Institute of Aviation Materials - VSYESOYUZNHIY INSTITUT AVIATSIONIKH MATERIALOV) it was established, in the testing, that the sample of mystery metal had a microsolidity varying between 330 and 1,500 kg/mm.

"In appearance the metal was dense and hard, and of a silvery colour. Its specific gravity was 6.3 to 6.6. The various laboratories which did these tests on the small fragments were: The Moscow Institute of Physical Engineering, the United Institute for Raw Mineral Materials, and the VIAM mentioned above, plus several other laboratories.

"According to Sochevanov, the leading Soviet scientists "had no doubt whatever as regards the extraterrestrial origin of the artifact". Among these scientists was Professor Mitin.


### PLUTO RETAINS ITS PLANET STATUS
