

Dr. Roger K. Leir "The Aliens and the Scalpel"

Finally - a serious scientist willing to travel down the bard and torturous road of scientific investigation into the UFO and alien abduction phenomena. Dr. Leir has been a podiatric physician and surgeon in private practice for 34 years.

Over the past he has brought his quest for knowledge to the UFO field with great intensity. Dr. Leir's research has resulted in his first book, "The Aliens and the Scalpel." In this compelling book, Dr. Leir describes his journey from consummate scientific skeptic to the belief that humans all over the planet are being tampered with by another intelligence.

Dr. Leir brings out the human side of this surgical quest for knowledge by conveying the personal feelings of his patients. He takes the reader on a journey through not only the surgeries themselves but also illustrates the practical aspects of biological and metallurgical research.

TESTS REVEAL AGE OF MYSTERIOUS MIAMI CIRCLE By Jim Loney

Miami, March 9 (Reuters) - Scientific tests on charcoal found in the mysterious Miami circle, a dusty Indian relic at the heart of a fierce political battle, suggest the site was occupied by humans at least 2,000 years ago, archeologists said on Tuesday. The tests were the first done on artifacts found at the site and the first scientific indicator of the age of the nondescript 38-foot (11.5-metre) circle. found last summer on a downtown plot of land where a developer wants to erect a \$100 million condominium. A series of man-made basins and boos hacked into the limestone bedrod n one of Miami's priciest parcels of real estate at the mouth of the Miami River. the Miami Circle has become the focus of a war between city and county governments, and developers and preservationists. Native-American groups have adopted the circle as an illustration of America's ill treatment of sacred Indian sites. The circle is believed to be the foundation of a ceremonial lodge constructed by indigenous Tequesta Indians before they vanished in the decades after European occupation of Florida.

The Miami-Dade County Commission on Feb. 18 voted to attempt to buy the 2.3-acre (0.92-hectare) parcel of land and obtained a court order preventing construction at the site. The court order came over bitter opposition from the city of Miami, which stands to lose millions of dollars in tax revenue if the condominium is not built. The Florida cabinet, made up of governor and other executive branen leaders, on Tuesday heard pleas to save the circle and approved a study to determine if the state should buy the

land. In this century there has been a lot of things taken away from the ople," Paul Eagle Heart, an Apache Comanche, told the cabinet. "We're going into the new millennium, the new century. Don't take something away that could carry on into the next century." Carbon-dating tests were completed on two small bits of charcoal, probably created by Tequesta fires, said John Ricisak, a Miami-Dade County historic preservation specialist.

The tests showed that a sample found in one of the basins that form the circle was 1,800 to 2,100 years old, Ricisak said. A charcoal sample found in the earth that covered the circle was 1.850 to 1,990 years old. It tells us that the occupation of the site...goes back probably 2,000 years," Ricisak said. "It does not come anywhere near proving that the circle itself may also be that old." Experts had previously said the circle could be 500 to 800 years old. Carbon dating measures the amount of carbon 14, a slightly radioactive isotope of carbon found in all organic matter, maining in ancient material. enables scientists to determine the age of fossils and other artifacts by comparing the test results to an international standard.

Ricisak said testing was to be done on other Circle artifacts, including bone, shell and the skeleton of a shark. But it was unclear whether it would be possible to test the limestone bedrock into which the formation is carved. Scientists also were trying to determine the origin of two basalt axeheads found at the site. Basalt is a rock of volcanic origin that does not occur naturally in Florida. The two nearest possible Appala-chian sources the Mountains of eastern North America and the highlands of Guatemala, scientists said.

PANIC IN THE YEAR ZERO Government Plans for the Worst in Y2K

Consultant cites preparations for martial law

Plans have been made for mass evacuations, government takeover of private industries, and the use of martial law, according to a Y2K consultant to municipalities in the state of Michigan. All the mechanisms have been put in place for mass evacuations of people to shelters, government government takeover of utilities and private industries, martial law, and a complete transfer of power from governments to the federal government, according to Franklin Frith. Frith is a consultant hired by Michigan municipalities to conduct workshops for state, city, and county agencies on how to prepare for contingencies related to the year 2000 computer bug, which is expected to cause disruptions. Frith became alarmed when Michigan's many government agencies opened their documents to him. In them he claims he found compelling evidence that a greater problem exists than has been admitted publicly. Frith conducted a workshop Feb. 11 at which Lt. Tom Mattioli, the emergency management coordinator for the Michigan State Police. gave a presentation. Participants were given a handout which showed a FEMA/Red Cross checklist for Y2K preparedness which is available to assist the public. One of the items on the list mentions the need to store a three to five days supply of food and water. Frith asked Mattioli if it was expected that Y2K disruptions would only last a few days. "The three-to-fiveday period for preparations is not the expected down time for essential services, rather it is the expected response time for emergency response personnel to arrive and evacuate people to shelters," Mattioli told the group. Mattioli confirmed that he made the remarks in a phone interview with WorldNetDaily. He pointed out that the recommendation is a generic one for

general disaster preparedness and has been part of the FEMA and Red Cross disaster planning for many years. Frith is also concerned that most local cities and counties have not done anything in the way of remediation of Y2k computer problems. "Local governments deliver essential services. Those essential services allow the industrial base and the civilian base to operate," Frith told WorldNetDaily.

"What has really thrown up a rec flag for me is that these people are no ready. Many have not even begun the assessment phase. In these meetings they're saving that there are no resources available to fix this, once they find out what is wrong. There's entire counties out here that haven't done anything," said a very concerned Frith. He was further alarmed when the President's Council on the Year 2000 issued a report Dec. 3, 1998, which stated that the country was now moving from contingency planning to crisis management. Frith says this is further evidence that the government knows there will be severe problems because far too few computer systems will be repaired before the start of the new year. Frith contends that the federal government knows local and state governments will not be able to deal with the problems which will occur because of the Y2K crisis. He says plans are under way for martial law and the use of mass shelters. Some states have already begun plans to use the National Guard as part of their Y2K contingency planning; others have not yet done so. "The bureau reported to the DoD (Department of Defense) in November (1998) ... some states are 'reluctant to become too dependent on the National Guard for disaster response because they believe that the National Guard might be pre-empted by national priorities," the report says, according to an article in the January issue of National Guard Magazine. World Net Daily has completed an extensive series of articles about National Guard plans for Y2K. Plans include an extensive nationwide exercise on May 1 and 2. The guard

assume that all telecommunications services are out and will use only battery and generator operated radios to communicate. They will simulate a full mobilization of the guard, something that has not been done since World War II. Frith said the National Guard exercise is not the only evidence of plans to use the military for the Y2K crisis. He pointed out the recent Operation Last Dance training conducted by the Army Special Forces Command in some Texas towns. Frith says the use of live ammunition and explosives in civilian areas, along with the name of the operation itself are sufficient reason for concern. believes this "really is the last dance." before use of the military begins as a domestic SWAT team. "Consequently. as this year progresses, we will become increasingly involved in DoD support to others," said Deputy Defense Secretary John Hamre to a Senate Armed Services subcommittee recently. Frith points out that Hamre is "the number two guy at the Pentagon, and the Pentagon's number one guy on Y2K." "We are in the process of refining the list of assets that have utility in military support to civil authorities (MSCA). Because Y2K is a special case of MSCA, in that many concurrent emergencies may occur, special procedures may be required to ensure the most effective use of these resources." Hamre stated in a previous hearing. Frith says he believes the federal government has plans to take control of many private resources, perhaps with the use of the military to ensure they get what they want. As evidence of this, he points to Executive Order 12919 and a statement by the president's Y2K guru. "In a crisis and emergency situation, the free market may not be the best way to distribute resources. If there's a point in time where we have to take resources and make a judgement on an emergency basis, we will be prepared to do that," said John Koskinen in a Dec. 3, 1998, report of the President's Council on the Year 2000. "The statements made by Hamre and Koskinen, along with the existing FEMA Federal Response Plan

confirms the intention to invoke Executive Order 12919 and that the possibility of a national emergency being declared with the potential for martial law to follow is probable and should be planned for," warns Frith. Among other things, EO 12919 delegates power and authority to various federal agency heads to take control of private property.

"(EO) 12919 gives FEMA coordinating power over all federal agencies and everything those agencies have iurisdiction over. They also have coordinating power over all free market resources," explained Frith. "When you start looking at all these pieces, they are adding up. They are adding up," he stated. Frith has an agenda to spread distrust of government and create fear. according to one Michigan Y2K emergency planning official. "There's this tendency for people to think that there's something hidden somewhere in somebody's files, or some secret discussions going on," said Mike Prince, Michigan State Police Emergency Management Division, public affairs officer in a phone interview with WorldNetDaily. "That's certainly not our feeling. Most of that is hype and most of that is people trying to generate mistrust, and people trying to generate fear, and people trying to profit or benefit from spreading misinformation and that kind of fear," he explained. Frith pointed out that he does not sell anything. He is paid as a consultant. He does not sell Y2K related books, or preparedness supplies.

I'm Candy Peterson of Minnesota MUFON, and I thought I'd send information about a UFO hoax originating with a group called "CACOPHONY" that has members located in your states and provinces. This message forwards the details of a hoaxed UFO event (Feb. 26) as well as a description of the 10' diameter device's design, and the URL for an animated illustration of it. This UFO design "workshop" was staged in Los Angeles by the "CACOPHONY" group that has a private-discussion list and members in at least a dozen states and Canada. Of course, they may have a much wider following, as well.

helicopters. Note: "Cacophony Research And Potential Prank Institute (CRAPPI)" They do much more mischief than create fake UFO events, but it behooves us to keep track of efforts to hoax UFOs in case these generate "UFO" reports for MUFON to investigate.

Further Notes Concerning The L.A. UFO Hoax Event

Note 1: I just want to personally thank everyone who showed up [at the hoax event]. The result of our R&D was spectacular: A craft, ten feet in diameter, suspended by dozens of white latex anti-gravity units -- some eerily illuminated by green glow-sticks -- gracefully drifting in the LA night sky. Special thanks to Bob for the SFX module. The high-pitched beeping was truly an attention-getter. The result was hypnotic and otherworldly. There were a couple of non-Cacophonist witnesses to the event (one even ran into the woods. breathless, video-cam in hand, to document her "sighting") and they were absolutely mystified and - yes -awe-stricken. The numerous police chopper fly-bys were icing on the cake. All in all, this worked out even better than I expected, and the R&D was helpful in perfecting the craft for designing the next model.

Note 2: This message is a follow-up to the message about a California group staging/hoaxing a UFO event last month. The URL's animation shows a thin (metal?) hoop with 8 large helium balloons attached equidistantly. There are green glow-light sticks apparently inside each white balloon, providing the main light. There are also 4 evenly-spaced red flashing lights attached to the bottom of the hoop, aimed downward. It doesn't look to me like it would be too convincing to anyone who has ever seen green glow-lights, but ... add a warbling sound and the general public, and you might get a few believers.

MARCH 13 SIGHTING Reported by Jim Kelly

I received notification from Ton Taylor that a message was left on his answering machine concerning a sighting that took place on March 13 1999. No name was left on the message, but Tom's Caller ID bos revealed a name, which will remain anonymous.

I called the number and spoke to Mrs X. who informed me of a sighting that took place on March 13 in the Mesa The witness stated that a group of five people were playing canasta late into the night. At arounc 0100 hours (1 a.m.) a male witness walked outside to take a cigarette break and noticed what he first described as "an object that appeared to be a star" suddenly begin to move erratically up and down, side to side, in a fast-moving "erratic" movement. The object then began to change colors in a revolving fashion. This witness said that he used a Bushnell 715x35 binocular hand held set. He then stated that the object was moving so erratically he could not get a very good look at it, but he went on to explain that he saw no structure to the object - just revolving light colors of yellow, blue, red and white in the northwest sky at about a 45 -- degree angle. The other four people in the house then witnessed the object for about another 30 minutes; they then went back inside of the house and began playing cards again.

Mrs. X. stated that the object was still in the sky at 2:30 in the morning. She also said that the object appeared to be directly over the 1-10 freeway. The witness w2ould not divulge her address and declined to have an investigator to come out to do an official report. She did relay that the two major cross streets that are near her location are McKellips and Center in Mesa. The conversation was recorded; Tom Taylor and Alan Morey were notified. The witness gave me permission to contact her again by telephone.
