THE TRIMBLE COUNTY BEAST by George Clappison

The Summer of 1962 crept into Kentucky: lurked in backwoods, stalked the night. The Midwest, as the rest of the nation, worried about Cold War tensions, the Economy, and other mundane concerns. Trimble County Kentucky, situated along the Ohio River, 50 miles to the Southwest of Cincinnati, Ohio, eased into Summer, quietly infiltrated by the Unknown Sunday evening, June 3, 1962. Owen Powell heard a commotion out back. Something was causing the hogs to agitate. He headed for the back porch closely followed by his two companions. As he opened the door the dogs ran past him and hurried toward the hog pen. A dark form loomed over the swine, moving silently, but observed by the farmer. Over 6 feet tall and upright on its hind legs, completely black, Owen had never seen anything quite like it before, but he knew that whatever it was shouldn't have been in his hog pen molesting his pigs. Owen Powell immediately decided that his police dog, a large shepherd, and his collie, were going to attack the strange beast. "Get 'em boy", he commanded. The two dogs bounded toward the pen growling and lunging. The dogs worked in unison, alternately attacking and retreating. Owen could see the intense battle in the darkness and heard the strange guttural bellows mixed with the painful whimpers of his canine friends. He knew that two large dogs, one of which being a vicious police dog, could bring down any man or animal known to these parts. But that night, his two friends ran back to his feet, whimpering and crying. All three went back inside. The intruder lumbered back into the night. What beast could fight off these two? "What the hell was that?", Owen asked his wife. No one rested that night, but Owen kept his gun handy. Trimble County Sheriff Clem Curtis was a cautious, methodical man. He took his job as the top law man in the county very seriously. Owen's report was duly recorded by Sheriff Clem. Reports of prowlers roaming through the countryside were received by the stoic county judge, and soon the sheriff heard of groups of armed farmers scouring the hills in search of a mysterious animal. Described as about 6 feet tall. covered in black hair, walking on its hind legs with arms hanging to the knees, it had been seen numerous times at various locations in the county. Most witnesses described a most peculiar creature, but were unable to identify it. Sheriff Clem Curtis issued words of caution to armed persons who were searching an area northwest of Bedford, Kentucky. "There is no reason to get alarmed" the sheriff said, and pointed out that the strange crea ture had been in the vicinity for some time, but had not killed any animals to devour the meat, but that it killed was certain. Obviously, other reports had been received prior to the story leaking out to the press. Clem also warned that hunters for the unkown animal might accidentally mistake a human being in the darkness and fire with fatal results. Or they might wound the beast and infuriate it to the extent the gun wielder would be attacked and injured. The sheriff then asked that he be notified of any future sightings prior to anyone trying to kill or capture the beast. Assumed to be

a huge black gorilla lurking in the area, the county residents were on edge. Thursday, June 6, 1962, L. T. Doty, of Hickory Grove, reported that his two does had returned to the house with numerous severe lacerations and showing evidence of having been in a great fight. It wasn't known what the dogs had battled. Apprehension was high among the residents. Patton's Creek, Widwell Pike and the neighborhood of Hickory Grove were being avoided by citizens fearful that the beast might attack them. Trimble farmers armed with high powered rifles searched again through the undergrowth in another fruitless search to flush out the "Thing". The area in question was about 10 square miles, largely covered with dense forest and thick underbrush. At a point near the Ohio River a mile below Hanover is an area known as The Cliffs. Large rocks the size of cars, and caves from 20 to 70 feet deep was suspected of being the area where the unknown animal hides. Silas McKinney was concerned about his two 10-day old calves. As the sun poked through the trees around his farm early that June morning, he set out on his daily chores. There, lying on the ground about 15 feet outside the barn. Silas witnessed a horrible sight. One of his calves was dead. Its head had been smashed, the only sign of violence evident. Inside the barn. the other calf was alive, but had been roughed up. How or why, Silas couldn't imagine. The only entrance to the barn was a 2 1/2 by 3 foot window, eight feet off the ground. Under the window a farm gate leaned against the wall of the barn that hadn't been there the night before. "There ain't no way that calf could of climbed out", Silas told the sheriff. As Sheriff Clem looked around inside the barn he found tufts of black hair around the window frame, and took note that the remaining calf was in a 12 foot square pen, 4 feet high, made of heavy timber rails. Both calves had been in there the night before. Claw marks of some kind could be seen on the gate under the window, and in other areas inside the barn. Mrs. Dunn had stopped by to visit Ruth Corley Monday evening June 11, 1962. Their conversa tion had lasted into the night and Mrs. Dunn would soon have to eave. But a noise distracted both women. Together they looked toward the window and were frozen with fear Looking back in through the window was the most dreadful face they had ever seen. Strangely human, but inhuman, the beast was covered in reddish hair except for the face area. It just watched them, didn't move, didn't flinch, just stared back. The ghastly eyes penetrated the women, looked into them as much as at them. It disappeared just a fast as it had come. Both ladies reported they were unable to move as the dark, looming visage inspected them, even though a rifle was at hand. That night, as Mr. and Mrs. Corley were retiring and trying to figure out who or what had peered in, a scratching sound from the direction of their water barrel out back could be heard. Then the scratching moved: in front of the house now, almost too quick of a movement to be made by the same source. Faintly, incessantly, something was scraping at the window screen, but a glacial fear held them fast. Neither slept well and at first light they went out to look around. That's when they heard it, off in the distance across the field. "It coming from

over toward the Powell place", Ruth said as she and her husband strained to look deeper into the surrounding forest. And he gripped the rifle tighter. Owen was outside that morning. He heard it too. But not until the reporter uestioned every one in the area did it become known that they had both heard the same animal at the same time. Owen Powell's place is only a half mile down Kidwell Pike. Mrs. Corley told Sheriff Clem that sightings of the creature weren't anything new to members of her family. About 3 years ago, some type of animal would lurk in the weeds and high grass and thump along after her children when they went for the cows, "It made all sorts of weird noises", she said. About this time the Corley family was raising a garden with melons. "We'd never get a whole melon before that animal, or what ever it was, would get to it. It looked like a human hand had scraped the heart out of each melon", she said. "One time my daughter Mary went to the garden, and looking up saw a black thing that looked like a small monkey or chimpanzee standing in a corn row. As some other children were coming, she looked first to the kids, then back to the spot, and the beast had disappeared." Similar reports were heard about that same year from the Patton's Creek area, only a few miles from the Corley place. Byrd Varble saw it. He didn't want to and wished he hadn't. "I will never forget that awful thing", Byrd told Sheriff Clem Curtis. Two years ago, driving down Kidwell Pike it ran across the road in front him, illuminated by his cars headlights. It happened again two weeks ago right here in the same place. "It was walking upright, slowly across the road. I thought it was a chimpanzee or gorilla, about 5 feet tall with arms that hang below the knees", Byrd stated. Reports continued to roll into police headquarters. A hog and calf were killed on a farm in the area of the sightings. One man heard it "clomping" along back on June 9, 1962. A beagle belonging to Earl Grant, who resides at the foot of Craig Creek Hill, was found dead with its throat ripped out and other cuts on its body. Lester McDowell sent his son Lawrence into town to report strange animal deaths on his farm. He lived near Earl Grant, but had heard nothing of the beagle's death. Four lambs had been attacked. One each night from Thursday, June 14, 1962 till Sunday, June 17, 1962. But the last one had survived the attack with only a gash on its head. The other 3 had their throats ripped out, heads crushed, and all the blood had been drained from the bodies. Attack by dogs was ruled out by the farmer due to the manner in which the killings had occurred. No pools of blood were found near the carcasses. Silas McKinney, who has lost a calf to the monster, found two tracks out back in the mud on Wednesday, June 13, 1962. He dug it out with a shovel and saved it for Sheriff Clem. They're about the size of a human hand, with 4 stubby toes and claws evident on each toe. Madison Courier Newspaper reporter Ed Gulley took the mud tracks to Hanover college zoologists Dr. J. Daniel Webster for evalua-"It looks like a big dog to me, probably a doberman pinscher or even a large boxer. A dogs print would have four toes, small palm and claws. A gorilla has a foot very similar to a human being's, probably a longer instep and a little wider

than a man's. Nor could it be a bear since they're a round print with claws showing, but toes which are almost unrecognizable", Webster told the Madison Courier reporter. Everyone agreed that the prints could be that of a dog, and still not be prints made by the beast because the prints were found near a spot where the creature is thought to have been and were not witnessed in the making. He also said, "all animals of the monkey family, including the gorilla, have five toes. The two prints shown had four". Adding, "a dog could easily have killed the calf too". Muddying the waters more, Webster states, "There is no evidence to indicate that 'The Thing' is not a dog.` How Webster could tell what breed a dog was by the prints is miraculous to say the least. Identifying a gorilla footprint as similar to a human is a very loose description indeed because the largest digit on a gorilla's foot is opposable, like a human thumb. Stating that a dog could have killed the calf, knowing that the calf died from blow to the head, is suspicious at best, and sad at worst. No dog has ever been known to kill in this manner. And how a dog could have removed a calf from a barn through a window 8 feet above, the ground was not addressed by Webster. Nor the fact that no dog has been observed as having any part in the attacks or sightings except to have been injured or killed. "No animal could do this except a gorilla or a human being", Webster said. Adding that he does not give the first thought that it could be a gorilla, and, "only a human being could do such a thing." Sheep herdsmen in Trimble County familiar with dog attacks on sheep, explained that a dog attacks a sheep from the rear. They nip along the body until they reach the head. After the sheep falls, the final kill is at the throat, a type of kill that results in a very messy carcass, with blood all over. The sheep found killed looked like they were struck by a blow and there was no evidence of wool being pulled out along the body as it would if attacked by dogs. Dr. Webster, retreated from his dog theory and stated, "It is characteristic of a bear to become enraged and take revenge on other animals, if it were wounded by dogs or another animal. But most bears do not damage livestock, unless they are in the habit of doing it." In support of his bear theory, Dr. J. Daniel Webster said that black bears once roamed this territory and were generally distributed throughout Indiana and Kentucky before the early 1800's. "The last reported shooting of a bear in Indiana occurred about 100 years ago. It is not impossible for bears to be around, but it is highly unlikely", the zoologists said. He also said the beast might be a bobcat, but that this too was unlikely because bobcats attack in packs of three or four and most often eat their prey. "A bear has a very keen sense of smell, but they are almost blind", "If they wanted to, bears could stay out of human sight and be seen only occasionally, upon chance", noting that the countryside is plentiful with wild berries and fruit trees, the zoologists thinks, "a bear or two, and its cubs could exist there." TRIMBLE COUNTY SHERIFF TO LEAD SEARCH FOR BEAST, the Madison Courier front page headline read on June 16, 1962, and was accompanied by a photograph of Sheriff Clem Curtis standing along side State Trooper John Miller's

patrol car as they checked their radio equipment in preparation for the "all-out" hunt. Radios were supplied by the Madison Radio Service, oordination of the hunt with the state police was important to the Sheriff. The article went on to say; There is some form of animal still on the loose in the northwest part of Trimble county-be it gorilla, bear, lion, or large dog-no one seems to know for sure, but many are sure something is there that doesn't belong, and they want it eliminated." Sheriff Clem Curtis realized what he had to do to quell the fears of his constituency We'd like to get it alive if possible, or dead if necessary. But we want to be sure he's removed or run out of the area. The people are scared and they want action., he told reporters. As the hot summer evening squeezed the sweat out of the determined group of men, Sheriff Clem surveyed his forces arrayed against the unknown. A large number of men, keen eyed and armed with rifles pow erful enough to drop any beast in the area milled around the police cars. Exactly how many wa never revealed, but the sheriff had asked that, "all persons desiring to join the hunt to register with him since vicious dogs will be used that could seriously injure anyone not in the party." Seven highly-trained, vicious police dogs arrived from Louisville, Kentucky. Steve lieischaker, a special dog trainer, offered the dogs, and joined the search. A helicopter will be overhead in case the creature is flushed into the open. And a Louisville radio Station placed an airplane at the sheriff's disposal to make air patrols. They all set out at 7 PM Saturday evening, June 18, 1962. The posse, combed the countryside near Kidwell pike for 5 1/2 hours. It was called off at 12:30 am Sunday morning, June 19, 1962. No gorilla, no lion or bear, not even a dog was seen. Everyone went home without knowing what lurked the dark places of Kentucky that hot June night. We may never know. No further documentation has become available. It was believed that what ever was there, had been flushed out as a result of the activities of the hunters, and increased traffic at night.

In addition to the "Beast" lurking some where in Trimble County, Hildred Paschall reported a snake as big around as a stove pipe and estimated its length at 28 feet. Reported in the Madison Courier of Thursday, June 21, 1962, officials near the community of Hazel, Kentucky requested the help of a trained snake handler in assessing evidence of a large reptile. Ernie Collins, a carnival snake handler, working in conjunction with Murray State College biologists Dr. Hunter Hancock, found belly tracks and other evidence that indicated a snake some 20 feet or better was in the area. Raided squirrel nests at least 20 feet off the ground had been found and Mr. Collins conjectured that the reptile might be a dimbing snake, possibly an Indian Python. Markings on the snake witnessed by Hildred Paschall corresponded to the markings of the Indian Python, Hancock said. There were no reports of escaped reptiles. Dr. J. Daniel Webster was contacted in February of 1999 in regards to this series of events. He is still active in research, Professor Emeritus at Hanover College, and remembers the incident vividly. Webster indicated to this writer that together with a Madison Courier reporter and the sheriff of Trimble County, they visited the

barn where the calf had been killed. He estimated that the calf was a half grown heifer and admits that he did not see the carcass. The conclusions he offers, still clear in his mind after 37 years, are as follows: " !.) The killing had probably been done by a large dog, possibly the one I had seen (large, black, shaggy St. Bernard size on neighboring farm less than a mile from the killing place), or perhaps a group of dogs. 2.) Rumors and newspaper stories make fine tales (see Conan Doyle's The Hound of the Baskervilles.) all due respect for the eminent Dr. Webster, this all sounds extremely ridiculous. The "Beast" had been identified by authorities variously as a bear, mountain lion, dog, gorilla, chimp, bobcat, human. The method of killing was unlike any of these, and indeed beyond the capability of all these save human and gorilla, as stated clearly by Webster back in 1962. It was in 1958 that road construction workers found large human-like footprints in the Bluff Creek, California area, and Jerry Crew made a plaster cast of a print and reported it to a local newspaper. This story was carried nation-wide and bigfoot was exposed to the world. Although not widely known, reports of creatures matching descriptions in Trimble County in 1962 have been around for a long time. But no consideration was given to the obvious solution. As the saying goes: after you have eliminated the impossible, whatever is left, no matter how improbable, is the solution. Is the "beast" is a big-foot? YOU DECIDE !!!

Numerous reports of Flying Triangles are becoming common place. This infers that either they belong to our government or possibly alien forces. The following Flying Triangle reports may help provide significant evidence in our search for answers

GEORGIA

Former Chief of Police Tom Sheets, the Georgia MUFON State Director writes that he has information regarding the 'booms' heard in West Georgia and Eastern Alabama on August 2, 1999. This event has been heavily covered in all of the Atlanta and Georgia news. John Thompson of La Grange, a founding Board Member for ISUR and former MUFON State Director, advised that Georgia Emergency Management Agency (GEMA) had assigned a team to investigate this event. GEMA has also located a witness that observed something coming down, with speculation about it being a 'shooting star.' GEMA has also stated that these circumstances indicate a security or safety threat, hence the investigative team.
Three witnesses from Chambers County Alabama have come forward. At 9:58 PM on Monday, August 2, 1999, there was a loud boom heard throughout the area around Troup County and into Eastern Alabama. There was a concurrent interruption of satellite TV and some cable broadcasts, as well as some power disruptions. Dogs went wild, howling and seeking cover, then everything became completely quiet.

About a minute after the boom, the three witnesses went outside to look and listen and saw two huge 'V' shaped objects fly directly over their home. The craft were moving completely silent at about 30 mph at an estimated 250 to 300 feet altitude. They calculated the size of craft to be about 160 feet wide. They saw 7 or 8 very bright, very big, (like blue-white halogen) lights aligned along the surface. The observation was about 5 minutes in duration, or until 5 jet fighters arrived on the scene as if in pursuit. At that point, a witness stated that the two 'V' shaped craft split and went straight up, arching apart at an incredible speed. They left a bright streak as they departed. The streak estimated apparent size was about 3 feet long if held at arm's length. Local authorities have vouched for the reliability of the primary witness in this case. Furthermore, a spokesperson for the Troup County Georgia Sheriff's Department has stated that they received a report from another witness of seeing an unusual bright white light on nearby West Point Lake. This lake seems to be 'center point' for anomalous events in the Troup area. Thanks t John Thompson and Tom Sheets, ISUR Board Thanks to www.isur.com. Editor's Note: These Flying Triangles may represent an advanced antigravity propulsion system that affects electrical power and television transmission. Did they penetrate from space causing the sonic booms? Remember the F-117 Stealth fighter represents 20 year old technology and the Black Budget spends billions on dollars annually, more than is spent on health and education. We can speculate these craft were

Senior Citizen (Program Element 041316F) a tactical lift aircraft. A vertical lift aircraft could operate from Eglin Air Force Base and use low level training routes over Heard County to train for troop insertion and covert activity. The craft deliberately operate at low altitude in order to avoid radar detection. The possible intercept by jet aircraft infers that an exercise was taking place or the jets were actually chasing alien UFOs away.

FLORIDA

FORT MEYERS - On July 31, 1999, at 11:30 PM a young man and his friend went out by the pool and noticed 3 blinking lights very low on the horizon in a symmetrical line. The objects changed color from white to red to orange and back to white. After getting binoculars they saw the lights stop blinking and then start again. Sometimes two lights would blink in unison and then stop. The observers saw the bottom light come up to the middle one and stay by it. At one point they saw a fourth light come up quickly from below and disappear back down again. After midnight at 12:25 the three lights formed a triangle, sometimes blinking in unison with a fourth and fifth light coming from the east. It seemed to move east slightly, just above the trees. DEERFIELD BEACH - On July 20, 1999, at 8:10 P.M. a woman driving home from work saw a "large silver rod-shaped craft" at Military Trail and S.W.10th Street.

OHIO

COSHOCTON - Jenny Herritt reports, "I just got back from Ohio where I was investigating some strange occurrences. Hawk and Karen who live on the infamous Township Road 6, where there are frequents strange sightings saw a triangle shaped UFO last April. The craft hovered and slowly moved around the area for 15 to 20 minutes. Then it seemed to descend below the tree line. The UFO was dark in color and had rapidly flashing bright lights. The sighting lasted about five minutes. Angular elevation was 45 degrees and object was seen to the west. The region is fairly remote and heavily forested. Witness did not attempt to follow the UFO to the apparent landing site. Due to the heavy cover they were not able to determine location of where the UFO descended of if it did land. OAKVILLE -- Sunny Barclift writes, "I appeared on the 'Unsolved Mysteries' program in 1997 regarding the gelatinous goo that fell over my mother's farm and surrounding area. Around 8:00 PM, on the third day following the first fallout I witnessed a very large dark charcoal gray triangular craft "floating" over our neighbors house. I say floating because it appeared to be flying slower than the stall speed of a conventional aircraft. It made absolutely no sound. The most anomalous feature of the craft was that it glowed all around the periphery a yellowish, green neon-like glow. There were contoured areas present and small rectangular "windows" from which emanated a soft diffused yellow light. The undercarriage appeared as though it had been molded. This sighting occurred on August 10, 1994. The craft was approximately 80 ft by 100 ft. It was at an altitude of about 500 feet. BOOK REVIEW

Unconventional Flying Objects A Scientific Analysis

Reviewed by George Clappison Hampton Roads Publishing Co. Inc. Copyright 1995



Unconventional Flying Objects: A scientific Analysis is the most in-depth, concise, and scientifically valid effort to date regarding the alleged "imposible" aspects inherent in nearly all reports of unidentified flying objects. Paul Hill first became interested in UFO's on July 16, 1952. He watched four vellowish lights rendezvous above Hampton, Virginia at 9pm. The lights were too large for aircraft. Two of the lights engaged in a rotational maneuver about 200 feet apart, within a period of one second. His scientific assessment yields a 123g force exerted upon the objects. Well beyond earth technology, but not beyond earth's scientific understanding of the laws of physics.

Paul Hill began his career with the National Advisory Committee for Aeronautics, the predecessor of NASA, National Aeronautics and Space Administration. He was prevented from making any announcements about UFOs by both NACA and NASA. Their official policies being that UFOs are nonexistent His accomplishments and credentials are too numerous to list. But his expertise in Mathematics and analysis relating to Aeronautics, rocket propulsion, advanced materials, orbital navigation, to name a few, is certain to usher Ufology into a new era. Mr. Hill thinks of his work as a shift from one type of spacecraft to another. He states: "The world of UFO students have literally and openly been crying out for scientific assistance and explanations. This book is my answer!"

The rationale used in the analysis is primarily simple logic, and the usual fitting of the evidence to theory in what has come to be known as the scientific method. Hill has developed a UFO pattern comprised of highly repeating aspects of UFO behavior. Hill seeks answers to the UFO enigma in

the physical sciences. The main objective of the analysis in the book is to present what can be explained of the UFO pattern in terms of todays scientific principles. Those debunkers that cry, "defies the laws of physics", will be discredited.

Skeptics often sight the speed of light barrier as a reason to dismiss UFO'S. Mr. Hill shows that the time reference frame for occupants of a craft is not earth time, and tells us that, "Nothing goes faster than the speed of light, but spaceships can go more quickly as reckoned by their own time." The mathematical proofs that are presented to explain UFO characteristics are backed up by sound scientific principles which are extensively referencd to verifiable sources. All mathematical proofs presented by Hill have been verified to this writer by a scientist who works in the same field as Paul Hill.

An analogy to the situation in the UFO field of having theories that can explain UFO's but not the technology is the attempt to experimentally confirm Einstein's theories. On May 29, 1919, scientists watched light from a distant star appear to bend inward as it passed through the gravity field of the dun during a solar eclipse. And sometime between December 1999 and October 2000, Gravity Probe B is scheduled to be launched. It is an instrument that was conceived of in 1959. funded by NASA in 1963, and intended to confirm only the second of the theory's prediction that a spinning body would drag space and time around with it. Only now have we developed the technological knowhow to measure such a small effect.

Some of Hill's theories are already being applied to aircraft. Funding of research into Hill's idea of plasma fields as they relate to supersonic airflow over the surfaces of aircraft, has been granted. The goal of this research is to produce an aircraft that could fly faster that the speed of sound without generating into a sonic boom. Yes, Paul Hill was years ahead of his

Scientific validation of the many sightings through the years mey confirm what many have believed all along. That the government knows that UFO technology is not only explainable, but attainable!
