NEW CASES

Recently MUFON received some media attention.
The Channel 7 news team interviewed Marge
Christensen and Linda Seal on the 6:00 p.m. news
on Thursday, Jan. 20th. That Sunday morning, Jan.
23rd, Marge Christensen was a guest on the Boston
Sunday Review program on WBCN radio for one hour.

Following these two programs, we received eleven phone calls on the Hotline, and many of these were related to new cases. Sightings and UFO-related experiences were reported to us in the following locations: Cambridge, Stoughton, Medford Danvers, Fitchburg, Sagamore, Wareham, in Massachusetts; also, Las Cruces, in New Mexico, as well as central Pennsylvania.

These cases have been assigned to the various State Section Directors, who are in the process of enlisting field investigators in their areas to investigate them. There will be an extensive discussion of these cases at the February meeting, and hopefully, a follow-up discussion in March.

For Income Tax Purposes

The Mutual UFO Network, Inc. is exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code. MUFON is a publicly supported organization of the type described in Section 509 (a)(2). Donations to MUFON may be deducted as contributions from Federal income taxes.

Also, investigators may deduct 9¢ per mile for transportation costs incurred with work for MUFON. The activity log in your case report is sufficient verification that you did travel in conjunction with an investigation. (The IRS will accept this.) If you should have to stay overnight during an investigation, you may deduct motel and meals and tolls costs, but you must be able to verify that this was part of your work for MUFON and was not a personal vacation.

UPI RELEASE

Some time ago, a National Committee on Public Education was appointed by Walt Andrus. Committee members include: Dennis Stacy and Tom Deuley in Texas, and Marge Christensen, Walter Webb, and Joan Thompson, in Massachusetts. One function of committee is to continually write press releases for the UPI news wire services, in order to keep the UFO topic in the national news. The first release, which deals with the govt. documents we have received under the Freedom of Information Act, is slated for release on the weekend of Feb. 19 and 20, according to Walt Andrus. This particular press release was prepared by the Massachuset members of the committee, with Barry Greenwood acting as a special advisor. Count Your Blessings

A second letter, dated Jan. 25, 1983, has been received by Marge Christensen, from Cynthia Hind, MUFON's Continental Coordinator for Africa. She relates in the letter how excited she is that at last she has one new case. Her other cases are old cases that have just been reported. Ironically, now that she has a new case, the shortage of gasoline in Zimbabwe is so severe, that she is unable to obtain gasoline for her car, and is therefore unable to travel to do any investigative work on the case.

The new case involves a sighting of a blue light in a place called Chinhoyi, which is 74 miles from Cynthia, who lives in Salisbury. The farmer who sighted the object managed to pinpoint the spot where he thought the light had actually come down on a hill. He found that some of the bushes in the area were flattened and around the bushes there were some thin arrow marks, and what looked like a "bear" imprint. (There are no bears in Africa!) The light had been seen on numerous occasions, and the man's niece wrote to Cynthia to say that she too, had seen the arrow marks in another area where the light landed on another occasion. Strangely enough, the farmer's neighbor then reported waking up one night to find three men in silver suits standing outside his window. Costs of items purchased in conjunction with an investigation, such as tape cassettes, compasses, cameras, etc. are not deductible. If the item to be purchased were costly, one should write a check to MUFON, and then have MUFON purchase the item. That way, your check to MUFON will be considered as a deductible contribution. The same rule applies to payments made for lab fees or psycholological testing administered for a witness. For your check to be considered deductible on your Federal Income Tax, you should write it to MUFON, and then have the bill for the serwice submitted to MUFON.

I have spoken with an IRS representative, and have also ordered an IRS publication on this type of deduction. The publication is #526, and may be obtained at the JFK Bldg. in Boston. You may deduct your MUFON contributions and other case-related expenses which qualify, on your 1982 Federal Income Tax Return.
