## Current Cases on New Computer File

At the suggestion of David Webb, we are now maintaining a computer file of all cases which have been assigned to our investigators since Jan. 1, 1983. This information will enable us to see at any time, how many cases are under investigation; what types of cases they are; how many cases a particular investigator has and how many people may need assistance as a result of a large case load, etc. At each meeting, a print-out of these cases will be available.



As a result of a recent influx of application for membership from several less than serious individuals, the State Director and State Section Directors, together with Special Advisor, Joe Santangelo, met to compile a policy regarding membership requirements as well as requirements for investigators. These requirements are intended to be fair to everyone and to maintain the professmonal caliber and high level of credibility of the Mass. MUFON organization. # Computer File of Resources Proposed

During a meeting of the Section Directions and State Director before the Feb. meeting, Bob Gildea and Joe Santangelo proposed a directory format which might be used in compiling a computer file listing all of the resources which Barry Greenwood has available in his "mini UFO Smithsonian Institution," and which would be helpful or to us in attempting to locate specific items. This material includes books, files, clippings, reports, audio tapes, video tapes, movies, slides, cassettes, paperbacks, microfilms, etc., etc., etc.. This task will most likely be tackled in the summer after Barry has completed the work on his book.

It will involve a greatdeal of man hours indexing and cataloging, and anyone who would like to assist, especially if you have a background in computer programming, should let us know that you are interested and willing to work on this project.

Such a computer file would be of great value to investigators as well as to persons researching any aspect of the phenomenon.
