EXETER-HILLSBORO SELECTED LOCATIONS FOR VIDEO

I mentioned in the October 1986 newsletter that we are puttimed together a video of locations where significant historic events occurred in the New England area. UFO researcher and investigator Rick Giordano has been instrumental in selecting some of these locations near his hometown of Fremont, NH, particularly the Kensington-Exeter area. Thanks to Rick's assistance, I am now familiar with some of these country back roads of the Granite State where some of the best documented UFO accounts took place.

Journalist John G. Fuller studied and documented a series of sightings which occurred in Exeter, NH during the Fall of 1965. He published his findings into a book titled. "Incident At Exeter".

The sighting that received the most publicity occurred on Sept. 3, 1965. The sighting involved Norman Muscarello and Police Patrolman Eugene Bertrand and David Hunt who had a close encounter with a huge, roundish object, eighty to ninety feet in diameter with brilliant pulsating red lights. The object hovered and wobbled as it bathed a ten acre field in red light. Sixty people reported UFO sightings in the Exeter area during the fall of 1965.

Another selected area of ufological value is Hillsboro, NH. Robert Giqlio, a free lance photographer(now deceased) spent three years interviewing and recording witnessesin the area. From July 1977 through the next four-year period, there has been over 60 UFO reports from Hillsboro. These reports were of various description; 25 ft. in diameter top shape, rounded football shape, dirigible shaped and N/L's.


One interesting encounter was a report from a couple returning from a basketball game. Billy and Laurie recently became engaged and decided to park behind his family's barn as it seemed a good place to be alone for a few minutes. Billy then noticed what he described as a big Contact capsule floating on its end. It glowed a yellowish-bluish color and estimated its size to be about 40 ft tall and 15 ft. wide. They both watched as it drifted across the field at about treetop level until it was directly over their truck. At that moment, the radar detector located on the dashboard went off with a buzz. The object hovered over them for about a minute creating a humming noise. The object drifted away and then accelerated and was gone in an instant.

Up until the time of his death, Bob Giglio felt a federal investigation into the Hillsboro events was warranted.

Other areas of ufological significance currently being considered for videotaping are Fremont, NH, Ashburnham, MA, U.S. Highway #3 in the White Mtns, NH, Salem, MA, Fairfield County, Conn. and Pease Air Force Base (IFO segment). Videotaping will begin this fall.

The abduction scene is currently being reported strongly in magazines, newspapers and by the electronic media. Since my return from the D.C. symposium, Mass. MUFON has received approximately 30 phone calls from people wanting to report an abduction experience from reporters eager to interview an abductee or those seeking information on abductions. The handful of investigators who are capable of working with this type of case are putting more time in the field now than they ever did or probably ever will.

The latest influx of cases has pushed some of Mass. MUFON's projects and previous cases onto the back burner. Has a Pandora's box been opened? It certainly has!

Whitley Streiber (Communion) now has a great following as evidenced by our recent symposium. Streiber is a rabid believer and his fellow Communionites are likewise. These followers are attaching themselves to Ufology with Streiber as their Supreme Idol. By believers, they are more attuned to belief and faith rather than evidence and consequently their coming into the field can be just as detrimental as a debunker in that they do not favor a scientific review of the UFO situation. Both true believers and debunkers think they have the answer.

Budd Hopkins stresses that the patterns and content of abduction reports cannot be ignored and a thorough investigation is needed. However, as always, Budd is quick to point out that he is a committed skeptic (open-minded) and would welcome other explanations of this phenomena.

Camps are forming between the avid believers and those who work in a calm, objective scientific approach. This is also occurring with the people involved with government cover-up. The results of the MJ-12 circus created by Moore, Shandera, and Friedman could be detrimental to the future of document research. The hunger for publicity or for financial gain by any type of self-styled expert can be as damaging to the subject as the crackpots and fanatics. Moore and Friedman, of all people, should realize that by promoting evidence loaded with loopholes will cause people to question the quality of their research and would be disasterous to their reputation.

With the onslaught of abduction reports, the MJ 12 sideshow, the pop wave of channeling (there is now strong evidence of channeling in the metro Boston area with two individuals representing this new pop movement by appearing on numerous radio programs and holding channeling conferences in the area), and the rabid believers, an aura of illegitimacy is slowly forming around Ufology. Many prominent researchers and investigators are now falling back, regrouping and revising their thinking. Some of these people probably will go underground.

A word of caution: Ufology at this point in time is similar to a vast mine field. The only way to safely cross tothe other side is to study it, walk slowly and calmly and be careful where you step!



Public interest increases despite - U.S. coverup

As you and many Register readers are aware, the UFOs are back and public interest is increasing tremendously. This is happening when there is presently no major wave of sightings — the last

nationwide wave was in 1973. First, I would like to make it clear that there are competent, qualified and objective investiga-tors researching UFOs. Many researchers have master's and doctor's degrees in the sciences. In fact, some reside here in Connecticut. My UFO research started in the mid-1970s and really took off in the last three years. I am a

1987 electrical engineering graduate of Greater New Haven State Technical College.

Secondly, it should be noted that people who report UFOs, whether they be distant sightings of unusual lights and formations or close contact, are generally reputable, non-publicity-seeking, truthful individuals. Hoaxsters and phonies are easily distinguished. Cases of simple misinterpre-

tation are also generally recognizable.

The U.S. government has purposely been concealing substantial, solid UFO reports and encounters from the public since 1947. This is not

heresay or fantasy. This is fact and can be proven if anyone bothers to take the time to read the government's own statements obtained by UFO investigators through Freedom of Information Law requests. The public has a right to know and the excuse of national security is not and never was justifiable.

UFOs have been with us since biblical times

and their presence has really stepped up with atomic testing and development of radar systems in the mid 1940s.

I find this to be no strange coincidence. Note that not all UFO researchers have a deep-rooted fear of "atomic self-destruction" or a need to "escape this world's reality" via spaceships with little green men. This nonsense was cooked up by critics who could not explain the phenomena or hard evidence themselves.

Judge rules UFO-search ads can run

A federal judge in Alexandria has ruled that the U.S. Army must allow a civilian employee to place advertisements in defense newspapers asking potential whistleblowers to come forward with their knowledge of government information on UFOs

U.S. District Court Judge Claude M. Hilton earlier this month ruled in favor of a lawsuit brought by Larry Bryant, a civilian employee in the Pentagon, who claimed that his constitutional rights were violated after Army and Air Force newspapers rejected his advertisements.

Mr. Bryant, 48, is the founder and president of CAUS, or Citizens Against UFO Secrecy, which contends that the government is guilty of covering up what it knows about unidentified flying objects.

"You cannot escape the conclusion that the government over the last three decades has known more about the UFO problem than they have let on," said Mr. Bryant, who has worked as a senior writer for AR-NEWS, the Army news service, since 1981.

Mr. Bryant contends the government's acknowledgement of UFOs would create a dilemma because of "the far-reaching impact on society, military preparedness, space technology, religion and culture."

Judge Hilton also ordered the lawsuit's defendants — Defense Secretary Caspar Weinberger, Secretary of the Army John O. Marsh Jr. and Secretary of the Air Force Edward C. Aldridge Jr. — to reimburse Mr. Bryant \$2,000 for legal fees. But the judge dismissed Mr. Bryant's claim that he had been unfairly harassed at work because of his UFO-related activity.

Mr. Bryant contends that his job rating went from "Exceptional" to "Unsatisfactory" in 1985 after he began to place advertisements in various defense publications seeking the testimony of government employees who had knowledge of UFOs. Judge Bryant ruled that Mr. Bryant could appeal the job harassment charge.

UFO symposium

Having just returned from the 18th Annual Mutual UFO Network Symposium held on June 26-28, at the American University in Washington, D.C., I was astonished by the variety of UFO encounters presented by a panel of UFO experts from over a dozen countries.

Besides listening to some fascinating abduction cases from the likes of Whitley Strieber, author of the bestseller "Communion," and Budd Hopkins, author of "Intruders" and "Missing Time," the most impressive development at the symposium was the release of government documents by the Moore-Shandra-Freidman Research Project into U.S. Government UFO Policy.

The controversial papers, released to the press in May, describe a secret project known as Operation Majestic Twelve, consisting of a group of 12 respected scientists who were secretly brought together for the purpose of examining the remains of wreckage of a UFO and its four dead occupants near Roswell, New Mexico in July 1947.

The documents, marked "Top Secret" indicate the panel of scientists was established by executive order by President Truman on Sept. 24, 1947, and was inherited

by President Eisehower.

The Research Project crosschecked the details in the documents for over two years before their May release, to insure their accuracy. Although the CIA has labeled the documents a "forgery," they fail to explain, why all 12 scientists were either in New, Mexico or whereabouts unknown in July 1947. A document released by the National Archives on January 12 of this year describes when the President wanted to be briefed by the MJ-12 group during a regular White House meeting in July 1954. Additional evidence, not released at the symposium will be forthcoming.

Three books about alien visits are selling briskly; one of them has topped the nonfiction best seller list for weeks. Clubs, newsletters, mov-ies, and lectures about unidentified flying objects are generating revenues at a pace exceeded only in the 1950's, during the first wave of U.F.O.sightings.

Enthusiasts are now even charging that for 40 years the Federal Govern-ment has harbored physical evidence of an earthly encounter with extraterrestrial creatures, including their lifeless bodies and damaged space-craft. That startling report, dis-

In interviews, psychlogists, historians, philosophers and writers of science fiction said belief in allen en-counters was rooted in such things as the need for secular messiahs and the search for explanations for terres-

trial troubles.
"The urge to investigate and be-lieve in this stuff is almost religious," said Ben Bova, former editor of Omni magazine and a writer of science fic-tion. "We used to have gods. Now we want to [ee] we're not alone, watched over by protective forces far beyond

But others, often sober, respectable, scientists who have studied U.F.O. termorts for years, said the skeptics were missing the biggest story of the

"People who haven't been paying. attention to this stuff are in for a shock," said Dr. Bruce Maccabee, a full-time Navy physicist in Washing-ton, D.C., and a part-time U.F.O. re-searcher. "Some sort of things have been flying around for decades, and; they aren't ours."



Space clutter causing concern

Rapidly accumulating space debris is a growing danger causing problems for satellites and manned space vehicles, and

adversely affecting ground-based astronomy, scientists say.

The North American Air Defense System (NORAD) tracks
6,194 trackable objects, only 300 of them operating satellites. according to Astronomy magazine. The magazine said 40,000 golfball-sized pieces and billions of smaller ones are not being tracked. The debris is made up mainly of expended rocket stages, rocket panels, fragments from exploded satellites, nutseand bolts, and even hand tools that astronouts have dropped

and bolts, and even hand tools that astronauts have dropped.

The debris is expected to double by the 1990s, says Donald Kessler, NASA orbital debris specialist. Proposed solutions include trash-collecting satellites equipped with "scoops" to pick up stray objects.

All three tell of personal encounters with aliens. In this they differ from the last great period of U.F.O. enthusiasm, in the 1950's, said David M. Jacobs, author of "The U.F.O. Controversy in America" and a historian at Temple University in Philadelphia. In the 1950's U.F.O. sightings were in vogue. Now, he said, we are in a "new era" in which aliens are taken as fact and attention had turned to "people's

experiences" with them.

Indeed, the hottest topic among U.F.O. enthusiasts is what they describe as the Federal Government's experience with aliens, especially the "Roswell Incident," one of the oldest U.F.O. episodes on the books. Timothy Good, a British U.F.O. researcher, and a group of U.F.O. investigators in the United States say they have documentary evidence that the Government hid its knowledge that a "flying saucer" crashed in 1947 near Roswell, N. M., killing its crew of extraterrestrial creatures. The charges are contained in Mr. Good's book "Above Top Secret: The Worldwide U.F.O. Cover-Up," to be published in Britain in July.

The Roswell Incident

The Government's position is that the 1947 incident was nothing more than the sighting of a weather balloon. But the U.F.O. researchers cite a newly discovered document, dated :Nov. 18, 1952, purportedly a top-secret briefing paper for President-elect Dwight D. Eisenhower. It discusses a secret Federal team known as Majestic-12, or MJ-12, established by President Truman on Sept. 24, 1947 to investgate the of the spacecraft and its crew.

"It appears to be genuine," said William L. Moore, who wrote a book about the incident and who investigated the document for more than two years after a colleague received it anonymously in the mail. But he said there is nothing in the records "that shows it's a fraud."

Stanton T. Friedman, an nuclear physicist in Frederickton, New Brunswick, Canada, who is investigating the document with Mr. Moore and who lectures widely on U.F.O.'s, acknowledged that interest it generated would raise lecture fees but said their goal was to get at the truth.

"We're dealing with something of extraordinary importance," he said. - thentic."

"What this means is that we humans are not the big shots we think we are." He said the landing was concealed because "no Goverment wants." people to have their allegiance to the planet rather than themselves."

Reflecting on the scope and intensity of the current flurry of interest, " Jerome Clark, vice president of the J. Allen Hynek Center for U.F.O. Studles in Chicago and editor of "Internattional U.F.O. Reporter," said: "What's interesting is that all this is. happening in the absence of a sighting wave. There hasn't really been! anything sighted since the 1970's. If I were paranoid, I'd say it's quiet, too

Frederik Pohl, a science fiction writer, said belief in U.F.O.'s is flour-Ishing now because the nation's political leaders are seen as floundering. "We're told by our leadership to bei resolute against terrorism, yet they make deals." he said. "We're told; 'Star Wars' is the future, but no one other than Ronald Reagan believes it. People have lost trust in reality and. they're looking for something else."

Michael Wertheimer, a psychologist at the University of Colorado who, has participated in studies that de-bunked U.F.O. reports, agreed that, feelings of helplessness tended to reinforce the urge to believe in the extraterrestrial

Paul Kurtz, a philosopher at the State University of New York at Bulfalo and chairman of the Committee, for the Scientific Investigation of Claims of the Paranormal, said the current U.F.Q. wave was "part of a. bizarre trend in which there is no sense of standards of evidence."

Dr. Maccabee, the Navy physicist, conceeded that skeptics often made valid points, "But the simple fact is;" that there are unexplained sightings," he added. "Over the past 40 years there have been 100,000 sightings, with 10 to 20 percent that are hard to explain."

In the case of the purposed Eisenhower documents, he said, "maybe somebody's been clever, but I think !-there's a good chance they are au-
