that information and has sent it together with a cover letter to the major networks, major newspapers, national news magazines, and some of our Conggessmen, in the hope that they might pursue the subject a bit further and follow-up on the Bentwaters report of CNN.


#### REGARDING SUBJECT MATTER FOR A PUBLIC AWARENESS CAMPAIGN...

## KEN MC LEAN TO SPEAK ON EDUCATING THE PUBLIC AT LARGE CONCERNING UFO PHENOMENA

Wyoming State Director, Ken McLean, has requested permission to present a paper on Friday evening at the Symposium in St. Louis. His paper will be entitled: "Educating For Critical Consciousness: From Thought to Action." Ken stated that: "Proponents of UFO research have always sought public support for their important work by attempting to educate the public as to the reality and importance of the UFO phenomenon. Traditional tools of lecture, seminars, forums, conferences, symposiums, publications, lobbying, etc., have been employed, and successfully if gauged by recent Gallup Poll "awareness ratings." But to achieve optimal effectiveness, education must lead to critical thought -- and critical thought to action. This paper will explore the principles of "critical consciousness" as they apply to the difficult task of encouraging the public at large to ACT on their UFO awareness."

Ken will speak at 8:30 p.m. on Friday evening, and at 9:00 p.m., we will hold our second annual meeting of the P.I.P.E. Committee.

## VIDEOTAPE TRAINING FILM TO BE POSSIBLY

#### AVAILABLE IN LATE MARCH

According to Dan Wright, Michigan State Dir., and P.I.P.E. Committee member, the two packages (one for lectures for the public, and one for investigator -training) are just about ready. Slides have been contributed by Barry Greenwood, Tom Gates, Dan Wright, and Marge Christensen. Also, additional slides are about to be included from Ray Fowler's collection. Dan plans to make 2 different sets of slides available for each of the types of sets. The only difference will be in the number of slides included. For example, in the set for use with the public, one may be able to purchase a set of 40 slides or a set of 60 slides. The same will be true for the set of slides for training field investigators. The numbers of slides mentioned here are purely hypothetical, and may or may not coincide with the actual numbers decided upon by Dan. Specific details regarding price and content of each slide set will be forthcomin in the March Newsletter.

Dan Wright is to be commended for his fine efforts in this vein, and for his time and efforts in finalyzing the field investiga-tor's examination.

#### COMPUTER CATALOG AVAILABLE

The computer catalog of UFO resources (available in three regional UFO resource collection centers) is now available. The catalog currently lists over 1000 books, hundreds of audio-cassettes, video cassettes, hundreds of UFO periodicals, clipping files, special publications, and microfilms. The catalog will also be expanded to include Govt. documents obtained under the Freedom of Information Act.
