#### PR OFFICE PREPARES FOR MEDIA IMPACT

In the face of at least two major network programs reportedly planning to focus on the UFO subject, preparations are being made here to respond to possible requests from the media for further information on the subject. If the programs do not come to pass, we will have lost nothing by being prepared, and if they do get aired and are as significant as they are reportedly going to be, we will be ready to furnish the necessary information at a moment's notice. A list of qualified spokespersons along with their areas of expertise, their addresses and their phone numbers is being compiled to be furnished to media personnel requesting information on various aspects of the subject. These lists will be sent to the major networks and major newspapers in the country. Also, MUFON is listed in a media directory under the topic of UFOs, so that media persons should be able to quickly contact Walt Andrus to obtain further information on the UFO subject.
