#### AN ESTIMATE OF THE SITUATION FOR 2002

These seem to be "military" times. In the military, at critical points in a battle, the commander may put together an "estimate of the situation" for higher authorities. Our "higher authorities" are the ufological community. Here is my estimate of the situation.

In a September 1947 memo, Lt. Gen. Nathan Twining wrote of the "lack of physical evidence in the shape of crash recovered exhibits". Debunkers and skeptics such as Karl Pflock, former intelligence agent, have tried to interpret this statement as evidence that the U.S. government had not retrieved any crashed alien craft. Such alien craft, containing advanced technology that the science of that day would have considered a priceless bonanza, would be properly given the highest possible security classification. Even if Twining were aware of crash recoveries, he could not write anything that would indicate that they existed, and might well write something purposely misleading, if not untrue. Note that the word "lack" does not necessarily mean "a total absence"! The purpose of Twining's memo was to order the military to collect all possible information about unidentified flying objects, not to tell the world what the U.S. knew at that point in time. Yet Pflock writes, "Finally, I come to the formerly classified record, which I am convinced demonstrates beyond any reasonable doubt that Roswell didn't involve the recovery of a crashed saucer and the bodies of its crew." Much of the record is missing. The base traffic records for a year before and after July 1947 are missing, and the filed is marked "Records destroyed" with no record as to who ordered this or why. Project Blue Book contains not a word about the July 1947 events at Roswell, which caused guite a stir at the time. Many other researchers, including myself, have concluded that the released documentation demonstrates a strong interest on the part of the government in the UFO subject, an interest implying that the government had hard evidence of the reality of these flying objects. Finally, the UFO research community has hard evidence, as I have described in previous articles.

So we have hard evidence. So what? Elaine Douglas, in an article in a past issue of the MUFON UFO Journal, has pointed out something that should have been obvious to all UFO researchers: Most people do not want to know about UFOs, and, God forbid, ETs. Yet a majority of the American public believes the government is not telling us what it knows about UFOs. The public is not stupid. In the backs of their minds, they must feel that there is are secrets about UFOs which the government does not want revealed. Journalist Terry Hansen has convincingly shown that, by and large, the press doesn't reveal much about UFOs and ETs either, as a result of behind the scenes influence by the government. Oh, sure, we have the National Enquirer (and other similar tabloids), but a former editor of the Enquirer was, you guessed it, a former intelligence agent! It seems likely that anything the government wished to discredit would pop up on the front page of the Enquirer or some of the other tabloids. So, to oversimplify the situation, the people don't want to

know, and the government and the press don't want you to know. Yet, slowly but surely, knowledge of the unknown phenomena seep out into the public. Cable TV has done a particularly good job of showing credible documentaries on these subjects.

During the last Presidential campaign, a MUFON member accosted George W. Bush in the company of Dick Cheney and in the presence of a CNN reporter and asked him, "If you are elected President, will you tell the American people what the hell is going on with UFOs?" Bush replied in the affirmative, as documented by CNN. But nothing has been forthcoming from the Bush Administration about UFOs, and with everything else that is going on, and given the fact that the government has nothing to be gained by release of information at present, nothing is likely to be forthcoming. Only if some very public, well-documented sighting occurs, compelling the news media to admit the presence of apparent alien craft or aliens, are we likely to hear any pronouncement from the government. In that event, as MUFON's consultant on theology writes, "MUFON could be a calm voice-well sort of calm-saying, 'We do not believe the UFOs plan to land and take over. We believe they just want us to admit they are real.' " This leads us into the religious dimensions of the phenomena - a subject too big to tackle in this article and maybe too big for this newsletter. But one of the cases I have started to investigate displays some aspects normally dealt with by religion. See "Telephone Conversation with S. ## Hard Data on the Close Encounter Phenomenon: The UFO Coalition's AMP Experiment

As readers of this newsletter are well aware, the close encounter phenomenon is known both for its mystery and for its ambiguity. Skeptics often point out that very little tangible evidence seems to exist to support the reality of this phenomenon. Encounter events generally occur subtly, at the boundary of our awareness, leaving few indications of their presence. Thus, experiencers and researchers alike are left with a shadowy phenomenon, difficult to study scientifically.

In the past, many readers of this newsletter may have heard discussions about various attempts to obtain some objective data on this mystery. In Minnesota MUFON, the Objective Verification Project is planned to monitor the residence of one or more volunteer experiencers. Other researchers, most notably David Jacobs, have attempted to install video cameras in the residences of volunteer abductees - with ambiguous but interesting

results. In addition, some physical effects have been documented accidentally, such as a case described in the MUFON Journal, about security camera footage appearing to show evidence of an abduction event.

To date, most monitoring attempts have generally met with mixed success. They offer tantalizing clues to suggest that physical effects do occur, but as yet little solid evidence. However, these results are just a beginning. Acquiring much more data in a very systematic manner might yield just such evidence.

In the last two years several organizations, including MUFON, have been participating in a low-key effort, called the Ambient Monitoring Project (AMP). This project is international in scope, being conducted jointly by MUFON, the J. Allen Hynek Center for UFO Studies (CUFOS), and the Fund for UFO Research. This project is a serious, comprehensive scientific study, to capture some concrete scientific data about this elusive phenomenon.

Earlier research suggests that the ambient energy fields which permeate one's home seem to be affected by close encounter events. Thus, the Ambient Monitoring Project (AMP) experiment employs a non-intrusive package of scientific instrumentation to continuously measure these fields. At regular intervals, the project team electronically collects and analyzes this data, to obtain a continuous profile of the fields within the experiencer's home, and any disturbances in them. In addition, the experiencer is invited to keep a daily journal, recording anomalous events, etc. At the close of the experiment the electronic data and the experiencer's journal are evaluated in a double-blind comparison to determine any correspondence that may exist between them - evidence of an encounter event.

Over the last year, Minnesota MUFON has been an active participant in this project. In a joint endeavor with Wisconsin MUFON, we have installed the AMP box in the home of one experiencer, resulting in an excellent set of data. In addition, Iowa MUFON has done several installations, and another Minnesota installation is planned for this winter or spring, by one of our out-state investigator(s). The project has gotten some excellent data to-date, and is now ready to proceed on a larger scale. We therefore invite anyone who feels that they may be an encounter experiencer to consider participating in this experiment. Participation is entirely voluntary at all times during the study, and can be ended at any time. All participants remain strictly confidential and privacy is respected at all times.

Those who have experienced this phenomenon are very aware of the mystery they present, both to the experiencer and to the researcher. If you think you

### **Alien Abduction Defense**

Ann Druffel holds a B.A. in Sociology and has done graduate work in screenplay and creative writing. She is a certified hypnotist.

Druffel's first interest in UFOs dates back to 1945 when she watched a high bright yellow object over Long Beach, California. It released small shiny objects which flew away from the main object. This sighting occurred at about the same time the first experimental atomic bomb was detonated in New Mexico.

She authored The Tujunga Canyon Contacts in 1980 and How to Defend Yourself Against Alien Abductions in 1998. A new book, Scientist vs the System: Dr. James E. McDonald's Fight for UFO Science is forthcoming.

The following is a summary of some of the main points of her presentation at the MUFON 2001 International UFO Symposium held in Irvine, California.

For a start, Ms Druffel takes issue with other abduction researchers who theorize that abductees are not able to defend themselves and should not resist these experiences because they might be for mankind's higher good. She regards abductions as traumatic events that go against the inalienable rights of human beings.

While admitting that there are abductions, such as the Barney and Betty Hill case, that seem to be linked to UFOs, Druffel maintains that the extraterrestrial nature of the phenomenon is unproven. Analyses of implants have not been proven to be the result of extraterrestrial technology and no verified hybrid baby has ever surfaced.

Because seventy people were able to defend themselves by using various physical and mental techniques, she has concluded that the "creatures" are not technologically advanced extraterrestrials nor an order responsible for the evolution of humankind. They must be something else.

Instinctive resistors seem to regard the visitors as intelligent and non-human beings which materialize only briefly in earth's space-time.

The majority of abductions take place in what seems to be an as-yet-unidentified altered state. Although abductions seem physically real, a growing number of abductees recognize that they are "out of body" and take place in what we can call "altered reality."

Druffel does not believe that a physical kidnapping actually takes place during an abduction. But, the abductees experience the event on a level of reality so vivid that they often assume they are fully awake. Most defense techniques break this altered state and the experiencer returns to full waking consciousness. The entities vanish and the scenario ends.

For centuries entities out of folklore have tampered with human beings in altered states. Lodovico Sunistrari of Padua, Italy (an acclaimed Catholic theologian) wrote about such creatures in 1701, calling them incubi. His book Demoniality has been made available by Dover Publications as recently as 1989.

Americans usually think of demons as devils or minions of Satan, but that is not what Sinistrari meant. They were creatures who abducted and sexually harassed people in Europe, but were not "devils." They were not part of normal physical existence, but lived a hidden existence on our earth plane. Although this creature is deceptive and can shape-shift when harassing humans in many unpleasant ways, they are not satanic.

The Celtic cultures called them faery folk and Muslims referred to them as jinns. They were called elementals in Buddhist countries, bunions in Malaysia, medved in Slovenia, and by other names in Australia and by Native Americans. Their shape-shifting ability might have allowed them to appear in forms acceptable to the cultures with which they interacted. In Ireland, sexual harassment seemed limited to switching babies during which time a changeling was left behind.

Jinns should not be confused with the concept of genies. The Koran describes them as a third order creation positioned between angels and mankind. They supposedly exist on a hidden plane and their bodies are described as being made of "smokeless fire," an Arabic term that has no English translation.

The American culture is a fairly new merging of older cultures. One might wonder if these abducting creatures were aware of our developing nation, trying to figure out what shape-shifting form would frighten us. America has preserved only remnants of our ancestors' ways. Just what shape-shifting form could frighten

Americans enough so that we would yield to attack? Did they begin presenting themselves as UFO occupants, a form which might frighten even a technologically advanced society? Did its penchant for sexual harassment take the form of hybridization techniques to make it acceptable to Americans, many of whom were a bit puritanical compared with other countries? Are, then, UFO alien abductors simply an ancient human problem shape-shifted into modern form?

The resistance techniques can be listed as mental struggle, righteous anger, protective rage, physical struggle, support from family members, appeal to spiritual personages, intuitive practices, metaphysical practices, and repellants.

Space limitations here do now allow for a detailed description of each. But, readers might be interested in a few highlights regarding the first four.

Mental Struggle is used prior to the appearance of the entities when paralysis is experienced. The victim instinctively focuses mental energy toward breaking the paralysis. In one case a girl succeeded in moving a finger and the paralysis broke for both her and her roommate. Righteous Anger is targeted directly at the entity, in essence demanding to be left alone.

Protective Rage is an escalation of Righteous Anger and has been used to protect family members from harassment by experiencing rage after the intruders have departed. She speculates that it places a psychic shield over the home so that the entities actually sense rejection from their higher plane. Perhaps they perceive

that these humans no longer fear them and that their power over humans has vanished.

Both Righteous Anger and Protective Rage must be devoid of hatred, which is rooted in fear and despair. The victim cannot hold any grudge against the entities. They should simply be regarded as a form of intelligence that has temporarily stepped beyond its limits.

It is Druffel's idea that experiencers need to develop a sense of their own inviolable rights. They also need to get rid of any notion that these creatures are either technologically superior or that they are somehow in charge of mankind.

In one case of Physical Struggle three entities materialized from a beam of light in a woman's bedroom. She jumped up and clutched one of the creatures by the neck, which snapped. Its head fell over on its back. The woman, a compassionate person, felt sorry she had injured the creature but communicated to the entities, "You're going to leave me alone." The

other two dragged the body back into the beam of light and vanished.

She was left alone for a few months. Then, Nordics appeared which were as sexually intrusive as the Greys. The shape-shifting abilities of the entities permit them to return in more pleasing forms which can worm their way into the confidence of humans. The danger is that many begin to think they are "chosen" and are given extraordinary information about the universe, dangers facing our earth, etc.

This has been a very brief summary of a few of the main points of Ann Druffel's presentation. Some of it was taken verbatim and some was paraphrased. Abductees, especially those who perceive that these intruders are not really a lovey-dovey bunch, should consider obtaining a copy of her book, How to Defend Yourself Against Alien Abductions.

### On: UFOs and the National Security State A letter by Joe Firmage (partial)

Having studied the UFO mystery for many years, I have many important questions. Most of them are focused on the long-term, transformational implications of the remarkable phenomena reported. Other questions relate to our understanding of 20th century history and the true present circumstance of human civilization. I share with you below some of these latter questions, with the hope that they may at least open your mind, and at most engage you in a shared quest to open what may be among the grandest future chapters in our ancient saga.

40 Questions for Scientists Who Care About Truth:

- 1. What are the implications of physicists' realization that "space-time" is not a void, but is rather an ocean-like medium of energy? (1)
- 2. Are scientists and journalists aware of new, broadlypublished, peer-reviewed theories of the nature of gravitation and inertia meeting every experimental test of general relativity, yet in principle allowing super-

luminal motion of gravity-propelled spacecraft without time dilation? (2)

- 3. If scientific papers speculating on time travel, worm holes, and 'many universes' are greeted by the press with respectful wonder and awe, why are scientific papers speculating on notions far less exotic propulsion systems not requiring that we shoot matter out of a nozzle greeted with skeptical disdain, especially when no empirical data exist to support the former, while much exists to support the latter?
- 4. Are scientists and journalists aware that much of the research staff on a pivotal government-funded study of UFO evidence the Condon Committee resigned or were fired when they challenged its director's intention to report a pre-ordained conclusion that all UFO sightings can be explained in mundane terms? (3)
- 5. Are scientists and journalists aware that the chief scientific consultant in the Air Force's Blue Book study of UFOs later characterized the project as a publicity maneuver to mollify the public, himself convinced by the evidence he saw that genuine, unexplained aerospatial phenomena are in our midst? (4)
- 6. Are you aware that reports of these two government funded, now-discredited studies the Condon Committee and Project Blue Book are the primary reasons why most scientists and journalists have dismissed UFO evidence as pseudoscience? (5)

- 37. When will we band together, demanding relief of security oaths for those with first-hand knowledge to testify in open hearings before the United States Congress and the people of Earth?
- 38. Do we or do we not have both the right and need to learn the truth of our Nature?

Many people - mainly those who've not studied the UFO mystery deeply - have asked me, "Joe, you're a smart guy. You can live a great life doing whatever you want. Why are you complicating it by raising such controversies?"

The social paradigm of the second millennium is hurtling us into what scientists now call the Sixth Great Extinction of life on Earth. (23) Forests are disappearing. Fisheries are becoming depleted. Oceans and lakes are being flooded with wastes. Aquifers are emptying.

### U.S. Has Heavily Researched Anti-Gravity, Book Says

LONDON (Reuters) - The U.S. military may have conducted serious research into anti-gravity based on Nazi studies, a top defense journalist suggests in a new book.

In "The Hunt for Zero Point," journalist Nick Cook says, based on a decade's research, he believes by the 1950s the U.S. was seriously working on anti-gravity "electrogravitics" technology, which would lift and propel vehicles without wings or thrust. "I feel intuitively that some vehicle has been developed, particularly given that there is this wealth of scientific data out there, and the Americans have never been slow to pick up on this sort of science," Cook, the aerospace consultant for Jane's Defense Weekly, told Reuters in an interview.

Cook uncovered reports and sightings of a Nazi research device that had been hidden in a remote part of Poland, where it had apparently been supplied with great quantities of electricity -- which an electrogravitic experiment would require. Curiously, barely a hint of such Nazi research appeared after the war, suggesting that whoever captured it -- probably the United States -- immediately stamped it ``secret," he said.

Cook noted that, as a respected expert, he is risking his reputation by writing seriously about a technology associated with UFOs, which most scientists dismiss as science fiction embraced by "hocus-pocus" believers.

The United States is known to have a huge budget for so called "black projects," because it spends more on defense than can be accounted for by adding up the value of public programs. Cook admitted he cannot produce a conclusive case. But that is the nature of black projects, in which even the workers usually have no idea what they are working on.

In 1947, amid the early craze of UFO reports, an air force general reported on the possibility of the United States building disc-shaped objects with extreme rates of climb and maneuverability but without noise or evident propulsion.

In the mid 1950s electrogravitics was the subject of a few press reports, including one that described work by most of the United States' major defense contractors, Cook reported.

And then it all went quiet -- just as stealth technology suddenly disappeared from view in the mid 1970s, only to re-emerge as operational aircraft in the late 1980s. Academic papers on the subject have mysteriously disappeared from libraries.

There is still no firm evidence that electrogravitics is more than science fiction. Civilian scientists and amateurs have experimented with it, and while some have reported success, no one seems to have reproduced their results to prove that it works.

## Field Investigator Update: December 2001 by Craig R. Lang MN MUFON FI Coordinator

In the last two month, the Minnesota MUFON field investigators have been steadily chipping away at a considerable backlog of cases. Many of these had resulted from an influx of reports coming from the National UFO reporting center (NUFORC). While in many of these cases, the witness was not interested in follow-up, several cases have hit "pay dirt". One case, investigated by Dean DeHarpPorte is described later in this article.

In addition to the NUFORC cases, the usual steady trickle of reports continues to reach Minnesota MUFON. Many of these are sent to us by e-mail. Bill McNeff, MN MUFON State Director describes one such sighting report which he received by e-mail in early December [CL Note: I am paraphrasing much of this report to maintain witness confidentiality].

This sighting took place in October, 1979. The witness was driving with his wife, from North Dakota to the Twin

Cities. They were headed East on Hwy 1 in Marshall County, Minnesota, near Thief River Falls. At one point, they observed an extremely bright light hovering low over the road, about a mile ahead of them. Thinking that it might be an accident or a road construction site, they assumed that they would see it more clearly as they approached. However as they drove toward the light, it remained quite a distance ahead of them.

Curious, they accelerated to a high speed attempting to catch up to the object. As the car began to close on it, they saw that the object was actually an extremely bright yellowish light, approximately 4 to 6 feet in diameter. It seemed to be hovering about 3 to 4 feet above the road. As they got to within approximately 100 yards of the light it suddenly shot directly toward them. The witness immediately put on the brakes and swerved to avoid a collision. Instantly the light was back to its original position, approximately a mile ahead.

Determined to see what the light was. The witnesses again gave chase, and once again, as they neared the object, it suddenly shot right at them, then abruptly resumed its position about a mile ahead. This second time they were able to observe that the bottom guarter portion of the light merged into a brighter-whiter light than the rest of the object, and was bright enough to make them squint. Determined to get a closer look, they gave chase for a third time, coming to within 30 to 50 feet of the object, with similar results. At that point they decided that enough was enough, and continued to follow the object at a safer distance for a few more minutes. The witness turned blinked his headlights, and flashed his brights at it, with no result. The object remained ahead of them - until suddenly, as they neared the town of Warren, MN it abruptly disappeared.

### CL Notes:

The description of this witness' sighting and that of the Val Johnson sighting of August 1979 are extremely similar. The two events are in a similar location and only a couple of months apart. Furthermore, as I discovered when investigating a sighting near Thief River Falls two years ago, there are numerous sighting cases (usually unreported) in that part of the state. Many consist of lights, hovering above the roadway, or just above the tree line. On at least one occasion, they have responded to a witness who flashed a light at it in an attempt at communication. It is not at all clear whether a high level of UFO activity in that area might be due to its remoteness, or whether the location is somehow important to the phenomenon. However, I suspect that we can look forward to many more reports from this part of the state in the future.

In addition, the event described in the report above occurred at the peak of an apparent wave of sightings in

the northern Twin Cities, which have been investigated by Minnesota MUFON. A check of the MN MUFON website, investigation reports section - for the time around 1979 - reveals some excellent cases. And these appear to be just the tip of the iceberg - many more sightings in the 1979 wave may well be out there, unreported.

### Stillwater, MN Triangle: April 2001 - Reported to the National UFO Reporting Center

In December, MN MUFON received a set of reports from the National UFO Reporting Center (NUFORC). While many of these could not be investigated for various reasons, one very spectacular event which occurred near Stillwater was investigated by Dean DeHarpPorte. The following description is summarized from Dean's field report, which was filed with both MUFON and NUFORC.

The witnesses, a married couple, called the UFO reporting center on the night of the sighting. Their report was relayed to Minnesota MUFON and Dean investigated the case. The witnesses were in their car, driving east on a rural highway near Stillwater, MN. Both observed apparently unexplained events at the same time. However, Dean's report notes that the sightings do not appear to be the same object. It is not clear if they are related, or are separate, simultaneous sightings.

### Witness 1 Object description:

Sitting on the passenger side of the car the witnesses were traveling in, witness 1 (the husband) noticed a lighted, triangular object to his right. The object appeared to be about 250 ft on a side. The witness reported the triangle was equilateral, though his (inexact) drawing showed it as isosceles. It was not possible to discern a texture to the surface of the object. A bright white light was at each apex of the triangle underneath the craft. The lights were not bright enough to illuminate the ground beneath the craft. There was also a red light in the center of the bottom of the triangle, less bright than the white lights, which blinked about once per second. There were no other lights on the object and no windows, orifices or other surface features were visible. The color of the object was black, but not the same color as the stealth aircraft. The object produced no sound, although the witness did not get out of the car. No other witnesses are known to have observed the object.

### Position, movement and duration:

The nearest surface of the object was approximately at a 60 degree angle from the ground when the craft was at its lowest altitude. When first seen the object was about 400 ft above ground but moved down "quite rapidly" to about 150 ft and hovered for several

seconds, then rose up to about 400 ft. There was no apparent lateral motion of the object. The car was moving about 45 mph but slowed to 10-15 mph immediately upon sighting of the object. The object was last seen to the rear of the car and disappeared when the car got too far away for the witness to see it. The duration of the sighting was about 1 minute. Witness 2, the driver, did not see the object because she was concentrating on driving.

### Sighting evaluation: CE1.

The object described is similar to the description of many triangular objects seen worldwide for the past 20 years. There is no conventional explanation apart from the possibility that the craft was an advanced military aircraft. However, current known technology is not consistent with a craft capable of hovering and moving rapidly vertically upward and downward without engine noise. Thus Dean's report concludes that this is an unexplained sighting.

### Witness 2 Object description.

Witness 2 observed two white lights, separated by the width of her thumb at arms length directly in front of her (toward the east). The lights were estimated to be 15 miles away (though she emphasized the uncertainty of this estimate), and were seen at the same time as witness 1 observed the triangular object to his right. Witness 1 also observed the two lights, but not closely, since he was occupied with observing the triangular object to his right. Witness 2 estimated the size of the lights to be about 1/8th the diameter of the moon and the brightness as brighter than a streetlight. Based on the inverse square law, this would mean the lights were more than 225 times the intrinsic brightness of a streetlight. As far as she could tell the object was not illuminating the ground. No other witnesses are known to have observed the lights.

### Position, movement, and duration.

Witness 2 estimated that the object was about 20 degrees above the horizon. This would make the altitude of the lights about 6 miles (~31,000 ft). The lights appeared motionless for about 1 minute, then moved downward rapidly until they disappeared below the treelined horizon about 3 seconds after they began their descent. The calculated speed of movement was 7200 mph. The lights disappeared at about the same time as witness 1 lost sight of the triangular object. The witnesses observed airplanes in the vicinity but witness 2 was adamant that the lights she saw were not conventional aircraft. The nearest airport is 9 miles to the southwest, 135 degrees to the right of (behind) the direction where the objects were sighted. There are no airports within at least 40 miles to the east of the sighting location.

### Additional lights:

During the time the 2 lights were hovering, they emitted 2 smaller lights which circled downward and back up and joined with the primary light a few seconds after they appeared. The witness had no estimate of the speed of these lights and said they were not quite as bright as the primary lights.

### Sighting Evaluation:

The description of the sighting, along with other factors such as time of day, sighting geometry and proximity to the airport, argue that it may well have a prosaic explanation, such as a conventional aircraft. However, it's association with a simultaneous unexplained sighting by someone in the same car makes this event far more interesting than it otherwise would be.

The husband's sighting description bears striking similarities to several spectacular triangle sightings which Minnesota MUFON has investigated over the years. Triangle sightings have been investigated by Bill McNeff, Casey Holt, Joel Henry and myself. The sighting event sequences are generally similar, with the object being seen by motorists, who observe it pass slowly overhead. Descriptions of the objects are also very similar: Slow moving dark triangles, on the order of 100 feet across, moving silently at about tree top level. They typically have white or colored lights at their vertices with a brighter white light at the center.

Also prominent in these cases are the apparent paradoxes which accompany the sighting. The most spectacular of these is the sighting location - generally near a well-traveled road, or populated area. Yet, there are seldom any other reports of sightings by independent witnesses, even though the object should have been widely observed. This paradox is very common. Often such triangle sighting cases are often accompanies by unreported paranormal events, which are generally not reported by the experiencer.

If you are interested, and feel that you have the necessary time, energy, and objectivity to be a UFO investigator, please contact Craig Lang. If you have not already done so, you also will need to join MUFON as a field investigator trainee and purchase the MUFON field investigators manual.

We need as many active investigators as possible in our effort to better understand the UFO phenomenon. For those who decide to pursue the study of this strange phenomenon, there will always be enough mystery to go around.
