#### Foo Fighters

"*Foo fighters*," a term coined by allied pilots during World War II for a strange aerial phenomenon seen in the skies over Germany, might have originated from the comic strip Smokey Stover. Smokey, a fire fighter, liked to say, "Where there's foo, there's fire." The word "*foo*" was a nonsensical term used in a variety of contexts. Some think it might have been an adaptation of the French word "*feu*," which means fire. In effect, "where there's fire there's fire."

Although the UFO subject seems to go far back in history, the modern era can be considered to have begun in the mid -1940's with sightings of glowing balls of light by pilots both over Europe and the Pacific. Another term used was "kraut fireballs." They were also seen by soldiers on the ground and sailors on ships.

Increased numbers were reported beginning in June of 1944 as the Allies began invading France and as Germany was launching V-1 buzz bombs against London.

These objects paced alongside Allied aircraft and sometimes "played tag" with them. They seemed to be under intelligent control, were never hostile, and it was assumed that they were some kind of secret German reconnaissance drone.

When Japanese and German pilots were later questioned it was discovered that they had also seen them.

Some reportedly followed ships at sea and were also observed by pilots during the Korean War in the early 1950's.

The New York Times published a report on Jan. 2, 1945, in which an Air Force lieutenant claimed that there were three kinds of foo fighters based on where they were in relation to an airplane.. There were red balls of light that stayed close to an airplane's wingtips, balls of fire that flew in front of them, or lights which appear far away, like a Christmas tree in the air, flickering on and off. He confirmed that foo fighters could match the maneuvers of airplanes.

A classified project had been established in England in 1943 directed by Lieutenant General Massey. A few reports of crashed Allied aircraft suggested that foo fighters might have caused the crashes by making the aircraft's engines cut out, but this was unlikely. Foo fighters merely tailed the planes and caused the pilots psychological distress. If fired upon, foo fighters left the scene.

Today, a foo fighter would be called a UFO. An early characterization, such as "spherical fire," might not sound familiar but we would know what it means. And early descriptions of maneuverability are similar to present-day accounts.

Following are a few representative examples of encounters with these strange objects.

Two pilots were over Germany photographing troop movements. After getting some pictures they were heading for a new location. The wing man broke radio silence and said that there were bogeys at 9 o'clock. Five objects that looked like silver footballs were below them which stayed with the two fighter planes. The pilot thought that they must be something belonging to the Germans. He watched to see what they would do, but they didn't do anything. As they turned away towards a new location the lead pilot thought that these things must not be of much value to the Germans.

In late September, 1944 a German test pilot was flying a new ME-262 jet when he saw two luminous points off to his right. He flew towards it and was soon close enough to see that it was a cylindrical object, 300 feet in length, and seemed to have something like antennae spaced from its front to about the middle. He estimated that he got to within 1500 feet (about a quarter mile) of the object and thought it ended up moving at a speed of 1200 mph.

On a bombing mission over Europe B-17's were under attack from German fighter planes. After one group had completed its bombing run, a crewman watched another group approach the target. To his amazement, the German fighters stopped their attacks and were nowhere to be seen. Instead, a cluster of silver objects was descending into the group of bombers. As the cluster flew through the bombers there was no effect on the planes' wings or engines. One crew member thought that an object had hit the tail of their B-17. Later examination showed no mark had been made on the tail.

On the morning of August 12, 1942, a Marine Sgt. was on the island of Tulagi in the Solomons. An air raid warning was sounded and he went into his foxhole and laid on his back. A roar that seemed to "echo in the heavens," unlike the drone of Japanese aircraft, was heard and then he saw a formation of silver objects overhead that were higher than the

clouds. He estimated that there were over 150 objects moving in straight lines of about a dozen, one behind the other. There were no wings or tails and they wobbled slightly, shimmering in the sun. He said that it was the most awe-inspiring and yet frightening spectacle he had ever seen. Others on the island also witnessed the event.

An experimental rocket was launched at the Kummersdorf Test Center in February, 1944 with Goebbels, Himmler, and Kammler in attendance. The launch was filmed and days later the film was shown. A spherical object which circled and followed the rocket was clearly visible.

It seems that these objects were also interested in studying earth warfare in general. During the Normandy invasion an object was seen from the deck of an anchored ship at Omaha Beach. A gunner was watching the sky as a dark cigar-shaped object moved across the horizon a few miles away. The object, moving fast enough that it could not have been a blimp, traveled a circular course about fifteen feet above the water and had no wings.

A columnist for the Los Angeles Herald Examiner sent a dispatch saying that a party of four had watched a red fireball move to a point directly over the American-German front lines during the Battle of Normandy. It then remained motionless for fifteen minutes before moving on.

We might wonder how many reports from that era might still be locked away somewhere. In 1992, forty years after the fact, Barry Greenwood, from CAUS, ferreted out fifteen mission reports from the 415th Night Fighter Squadron which were at the National Archives in Suitland, Maryland. One of these involved an incident in which a night fighter encountered two sets of lights. He turned into them and watched one set of lights blink out. The lights in the second set quickly shot up 2000 - 3000 feet. The pilot turned away, looked back, and saw that the lights had returned to their original position.

Putting "foo fighters" into Google will bring up about two dozen informative web sites, some of which were used to gain information for this short article. There is also a musical group with the name Foo Fighters, which slightly complicates a web search.

They receive varying amounts of coverage in some UFO books. *Strange Skies* (2003) by Jerome Clark is about pilot encounters and there are ten pages on foo fighters in Chapter 1.

Clark and Lou Farish wrote a five-page article, "The Mysterious Foo Fighters of WWII" in the magazine *UFO Annual* 1977. If one can still get a used copy, the pages are sure to be brittle and turning brown around the edges. Luckily, this article in its entirety can be found on a website called UFO Area. Type [ufoarea.com](http://ufoarea.com) into Google to bring up the home page. On the left side click on Sightings. In the resulting list it will be found ten up from the bottom. Or, type "foo fighters clark" into the small search rectangle and it will be at the top of the list.

**Crop Circle Formation in  
Cottage Grove, MN, 25 July, 2004

At 6 PM on the evening of July 25, 2004, a farmer noticed 5 crop circles in his oat field. The farmer is prominent in the community and appeared to be a reasonable and logical person. Since there was no disturbance of the oat stalks near the circles, the farmer feels there is no way that hoaxers could have gotten into the field to make the circles, which are about 75ft from the road at the edge of the field. Between the road and the field is a 6ft high padlocked chain link fence about 1 mile long. The only access to the area where the circles were found from other directions would have required disturbance of the crop for several hundred feet. Furthermore, the farmer said that if any mechanical device had been used to down the crop it would have separated the dry and brittle oats from their stalks, which was not the case.

The farm is near Cottage Grove, MN, which is some 30 miles southeast of St. Paul. The people (not the owning farmer) in the nearest residence, about a half mile from the circles, could not see the circles from their house and reported no unusual lights, sounds, or other activity on the night of the 24th or during the day on the 25th.

The field was investigated by certified Minnesota MUFON investigators on August 8. The results of the investigation and sampling procedures are described in the sampling report below. By August 8, the oat crop had been harvested, so it was difficult to determine the exact outline of the circles and the lay of the crop had been disrupted by harvesting equipment.

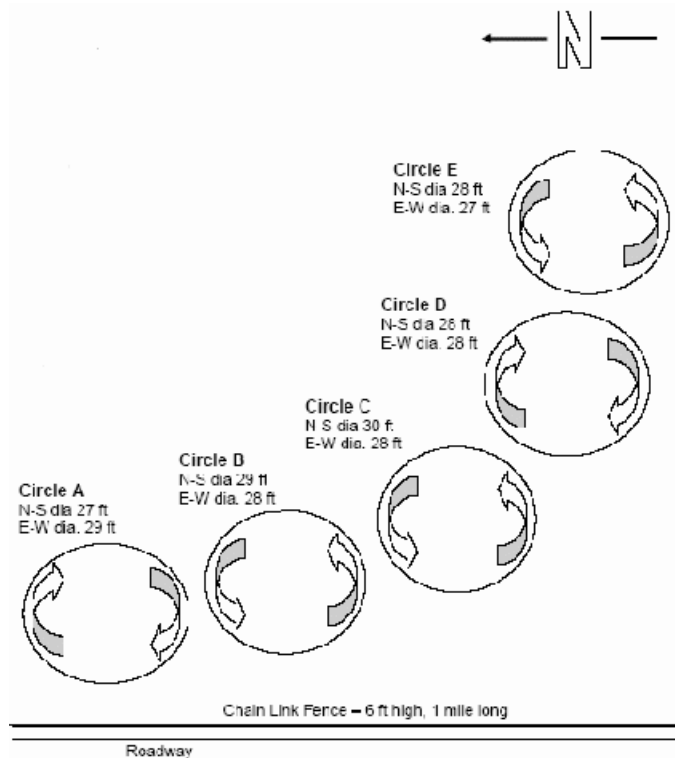
Nevertheless, it was possible to get reasonably accurate measurements of one of the circles (circle D in the sampling report) and to carry out soil and magnetic sampling procedures. Scientists associated with BLT Research plan to study the fungi on the roots of the plants to determine whether the soil was abnormally heated. Preliminary results of the magnetic sampling indicate that there were tiny iron particles in and around the circles. The density of these particles apparently was greater just outside the circles than within them. This preliminary finding is consistent with the plasma vortex theory favored by some BLT scientists.

**Magnetic Drag**

For the magnetic drag samples, a flat, 3.5 in. dia., 1/2in. thick magnet mounted on the end of a 4ft. wooden handle at a 45 degree angle to the plane of the magnet was used. The bags were dragged once



1-2 ft inside and 1-2 ft outside each of the 5 circles. The outside drags were confined largely to the North and South sides of the circles to avoid confusing the sampling procedure because the circles overlapped or nearly overlapped on their East and West sides. The edges of the circles were ill defined because most of the oats had been harvested. However, Circle D, the circle for which soil samples were taken, had a well defined edge. A control drag was done starting on the north edge of Circle D, extending radially outward 100 ft.



When each drag was completed, the bag was carefully turned outside-in and sealed while still in contact with the magnet to preserve the magnetic particles collected.

There was a noticeable difference between the amount of magnetic material gathered inside the circles compared to the outside. Approximately 2 to 3 times more material was collected outside than inside. The 100ft control drag gathered approximately twice as much magnetic material during the 1st 50ft of the drag than the second 50ft. All of the magnetic material from this drag was placed in 1 zip lock bag.

### Anomalies

No magnetic anomalies of any kind were noted by compass observations. A farming couple located ½ mile from the formation noted nothing unusual. Their animals displayed no unusual behavior.



### Crop Samples

A sample of the downed crop (oats) was taken from a point about 1ft east of the center of Circle D, the circle from which soil samples were taken.

Although most crop in the circles was downed, a few crop stalks remained upright in a few of the circles. A thorough count of these standing stalks was not made, but a sample was taken approximately 2in. North of the center of Circle D.

A control sample of the remaining crop was taken about 100ft east of the formation near the field edge. The crop from which this sample was taken was cut but left behind when harvesting down the east edge of the field.

### Weed Sample

There were very few weeds in the field. Most were very immature and unbent and probably grew there after the formation was laid. A weed sample (approximately 2ft. long, including the root, and 1/4in. dia. was taken from the northeast quadrant of circle E, approximately 1.5ft. inside the circle

edge. It was laid down in the same way and direction as the oat crop around it but was not damaged at the bend over point. Rather, it was bent cleanly where it emerged from the ground. It had begun to grow on the leafy end, curving up towards the sun. There was no damage of any kind visible at the bend point or the root or above the bend. Another weed of equal size and diameter, and type was found on the east side of the field approximately 150ft. from Circle E. It was tested for breakability by pushing it over to it's side. It snapped clean at the bend point (too stiff to bend without damage) even before reaching the ground. This weed is not included in the normal sampling procedure.

Samples were sent to BLT Research for analysis. It may be some time before we get the results.

## **Litchfield, Minnesota Crop Circle**

Date Found: 7/11/04

Date Occurred: 7/9-10/04 (?)

Crop: Barley

Description: BLT fieldworkers found, again, an extensive area of randomly-downed crop in numerous patches alongside the road. One of the field-team, a meteorologist, reported that there had been heavy thunderstorms in the area during the time event is thought to have occurred and it was his basic impression that this downed crop was most likely caused by rain & wind damage. However, he reports that the plants were bent at the base rather than broken, and that he did observe what looked like atypical node elongation in the downed crop as opposed to the controls. Crop was laid at various angles throughout, with abrupt boundaries between standing and downed crop. No EM anomalies reported by owner.

## **Retracing the Interrupted Journey**

About forty years ago now, I first read the book, "[The Interrupted Journey](http://www.amazon.com/exec/obidos/tg/detail/-/1567311342/102-0222728-7510540?v=glance)" by John C. Fuller (<http://www.amazon.com/exec/obidos/tg/detail/-/1567311342/102-0222728-7510540?v=glance>). The book is the account of one of the first well-documented UFO abductions. It is the story of the close encounter of the fourth kind (CE4) experienced by Barney and Betty Hill, in 1961, and of its aftermath. The book was a Christmas gift from my grandmother and truly changed my life. It is at least partially the responsible for launching me on a lifelong quest to understand the UFO and close-encounter phenomenon. A never-ending quest which occupies many of my waking hours and has fascinated me for years...

I first met Betty, myself, at the 2002 MUFON conference. She is a delightful lady with a somewhat mischievous sense of humor. At the conference, she gave a superb lecture on the encounter, how it changed her life, and how it altered the lives of all of us - especially those she knew.

At the conference, she later told me the location of the site where the abduction occurred. At the time of the encounter, it was pretty much out in the boonies in New Hampshire. However, the location turns out to be relatively close to where the National Guild of Hypnotists annual convention was held. I was scheduled to give a talk at the 2003 NGH convention. So not too long before the convention, I called Betty and asked her for some additional directions.

When I reached Betty by telephone, I was again struck by her pleasant, slightly impish sense of humor. I hadn't realized that she had written a book on UFO's herself. I looked it up and perused it, and I now understand why some have called her the grandmother of UFOlogy. She definitely has her own views on the topic, and takes these very seriously. Yet like everything else, she seems to approach it with a sense of both determination and fun.

She gave me more detailed directions to the site, and some very detailed descriptions of landmarks. I thanked her and we hung up our respective phones. A few weeks passed, which included my doing a presentation at the NGH convention - which was on doing regression work with close encounter

experiencers. My wife Gwyn and I both attended this conference, and enjoyed a whole weekend of fascinating talks on various topics in hypnosis and hypnotherapy. My talk also went well, with some excellent feedback on techniques for working with close encounter experiencers. Then, once the convention was over, it was time for us to go find the Hill abduction site.

The weather that day couldn't have been worse for doing UFO field work. It was pouring when we started out. But we figured that we might never get this opportunity again, so we decided that rain or shine, we would go find the Hill CE4 site. So that day, we drove north from the convention site in Nashua, NH, to where we thought the location was.

The rain let up as we approached the location on Hwy 175, where the Hills took their hypnotic detour off of U.S. Route 3. It stopped as we pulled up to the site. We quickly found landmarks that matched Betty's description, and walked into the woods on a soggy, overgrown 4WD trail. The trail ended in a large field, only about 100 yards from the road. It was a location that seemed to me to be ideal for a UFO set-down. But what seemed most truly synchronistic (at least to me) was that at that moment, the clouds parted, and we were treated to the most beautiful sunburst, I think I have ever seen.

The opening itself was a flat field about 100 yards wide and 200 yards long, tucked into in the thick New Hampshire woods. And if I were the captain of an alien spacecraft, looking for a place to carry out covert work on Earth, I would have certainly picked this spot. It was both beautiful and functional. It matched perfectly my mind's image of the perfect location for a UFO Encounter in the dark of night.

At the far end of the field, was an old cottage. We wondered if it had been there forty years before, and if so, if the residents had been home. If so, then perhaps they had been treated to the sight of a lifetime, as a flying saucer from another world settled into their back yard.

We took a rather detailed photo survey of the field, and took a couple of glory shots, with Gwyn and I posing for the self-timed camera on a tripod. Then we left - mission accomplished.

The next year, at the MUFON conference in June 2004, Gwyn and I got to talking with Kathleen Marden, Betty Hill's niece, who was very familiar

with the location. I described to her what we had seen in the field, and got some very puzzled looks. When I mentioned the old cottage, I got a response like "hmmm, - I don't remember anything like that..." At that point, it was clear to Gwyn and I that we still had some more hunting to do.

Kathleen gave us details of where the sighting and abduction had (really) taken place. They seemed compatible with what Betty had said, but had some details we hadn't known before. And so once again, after this year's NGH conference, we began the hunt for the Hill CE4 site.

This time we found it easily. It turned out to be on a side road, less than a block off of Hwy 175, and was easy to find. Unfortunately, there was a new house built on the site (it had been built only recently - we missed it by a year). Since this was now someone's front yard, and we hadn't introduced ourselves to the property owners, it wasn't appropriate for us to do much of a site survey. And since we were en route from one location to another on our vacation, we didn't have much time to go knock on their door, etc. So a quick look at the front, a couple of quick pictures of the neighborhood, and we were off.

As we drove away, I smiled and quipped to Gwyn, "I liked the other site better..."

The next day, we also located the site where Barney initially got out of the car, and watched the object descend. For those who have read "The Interrupted Journey" they will recognize that this was the location where the aliens took him over. It was at that point when he was mentally captured by the eyes (so commonly described in CE4 narratives).

The site is now a business, which it turns out, had also been there in 1961, when the CE4 occurred. So a few days later, we were actually able to talk with the manager there. She was good friends with the owner, but was unfamiliar with the Hill case, herself (I'm not sure whether or not she had even been born yet, at the time of the Hill encounter). However, she did call the owner, who indicated that he was familiar with the case. She give me his phone number and said it was OK to call him later (which I plan to do).

And so in a way, we were able to re-experience a sense of the events which were described in the book that so captivated me forty years ago. In a sense we seemed to come full circle, as we followed



in the footsteps of the Hills - Retracing the Interrupted Journey.

## **Greys Before Betty and Barney Hill**

As I remember, the first-ever sighting of a "grey" alien - about 1.2 m tall with a large head and large eyes - was on 14 August 1947, when a geologist walking in mountains at Villa Santina, near Bolzano, Italy, came across one and his landed UFO. **Aztec to premiere UFO documentary**

AZTEC — As research continues into the infamous, yet unproven Aztec UFO crash of 1948, a Canadian film company has released the first full-length documentary about the event.

The Aztec Public Library, sponsor of the annual Aztec UFO Symposium, recently received a copy and plans to premiere it at 7 p.m. Thursday at Aztec City Hall.

"This video elevates the story to a national level of discussion," said Leanne Hathcock, librarian and founder of the symposium.

It was her research, along with the help of North Carolina resident Scott Ramsey, that led to a renaissance of interest in the purported crash in March 1948 in Hart Canyon north of Aztec.

Ramsey has completed countless hours of research and successfully declassified material pertinent to the incident.

"We're working very hard in trying to identify two law enforcement officers at the scene, and at the same time trying to be respectful to the families," Ramsey said.

New Mexico and UFOs have become synonymous since the surging popularity of the Roswell crash in

July 1947, but Aztec is coming into its own, according to Hathcock and Ramsey.

"I think the documentary puts Aztec in a positive light," Ramsey said.

City Commissioner Jim Rubow agreed, saying the film was well done.

"I thought it was fairly open minded," he said. "They did a good job of integrating local history giving (the story) a better understanding of anything I've seen to date."

The film begins with a view of San Juan County's high desert landscape and film producer Paul Kimball telling the story of Aztec.

It was a quiet evening north of the county seat, when an oil well fire broke out on a mesa above Hart Canyon. The fire led people to something much more interesting — a crashed UFO containing charred bodies, Kimball tells in the story Ramsey continually attempts to verify.

It has been the researchers desire to locate all living eyewitnesses, but Ramsey said he has missed many due to their untimely deaths.

He has spoken to a number of people in Cuba about a former resident who may have been at the crash site. He learned from them that in March 1948, the Air Force paid that small town a visit.

Dr. Lincoln La Paz and a high-ranking military official came to Cuba to investigate strange sightings, Ramsey said.

"At the end of a few days of investigation, La Paz wrote it off as meteor showers, including rock samples that he tried to pawn off on locals as meteorites," Ramsey said.

The researcher, who is most prominent in the documentary, believes this incident might be tied to Aztec.

This information will not be found on the video because it was only recently discovered.

What viewers will see is a potpourri of ufologists including Stanton Friedman and Nick Redfern and skeptics like Karl Pflock.



Ramsey, however, is the center of attention, having done most of the updated research on Aztec.

"He was going on the paper trail and the evidence," Hathcock said, adding Kimball used "talking heads" to tell the story to provide a basis for credibility.

"I feel like it was well done," she said.

"(Kimball) is a purist when it comes to doing a documentary," Ramsey said. "It has to be based on as much fact as possible."

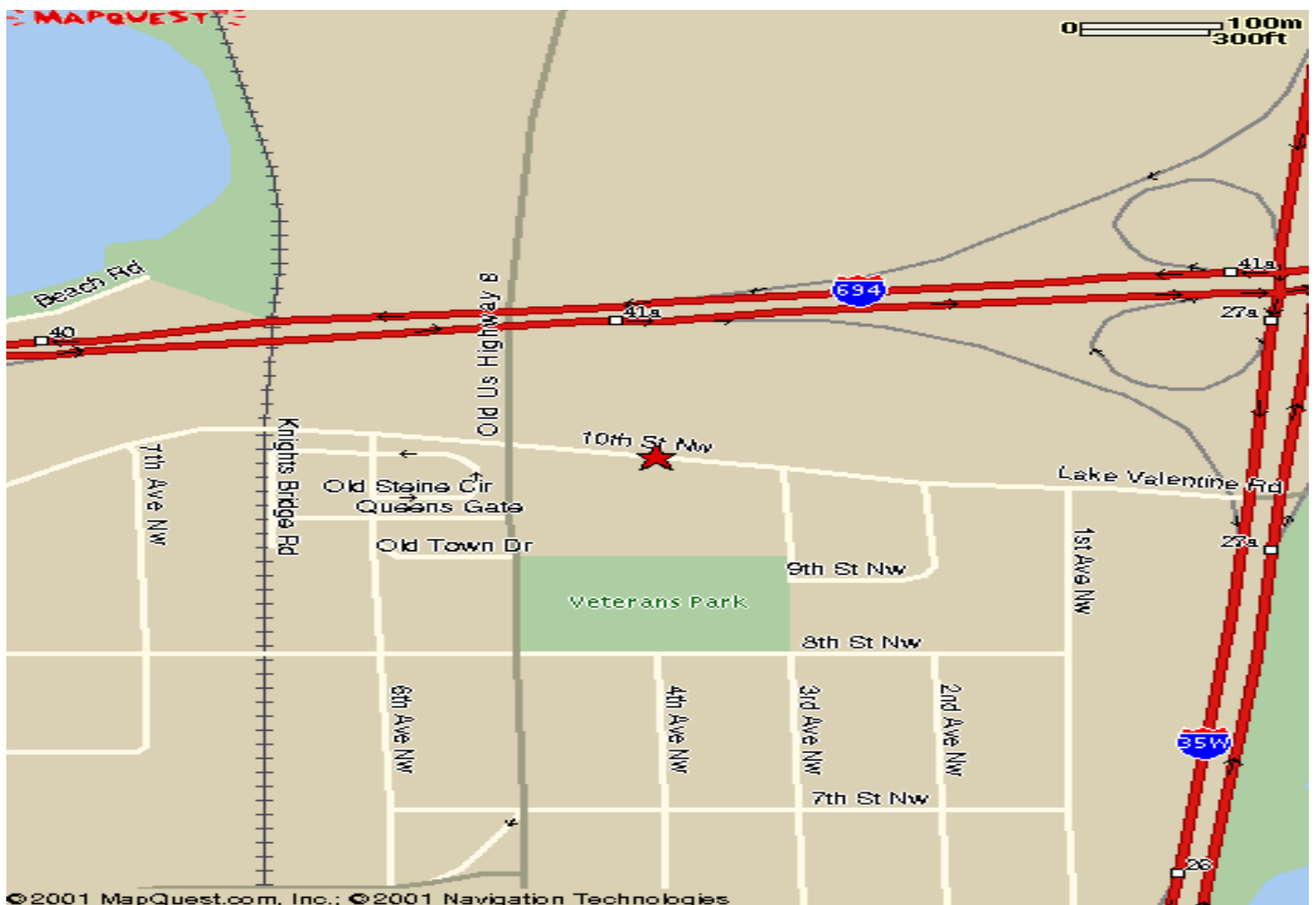
