It's MUFON Symposium Time **By Dick Moss, MN MUFON State Dir.**

Each year, in July, MUFON holds its Annual Symposium and this year it will again be in Denver on July 14 - 16 at the Marriott Denver Tech Center Hotel. This gathering of MUFON members, presenters and the public has grown into a "must-attend" event for many past attendees.

Each speaker is a specialist in some aspect of the phenomenon.

In July, 2005, Scott Ramsey presented material supporting the crash of a UFO near Aztec NM in 1948. He has interviewed 60 first and second hand witnesses now living in 29 states. This event was the subject of a book, *Behind the Flying Saucers* by Frank Scully which, at age 13, was the second UFO book I ever read. The craft was about 100 ft in diameter and contained 16 humanoid bodies varying in height between 36 - 42 inches and wore tight-fitting once-piece flight suits. The existence of 2600 documents supports the notion that something classified took in March, 1948.

Phyllis Budinger holds an MS degree in chemistry and has established a small lab in which to study physical traces associated with UFOs. These included samples from abductions, cattle mutilations, crop circles, UFO deposits, and angel hair. She presented the results of her examinations of clothing worn by two abductees along with any particulates that may have been on the cloth.

Dr. Roger Leir has overseen the removal of several strange objects called implants from patients who were known to have had them inserted into their bodies. Surgical specimens include metallic objects covered with some kind of biological coating. One of these was so magnetic that it magnetized a surgical instrument designed to be impervious to external magnetism for safety reasons. The iron was shown to be amorphous, something that is impossible within our present capabilities. Isotope ratios did not coincide with these same elements on earth. Surface examination indicated both manufacturing and purposeful structuring. One object was found to be emitting two radio frequencies: 92.7 and 102.9, both in the FM range.

Esen Sekerkarar from Turkey, where sightings and abductions also occur just like throughout the rest of the world, described first-hand pilot accounts, police footage, and involvement of the professional community. In one instance, a huge egg-shaped object flew in front of a Turkish Airlines plane for about 15 minutes and then sped away at a fantastic speed.

Since 1947 the UFO phenomenon has been disparaged by the mainstream media and the world of academia. Richard Dolan asked,

"What does it say about one's academic institutions when a reality of major importance is denied for generations on end and what does it say about news media when coverage of the UFO is restricted to shallow jokes and 'what if they are out there' questions?"

Physicist Stanton Friedman, the Dean of UFO research, made a detailed presentation on Government UFO Lies. These included lies about the Roswell crash along with lies from Project Blue Book, the Air Force, the Navy, and the CIA.

PhD physicist, Claude Swanson was educated as a physicist at MIT and Princeton. For the last 15 years, interspersed with his conventional career in applied physics, he has pursued investigations into "unconventional physics" which are real phenomena that seem to violate our present science. His topic was The Rediscovery of Magic, something that seems especially important in any study of the UFO.

PhD psychologist, Dr. Leo Sprinkle, presented The ET Presence: Cons and Pros. The "Cons" are the "confidence" people who try to "con" us into denying the ET presence and the "Pros" as the professionals who profess the reality of ETs. He asked the provocative question, "Are we humans former ETs whose souls have accepted the challenge, or chore, of living in a human body on Planet Earth? During his presentation he compared some models of human consciousness. Dr. Sprinkle performed regressions on abductees almost from the beginning of the abduction phenomenon.

Elaine Douglass presented sighting reports, witness testimony, and a video which combined to suggest that alien spacecraft have the capability to become invisible, which is something that many witnesses have claimed over the years. In 1989 a UFO was filmed which disappeared and reappeared and this video was shown at the Symposium. Generations of researchers have always assumed that such behavior really amounted to the craft flying away so fast that it could not be seen by the eye. Is this invisibility caused by the bending of light in an extremely strong and controlled gravitational field?

Physicist Alan Holt has researched advanced/breakthrough shielding materials and techniques for aircraft and spacecraft. In his presentation he discussed physics and technology displayed by UFOs that are so advanced that we will

need to broaden our understanding of physics, matter, and consciousness in order to comprehend UFO technology.

Paola Harris told of how the Italian media covers UFO events. She also discussed the importance of networking information worldwide to prepare humanity for eventual disclosure.

Joan Woodward, a former volunteer for NICAP, contributed a paper concerning Animal Reactions to UFOs with fear being to most common reaction and UFOs tending to linger. She has contributed over 100 summaries involving animal reactions to UFOs to Francis Ridge's NICAP website.

Those were the speakers and topics in 2005. If you weren't there you missed some important information. What about this year's lineup?

It will be another great gathering of expert researchers and informed, but still curious, people eager to be updated on aspects of the UFO phenomenon. And first-time attendees will be glad they were there.

'UFO Hacker' Tells What He Found By Nigel Watson, Jun, 21, 2006

The search for proof of the existence of UFOs landed Gary McKinnon in a world of trouble.

After allegedly hacking into NASA websites -- where he says he found images of what looked like extraterrestrial spaceships -- the 40-year-old Briton faces extradition to the United States from his North London home. If convicted, McKinnon could receive a 70-year prison term and up to \$2 million in fines.

Final paperwork in the case is due this week, after which the British home secretary will rule on the extradition request.

McKinnon, whose extensive search through U.S. computer networks was allegedly conducted between February 2001 and March 2002, picked a particularly poor time to expose U.S. national

security failings in light of the terror attacks of Sept. 11, 2001.

McKinnon tells what he found and discusses the motivation behind his online adventures in this exclusive phone interview with Wired News.

Wired News: What was your motive or inspiration for carrying out your computer hacking? Was it the War Games movie?

Gary McKinnon: This is a bit of a red herring. I have seen it but I wasn't inspired by it. My main inspiration was The Hacker's Handbook by Hugo Cornwall. The first edition that I read was too full of information.... It had to be banned, and it was reissued without the sensitive stuff in it.

WN: Without this book would you have been able to do it?

McKinnon: I would have done it anyway because I used the internet to get useful information. The book just kick-started me. Hacking for me was just a means to an end.

WN: In what way?

McKinnon: I knew that governments suppressed antigravity, UFO-related technologies, free energy or what they call zero-point energy. This should not be kept hidden from the public when pensioners can't pay their fuel bills.

WN: Did you find anything in your search for evidence of UFOs?

McKinnon: Certainly did. There is The Disclosure Project. This is a book with 400 testimonials from everyone from air traffic controllers to those responsible for launching nuclear missiles. Very credible witnesses. They talk about reverse-(engineered) technology taken from captured or destroyed alien craft.

WN: Like the Roswell incident of 1947?

McKinnon: I assume that was the first and assume there have been others. These relied-upon people have given solid evidence.

WN: What sort of evidence?

McKinnon: A NASA photographic expert said that there was a Building 8 at Johnson Space Center

where they regularly airbrushed out images of UFOs from the high-resolution satellite imaging. I logged on to NASA and was able to access this department. They had huge, high-resolution images stored in their picture files. They had filtered and unfiltered, or processed and unprocessed, files.

My dialup 56K connection was very slow trying to download one of these picture files. As this was happening, I had remote control of their desktop, and by adjusting it to 4-bit color and low screen resolution, I was able to briefly see one of these pictures. It was a silvery, cigar-shaped object with geodesic spheres on either side. There were no visible seams or riveting. There was no reference to the size of the object and the picture was taken presumably by a satellite looking down on it. The object didn't look manmade or anything like what we have created. Because I was using a Java application, I could only get a screenshot of the picture -- it did not go into my temporary internet files. At my crowning moment, someone at NASA discovered what I was doing and I was disconnected.

I also got access to Excel spreadsheets. One was titled "Non-Terrestrial Officers." It contained names and ranks of U.S. Air Force personnel who are not registered anywhere else. It also contained information about ship-to-ship transfers, but I've never seen the names of these ships noted anywhere else.

WN: Could this have been some sort of military strategy game or outline of hypothetical situations?

McKinnon: The military want to have military dominance of space. What I found could be a game -- it's hard to know for certain.

WN: Some say that you have given the UFO motivation for your hacking as a distraction from more nefarious activities.

McKinnon: I was looking before and after 9/11. If I had wanted to distract anyone, I would not have chosen ufology, as this opens me up to ridicule.

WN: Tell me about your experiences with law enforcement and the procedures you have gone through.

McKinnon: I was arrested by the British National Hi Tech Crime Unit in March 2002. They held me in custody for about six or seven hours. My own

computer and ones I was fixing for other people were taken away. The other machines were eventually returned, but they kept my hard drive that was sent to the U.S. It was November 2002 when the U.S. Department of Justice started their efforts to extradite me.

WN: The British Crown Prosecution Service dropped charges against you because your activities did not involve British computers.

McKinnon: I was to be officially charged in 2003 but a warrant wasn't given until 2004.... In June or July 2005, I was scooped from the street by Scotland Yard. I was kept at Belgravia Police Station overnight. I just wore what I had on when I was out; I didn't get a chance to wear a suit in court. I was given police bail.

WN: When will they make a decision about extradition?

McKinnon: It's down to the Home Secretary, John Reid. The deadline for representations is 21 June 2006. Even after that date, it could be as much as 11 months for him to decide on my fate.

WN: How have you been coping?

McKinnon: God, it's very worrying and stressful. It's been worse because I'm unemployed. I worked on and off in IT, contracting and stuff, before this, but no one will touch me with a large barge pole now. Wired News © Copyright 2006, Lycos, Inc.

UFO SECRECY & POLICY QUESTIONS

A friend asked me, "Why does everything concerned with UFO's remain classified?" Actually, thousands of pages of formerly classified documents involving the UFO subject have been released under the FOIA. These documents show a strong interest in UFOs by the agencies involved. Today, I believe a better question would be, "Why is so much concerned with UFO's still classified?" I think the answer is a combination of these things:

1. The initial classification was to keep the technology from the communists (and everybody else but the U.S.);

2. A concern about admitting that we were being visited by aliens, and couldn't prevent them from doing anything they please to us;

3. A desire to hide the nasty things the government did to keep it all secret (which included threatening little girls and their parents, and maybe a few "necessary" eliminations);

4. A desire not to upset the oil profits applecart (if you can get energy out of empty space - zero point energy - who needs oil?)

5. The old, corrupting desire for power.

There is evidence that the U.S. government has had experience with UFO crashes prior to 1947. There are reports of more than one crash in the 1941 time frame. Leaked documents, allegedly highly classified, speak of atomic knowledge gleaned from these crashes. (See: www.majesticdocuments.com.) So when the Roswell crash(es) (there may have been three) took place, the government was primed and ready to recover the wreckage. Technology that was literally out of this world was there for the taking. The biggest problem was in understanding it. Time would be required to analyze and understand this technology. So the secrecy was needed.

Stories such as those told by Bob Lazar suggest that not all of the technology is understood even today, and that even when the technology is understood, how to duplicate certain materials and processes is not. Until everyone in the world understands this technology and can duplicate it, it is in the government's interest to keep it secret. But those of us who study the UFO situation would like to see an admission by the government that we are being visited by the makers of this technology. The 64 million dollar question is, if the government made such an admission, would that imperil the desired secrecy regarding some to the technology? This situation can be compared to the secrecy involved in atomic weapons. Until we dropped the first atomic bomb on Hiroshima, the U.S. government kept its atomic bomb project secret. But the leader of at least one of our chief enemies at the time, Adolf Hitler, was aware of the possibility of making a nuclear bomb and had his scientists hard at work on it. The sabotage of a heavy water plant in Norway checkmated Hitler's efforts. However, the U.S. government realized that they did not want any other government to be aware of the possibilities of atomic weapons, and that dictated

keeping the project a secret from everybody, including the American people. Similar reasoning may apply to UFOs.

What would be the results if the government admitted UFO reality? First, all those who have been ridiculed for reporting UFOs would gain a measure of respect. Second, those who claim that they have been abducted by UFOs would, I hope, gain some understanding and sympathy. At least each case would be looked at on its merits. But the government could be sued by those who believe they have suffered from effects of UFO encounters. Third, some countries might try to shoot down some UFOs to gain the secrets for themselves. This would be very ill advised. There are stories that in the 1947 time frame, the U.S. tried to do just that and lost a number of planes. There is also a story that the USSR tried this and lost an entire base! Let us also remember that in several cases, the U.S.'s Minuteman missiles became inoperative after visits by UFOs. This seems like a clear message from the operators of these craft that our technology is no match for theirs! I could believe that, since most estimates are that any aliens that land on earth will be at least a couple of hundred years ahead of us technologically, and likely thousands of years advanced!

This leads us to the subject of U.S. policy regarding aliens. One of the points made by former Defense Minister of Canada Paul Hellyer in his important speech at the University of Toronto, in September of 2005, was: "In his book Colonel Corso makes it clear that the Reagan Administration's Strategic Defense Initiative...was primarily designed for use against the alien intruders. Its contemporary successor, the anti-missile missile defense system is also being designed with that as one of the principal objectives. The policy question is this: Is it wise to be spending so much time and money building capability designed to rid the skies of alien invaders? And what are the possible consequences in the event we should shoot down a few of them? The time has come to lift the veil of secrecy and let the truth emerge so there can be a real and informed debate about one of the most important issues facing our planet."

Here we have heard the most important argument for ending the secrecy. It is also an argument that we in MUFON and in the entire UFO research community need to redouble our efforts to bring the facts about the alien visitors into the full light of day.

July/August, 2006: **Toward a Synthesis of Models**

It is a mystery: Visitation in the night by a phenomenon of which we understand little. What are the Visitors really doing here? What would an Extraterrestrial strategy be towards contact? We have thus far studied models⁽ⁱ⁾ of the UFO/CE4 phenomenon such as the Deardorff⁽ⁱⁱ⁾ model, the Genetic/Hybrid model and the Zoo/National-Park model. How can we combine them based upon what we have so far discerned about the phenomenon? We can also ask whether, to the Visitors, it might somehow be vital to "improve" humanity. Thus, in this article, we begin to unite these various models to build an overall hypothesis of the Visitor presence. In future articles, we can then ask how we can prove or disprove such a hypothesis. But today, let's look at theories and put them together - moving toward a synthesis of models...

Human Awakening

An eastern parable asks, "How do you eat an elephant? - one bite at a time." Similarly, we might ask, how do you change the human race? - one person at a time. Thus, in addition to the apparent genetic manipulation described in the previous article, we can ask whether we might also view the changes fostered in each experiencer as part of an overall drive to change humanity. As described by Dr. James Deardorff, which we discussed in an earlier article, perhaps the way to contact "primitive" beings such as humanity is from the bottom up, at the grass roots. Perhaps the way to ready us for contact is to foster the personal growth of each person - eventually reaching a critical mass of awakening to the Visitors presence.

In earlier articles, we discussed the phenomenon of psychic and spiritual awakening that seems to occur for the individual experiencer as he/she comes to terms with the phenomenon. We noted that for the newly awakened, signs of the phenomenon seem to include: a sudden shift in perspective to a more spiritual or metaphysical viewpoint, and less patience with the more petty aspects of human society in the face of the deep environmental and spiritual issues that our society faces. However, foremost for our purposes is the onset of psychic abilities and increased intuition. As more than one

experiencer has said, "It was as if my eyes were suddenly opened".

We have also noted that the CE4 phenomenon is just one of many possible drivers of such emergence. However, the result is the same, a form of both personal growth and interpersonal connectedness. Many of the awakened have described an increased sense of connectedness, as if (for better or for worse, voluntarily or otherwise) they were expanding out with their minds, forming psychic connections. Thus, as they grow, they seem, in some way, to interlink, each one becoming a node in an awakening network of a more interconnected humanity.

Barbara Marx Hubbard, in her book "Conscious Evolution,"⁽ⁱⁱⁱ⁾ describes this psychic networking in terms of Stuart Kauffman's theory of networks and self-organizing systems^(iv). Hubbard describes how, as nodes of any network become progressively more interconnected, at some point a critical transition occurs. The fundamental nature of the network changes. It is a phase change, like the formation of a crystal. The random disordered behavior of individual elements becomes that of a coherent whole. Hubbard theorizes that the ultimate result of progressive human psychic interconnection may be just such a transition - in which individual humans unite to become collectively awakened, a greater super-aware unity.

Many mental health and spiritual workers describe a psychic and spiritual awakening, which appears to be in progress^(v). In addition, many abductees describe these same experiences and this sense of interconnectedness with others. Might this be the early signs of such a phase change? Or to use the words of Barbara Marx Hubbard, could this be the start of the "conscious evolution?"

As we suggested earlier, perhaps the way to contact "primitive" beings such as humanity is from the bottom up, at the grass roots. Perhaps the way to ready us for contact is to foster the emergence of each person, for one person, two persons, then thousands, then millions - and eventually billions, building a critical mass toward the conscious evolution.

The Emergence of Humanity

To understand possible motivations and agendas for the Visitor presence in our collective lives, let's take a step back, and imagine that we can view humanity from their perspective.

1. Based upon cultural and historical considerations, we can suggest that large-scale contact would potentially be very damaging to the present-day human culture. In an earlier article, we examined the dangers of contact and suggested that as a whole, humanity is not yet ready to meet the neighbors.

2. Even a cursory look at human history shows that humanity is a fundamentally warlike being. In the present era, our largest single economic endeavor is war^(vi). During modern times, our history has been dominated by such cataclysms as World War 1, World War 2, and uncountable genocidal massacres^(vii).

3. Humanity has developed the capability for destruction on a planetary scale. We now have arsenals of multi-megaton nuclear weapons, which we could potentially unleash in a global barrage, resulting in gigatons of explosive power unleashed into the planetary environment. Thus, we now have the capability of destroying our world - and by extension, other worlds, as well.

4. Humanity may now be on the verge of developing interstellar flight^(viii). Advances in zero point theory^(ix), the understanding of gravity and other areas of physics^(x) suggest that within a few hundred years we might well have the capability to travel to the stars.

We can therefore imagine those in a cosmic civilization, which we presume to exist out there, asking whether we are the types of folks that they would want coming out into the neighborhood. In humanity's current state of civilization, I can imagine that the answer is probably "No". Yet, the recent rapid pace of human technological advance might provide the worrisome prospect of just such a premature human expansion.

Yet there are many humans (including myself) who believe that it is humanity's future to expand into space. Many now speak of a new manifest destiny: the destiny of humanity to expand to the planets - and eventually to the stars^(xi). If humans are indeed destined to go to the stars, then by that time, will we have changed our culture and habits? Will we have matured enough to realize that war is not the answer to our problems? Or will we simply begin building starships and carrying our warlike ways with us to the cosmos?

This question suggests an immediate ET agenda: to prevent our warlike race from prematurely spilling out into the stars; to provide quarantine and containment until humanity is ready for contact. The neighbors might consider it vital that we somehow be changed, tamed or civilized, in order to avoid the universal catastrophe that unchecked human expansion might bring. We can therefore imagine a hypothesized "ET Strategy for Earth" as a blueprint for human/ET relations, both now and far into the future. We can begin to understand that such an agenda would have a high priority for our cosmic neighbors.

The "Indigo Hypothesis"

We have discussed the phenomenon of psychic and spiritual awakening that seems to occur for the individual experiencer. In addition, we frequently observe that the Visitor experience seems to run in family lines. As I meet the families of experiencers, I have noticed that, in some cases, the characteristics emerging in newly awakened adults already seem to be present in their children. Many close encounter experiencers describe their children as gifted, psychic, deeply empathic, and other characteristics similar to those of awakened adults. As an informal observation, I have noted a disproportionately large number of such children among these families. I have wondered about the mechanism by which these children are awakened. Is it due to influences of the Visitors, or is there something else at work?

Earlier, we discussed the idea of genetic manipulation that seems to be a key focus of the abduction phenomenon. Budd Hopkins and David Jacobs argue that this is intended to create some form of hybrid being for purposes presently unknown to us. However, we can ask whether such re-engineered genes might somehow be integrated into the overall human gene pool for purposes we do not yet understand.

One variant of this genetic hypothesis is the theory that such a hybridization process is intended to breed a new human. One possible representation of such an advanced human is described in the literature as the "Indigo Child." This term is based upon the work of Jan Tober and Lee Carroll in their book, "The Indigo Children."^(xii) Wendy H. Chapman also describes the Indigo Children on the website: www.metagifted.org^(xiii). Both works describe these children as being deeply empathic, visionary, intuitive, and having a deep sense of mission and purpose. They seem to live with a thin veil between

the physical and spiritual worlds. Furthermore, they^(xiv) are often intellectually gifted, resistant to authority and endowed with a high degree of psychic ability. They tend to have difficulties with the more mundane, non-creative aspects of life.

Is there a correlation between the Visitor experience and the Indigo-child phenomenon? Might a "genetic agenda" of the Visitor phenomenon result in an increased number of such children?

This is what I call the "Indigo Hypothesis": That the genetic changes fostered by the Visitors might actually begin to appear in the general populace, in the new generation of humanity. We theorize hybridization changes by the Visitors being assimilated into the overall human gene pool, resulting in the emerging generation of "Indigo Children" that we see today.

What the true purpose would be for such a program of "human re-engineering" we could only guess. Nevertheless, we can speculate that as these children take their functional place in society, we might somehow begin to see a more "awakened" conduct of human affairs. Perhaps we might see a new humanity, more ready for contact and more accepting of an ET presence on earth.

Integrating the Models

Ultimately, is there a primary agenda behind the Visitor presence? We have so far considered a number of different models. Can we, with what we have learned to date, begin to synthesize an overall theory of the phenomenon?

We have discussed possible ET strategies for contact with humanity. To me, the most basic and all-encompassing model seems to be the Deardorff "Possible ET Strategy for Earth" - a hypothetical structured program of contact, which we can imagine that the Visitors might follow. Such a model suggests a slow, steady program of observation, limited contact at the grass-roots level, with gradual and progressive revelation of themselves as humanity adapts to their presence. It also allows occasional limited intervention should a situation on Earth become serious enough to so warrant. However, the ultimate goal of such an agenda would be to prepare Earth for eventual open contact and disclosure. This would seem to be the most basic paradigm for much of the overall activity of the Visitors, a framework for our combined hypothesis.

Within this framework, we can also see the nature-preserve (NP) metaphor as potentially being an accurate model of the on-going Human/Visitor relationship. We can envision a nature-preserve Earth in which extraterrestrial "naturalists" conduct research and perhaps manage the evolution of the indigenous human "wildlife." This model may serve as a framework to understand better what we now know as UFO abduction.

We have touched on the idea of humanity as a potential threat to the cosmic community. What can the Visitors do to prevent a dangerous humanity from spilling out in to the interstellar neighborhood? The obvious answer would seem to be to quarantine and somehow civilize humanity through contact and education. Ultimately, we can ask if it may actually be necessary to breed a more acceptable humanity. This suggests an immediate motivation for the genetic agenda as described by the Hopkins/Jacobs Model of UFO abduction - and leads us to an "Indigo Hypothesis."

At the individual level, the Visitors seem to foster a psychic and spiritual awakening. Simultaneously, they seem to be breeding some form of apparently more desirable characteristics into a new race of human beings. This suggests that the process is intended to engender a new humanity more acceptable to the cosmic community, our preparation for contact.

In the next article, we will carry our speculations into the future as we examine ideas of where the phenomenon is headed. So stay tuned and look for the next edition of "The CE4 Corner."

**Col. Jesse Marcel Jr.,
On & Off The Record**

RNU.com (Raiders News Update) - A new book by Col. Jesse Marcel Jr. - Roswell: It Really Happened - claims that the famous Roswell UFO event actually occurred, including the recovery of an extraterrestrial craft. Col. Marcel's famous father, Maj. Jesse Marcel Sr. was the lead military investigator into the crash of 1947 and is finally vindicated according to this book.

Without a doubt the 1947 Roswell, N.M. event is the paramount story of western extraterrestrial folklore. Some think whatever really happened there will never be known. The U.S. government says it was a simple case of misidentification. But as most people know, this wasn't the military's first position.

On July 8th, 1947 the Roswell Daily Record carried the RAAF release:

RAAF Captures Flying Saucer On Ranch in Roswell Region. The intelligence office of the 509th Bombardment group at Roswell Army Field announced at noon today, that the field has come into possession of a flying saucer.

Then something happened. The following day the newspaper featured a retraction by the RAAF:

An examination by the army revealed last night that mysterious objects found on a lonely New Mexico ranch was a harmless high-altitude weather balloon - not a grounded flying disk.

The contrast of statements by highly trained personnel set in motion the greatest cover-up in American history, says Col. Jesse Marcel, who is admittedly the only civilian alive to have handled the UFO 'debris' from the Roswell crash site. I set down recently with Col. Marcel and he shared information with me, on and off the recorder. I heard things I had never heard before from ufology's legendary friend. Marcel is almost 70 years old now, a soft spoken, gentle man who comes across as ultimately believable.

When I asked Jess, as he prefers to be called, if his father - the Intelligence Officer at Roswell Army Air Field at the time of the Roswell event - could have been mistaken about what was recovered during the field investigation, he answered without hesitation, "No way," he said, and then proceeded to tell me why.

When later I pressed about Mogul Balloons and Operation Paperclip as alternative theories, he shared at length the number of times he had joined honest investigators in a side by side comparison with his drawings and material examples and how each time not a single correspondent to what his father had brought home from the ranch that night could be found.

Getting to the big questions, I offered, "But of course whatever happened at Roswell, surely it could be explained as top-secret terrestrial technology, right?" As cool as silky water, he looked at me and replied, "Tom, what I saw was not of this earth. Though it was material, I held it in my hands, and the pieces were as light as a feather."

I gave Jess greetings from Stanton Friedman, who together with Bill Moore had brought the Roswell cover-up to international light many years ago, and then I said, "So you, like Stan Friedman, believe the Roswell debris were most likely a physical technology?" Jess smiled and told me how Friedman was such close family friend.

I'm not sure he ever did get around to answering my question about technology. But Col. Marcel, like

his father before him, is a career military man (he had just returned from Iraq where as an ear, nose and throat specialist he was busy patching up soldiers).

Over the years he's participated in field investigations of crashed known craft, and is very familiar with many hardware components. To this day he has never seen anything resembling the Roswell artifacts.

Marcel then proceeded to tell me an intriguing story about an incident that had happened some years ago, when he was scheduled to be in Washington, DC. To this day he doesn't know how the participants knew where he would be at that particular time.

When he arrived at his motel, there was a message waiting for him on the phone in his room. It was from a man we'll call Mr. "X". He wanted to meet with Marcel the following day, at 1PM in a certain room at the Capital building. Marcel felt uneasy, but agreed to go to the meeting.

On arrival, he was ushered into the office of Mr. "X", who got right down to business. "X" wanted to talk to Marcel about Roswell, and he asked if Jess would be more comfortable "in a secure room." When Marcel explained that he wouldn't be saying anything he hadn't said before, "X" pressed the idea of the secure room, explaining, "Well, maybe I want to tell you something you don't already know."

Leaving the office, they proceeded to the secure room where no listening devices existed, in an area Jess described as "the dungeons of the Capital building."

They sat at a table where Marcel noticed a book about Alien Abductions, UFO technology and Roswell. "X" tapped on the book with his finger and said outright, "This is not fiction."

The mysterious government insider continued talking for a while and then asked Marcel if he knew where the material recovered from the Roswell ranch was being kept. Jess found the question curious and said, "No. Don't you?" "X"'s answer was as curious as the question, so Marcel responded with a inquiry of his own:

"If extraterrestrial activity is real, and you guys know it, when is the government planning Official Disclosure of what really happened at Roswell?"

"If it was up to me," "X" said, "we'd be doing it now."

Following a story like that, I just had to ask Col. Marcel if he personally knew of other members of the government and military who also are anticipating a future moment when the representatives of the world's religions and leaders of nations will stand in the well of the United Nations and say, "We have an announcement to make. We are in contact with extraterrestrial intelligence."

Marcel grew silent for a moment, then looked at me and whispered, "Yes." Suddenly the phone rang, and Col. Marcel had to leave the building.

Court Limits Public Workers' Speech Rules That First Amendment Does Not Protect Every Whistleblower

WASHINGTON, May 30, 2006(AP) The Supreme Court on Tuesday made it harder for government employees to file lawsuits claiming they were retaliated against for going public with allegations of official misconduct.

By a 5-4 vote, justices said the nation's 20 million public employees do not have carte blanche free speech rights to disclose government's inner-workings. New Justice Samuel Alito cast the tie-breaking vote.

Justice Anthony M. Kennedy, writing for the court's majority, said the First Amendment does not protect "every statement a public employee makes in the course of doing his or her job."

The decision came after the case was argued twice this term, once before Justice Sandra Day O'Connor retired in January, and again after her successor, Alito, joined the bench.

The ruling sided with the Los Angeles District Attorney's office, which appealed an appellate court ruling which held that prosecutor Richard Ceballos was constitutionally protected when he wrote a memo questioning whether a county sheriff's deputy had lied in a search warrant affidavit.

Ceballos had filed a lawsuit claiming he was demoted and denied a promotion for trying to expose the lie.

Dissenting justices said Tuesday that the ruling could silence would-be whistleblowers who have information about governmental misconduct.

"Public employees are still citizens while they are in the office," wrote Justice John Paul Stevens. "The notion that there is a categorical difference between speaking as a citizen and speaking in the course of one's employment is quite wrong."

The ruling is significant because an estimated 100 whistleblower retaliation lawsuits are filed each year.

The Bush administration had sided with the DA's office, saying the government's desire to maintain an efficient workplace outweighs an employee's right to voice opinions about internal decision-making.

"When the government pays for somebody to do its work it has the absolute right to determine how that work will be performed," said Edwin S. Kneedler, deputy solicitor general.

Kennedy noted in his ruling that there are whistleblower protection laws. The ruling, which had the votes of the court's conservatives including new Chief Justice John Roberts, showed great deference to the government.

"Official communications have official consequences, creating a need for substantive

consistency and clarity. Supervisors must ensure that their employees' official communications are accurate, demonstrate sound judgment, and promote the employer's mission," Kennedy wrote.

He said government workers "retain the prospect of constitutional protection for their contributions to the civic discourse." They do not, Kennedy said, have "a right to perform their jobs however they see fit." The case is *Garcetti v. Ceballos*, 04-473.

Summary of Event: xxxx awoke around 3 A M to see a very bright light in the sky. She watched it for a while thinking it was a star but it started moving in a jaggy motion horizontally then vertically. She awoke her husband and he saw it to. Duration: about 10 min. till they went back to bed.

Location of sighting: Mpls, Hennepin County

Four separate bright white lights traveling across the sky, distort the light from stars as they pass.

On Saturday night, May 6th, 2006 at approximately 23:45, my two adult son's and I observed an unusual object moving across the sky. We were standing outside in an area devoid of light so that the evening sky was clear. We were in Winona, Minnesota. It was a beautiful night without a cloud in the sky.

A loose formation of 4 points of white light traveling from East to West were observed. The 4 points of light were of equal intensity, remaining constant at about the brightness level of a bright star. The 4 objects were separate, moving independently from one another, seemingly to dart about in a loose formation, all traveling together. As we stood near a tall industrial building, the objects were seen as they came over the roof of the building and then disappeared about 5 seconds later.

The most unusual thing about the objects was the area around and in-between them. The space around and between the objects of the formation seemed to ripple as though the light from stars in the background was being distorted. It was like a large bubble of water traveling across the sky, distorting the light, we could clearly see through it but distorted and rippling.

There was absolutely no sound, silent. Our first impression was that the objects were close. It then appeared that the objects were at very high altitude (or maybe not even flying near the earth) traveling at a very high rate of speed. Then, as the objects

flew to a point about 90 degrees from the initial sighting, they just vanished.

I'm 60 years old and have seen many strange things in life, but I've never seen anything like this before.

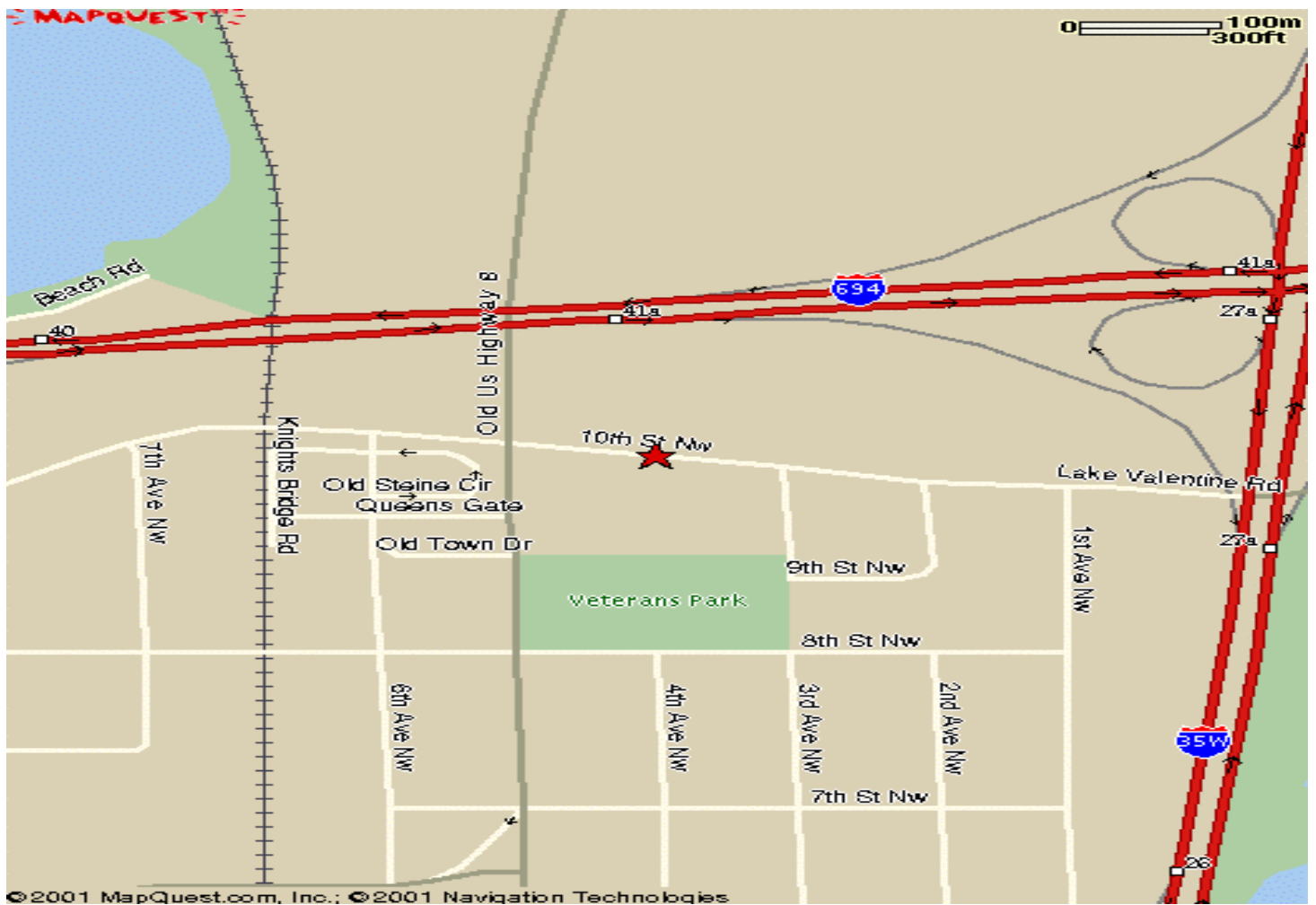
