

## NH. MUFON CASE LOG

July 12, 1991	2:00 AM	A Portsmouth, NH man had just returned home from work. While standing outside his home he observed an intense ball of white light. He was looking in an Easterly direction as the ball headed right toward him. It passed directly over his home and suddenly made a sharp angle turn to the South and disappeared. The sky condition was clear. It made no sound and was estimated to be twenty times the size of a star.
July 22, 1991		A Pittsburgh, NH. man called to report sighting several high altitude white lights. These lights were doing strange maneuvers such as darting back and forth, zig zaging and then shooting off in a straight line. This seems to be a regular occurrence up in the North country according to the witness. He has observed the lights on several occasions, most often between 9:00 and 11:00 PM He has also noted the lights move to a particular place in the sky and disappear.
July 27, 1991		Mr. Raymond Fowler Director of Investigations referred a possible abduction case to New Hampshire MUFON. A woman from New Durham wrote to Ray about her encounter. He indicated to her NH. MUFON would be her best course of action. She has not contacted us to date. If we don't hear from her in a few weeks I will make the first contact.
Aug. 13, 1991	2:45 AM	A Rochester, NH. woman observed a black flying wing while looking for falling stars with her nine year old son. The wing passed directly overhead with no sound or lights. She estimated the size as four to five inches if viewed between two hands at arms length. The shape was that of a boomerang with short wings and more rounded nose. She observed a slight white glow on the trailing edge of the craft. The first thing that comes to mind is the stealth B-2 aircraft. The problem with that is no lights, and what is the B-2 doing so far from it's home base. The night sky was clear. She observed the craft fly out of sight at less than six hundred miles per hour.
