Directors Message:

Our investigators are doing a great job getting out to interview witnesses and generating reports. This will be your chance to ask questions and interface with the investigators who did the actual on site investigations. UFO sightings have also increased in Maine. Congratulations to Sandra Black for passing the field investigator's exam. The exam is a good way for field investigator trainees to gain knowledge and expertise in the art of conducting an on site investigation. As many of you know NH Mufon with the help of **Paul Ray** has produced a **training video for UFO investigators**. It is the first in what we hope to be a series of training videos. Many of you will have received by now registration and convention information about the **CPR International Crop Circle Convention**. This convention was to be held at the Yoken's Convention Center on April 8th, 1995. It has been cancelled due to a number of reasons including very serious health problems for two of the speakers and the backing out of a major researcher and his data. This coupled with the announcement of a presentation by another Crop Circle researcher on the discovery of major hoaxing were the reasons for the can-

cellation. A letter from Colin Andrews explaining what happened is included at the end of this newsletter. **A refund will be sent to all who registered.**

Walter Friesendorf, Fran Geremia, and your director volunteered to produce the event for Colin Andrews and CPR. Not included in your information was the announcement that **Mr. Nick Pope** a higher executive officer of the **United Kingdom Ministry of Defense** was to address the convention. Believe it or not he has received **permission** from his government to discuss his involvement with UFO and Crop Circle investigations. We are now trying to see if he would be willing to speak at our September conference.

A word about our NH Mufon mailing list. NH Mufon will not sell, give or loan our mailing list to any person or organization for any purpose. This has been, and will continue to be our policy. The information you received about the CPR conference was generated and mailed by us.

Did the Feds confiscate film and video without due process here in New Hampshire? That's exactly what we are trying to determine right now. The following information was related to New Hampshire Mufon by a person of good reputation. We have no reason to doubt

the accuracy of his statements but must say there is precious little proof to back up his story. If this case is true it is another example of **official misconduct and intimidation**. On 7-14-94 a message was left on my answering machine stating there is something I should see. The time of said message was about 2:00 PM. I didn't get to return the call until the next day. When I returned the call I asked this individual what was up. His answer was a curt **"forget what I said"**. It was very plain he didn't want to talk so I ended the call and wondered what had happened. Approximately fifteen minutes later I received a call from this same person asking me if I would be home for the next hour or so. I said yes and he said I'll be there in thirty minutes. When he arrived it was obvious he had been through something very upsetting to say the least. The story related to me made my **blood boil** as it is just another case of **official intimidation** for no logical reason.

On July 14th 1994 this person I will call John, was at home. He had been contacted by an acquaintance who had referred an individual to him for having film processed by a private lab. The person needing the film developed, I will call Mike.

Mike arrived at John's home and asked him to have three rolls of film developed by a private lab. John agreed to take the film to the lab but before Mike left he showed John a **Video he had taken in Florida**. This video was taken a couple of days prior to this visit, near Pensacola and showed a silver disc hovering over an area of

water. It was a **clear daytime** shot showing the **disc hovering** near the water when helicopter noise is heard in the background. **Three helicopters** fly overhead from the back and head toward the UFO. The camera swings up to show a military helicopter with the side door open and someone holding and apparently operating a video recorder. We have what you may call a **video camera taking a picture of a video camera taking a video**. The three choppers head toward the disc, make a partial circle around it, when the **disc takes off** in a straight line. The choppers follow it out of sight. As you might imagine the takers of the video and 35mm film are quite excited about what had just happened.

We later found out it was two related families involved, two videos were taken as well as three rolls of 35mm film. The visiting family from New Hampshire (including Mike) decided to head back to New Hampshire due to the possibility of flooding conditions delaying a departure within the next few days. This would make the taping on or about the **10th of July**.

After showing John the video Mike departed. John called me, left the message on my answering machine and departed to deliver the film to the lab. He arrived back at his home some time later. After a few minutes there was a knock at his door. **Two men dressed in dark suits** were standing there. Parked in front of his home was a Black car with **Government plates**. The two men told John **they wanted the film** he had just been given. John refused stating the film wasn't his to give them and he didn't have it. The men were polite and left. **At no time did they iden-**

tify themselves or state why they wanted the film. John took careful notice of the Government plate on the car as they drove off.

Within a few minutes the two men were back. This time with Mike. One of the men said to Mike "ask him" Mike then said I have to have my film back. John stated he would have to get it. The men and Mike left with the understanding they would return later and retrieve the film. John then left and drove an out- of-the-way route to the lab and retrieved the film. **He didn't want anyone following him to the lab**. When he arrived at the lab the film was developed but not dried, cut or printed. He retrieved the film as is and returned home.

A short time later the two men returned but this time they had another two men with them driving a white car. All four men stood on the door step of John's home. After John gave them the film one man or agent or whatever he was **demanding the prints**. John explained there wasn't enough time for the lab to make prints. The film was looked at and the four men departed. Needless to say John got on the phone to ask his acquaintance what in the world was going on.

The acquaintance didn't want to talk to him, Mike doesn't want to talk to him. He is now left with no proof of what he saw and no proof of who the mysterious men were or who they worked for.

After hearing John's story I felt we must do something to find out what happened. I filed a FOI request

with the Government motor pool in Hooksett New Hampshire. After a few iterations of who what and where I was finally able to determine the car was signed out to the **USAF 3519 Recruiting Squadron**. We will continue to try and uncover what happened but there is very little solid information to go on. At the same time we were researching the car, I tried to see if the sighting had been reported to the local Mufon organization in Pensacola. All contacts were negative.

As time moved on we began to hear of a **second video taken at the same time** by a member of the other family. Allegedly, the other family has sold the video to someone who is in the process of making a UFO video for sale in the future.

Those of you who read the Mufon Journal will remember an article by Buddy Crumbley called the **Best of Gulf Breeze Sightings**. In that article there is a report of a sighting with a date of Mid-July and starting with the words "**During the middle of the afternoon**" That story is a direct result of my trying to find out about this case and talking with a person in Florida about this case. My question is how could my brief description of an **unsubstantiated** case end up as "**The Best OF**" anything? We continue the search for answers but it is chilling to know the Feds. (if it was the Feds.) are here in New Hampshire doing their thing **without due process and without regard to our privacy**.

News around the Network

A Roswell related event is taking place in England right now that **may blow the entire Roswell crashed saucer case wide open**. Allegedly a military person assigned to film the retrieval of crash debris, autopsy of the aliens and other related events **has sold duplicate reels of these 16 mm films** to a person in England. This person allegedly plans to make a documentary type show to be released some time in August of this year. This all sounds great but there are some **red warning flags up**. One such flag is, investigators made several appointments to view the film footage and the meeting was canceled each time. It is also hard to believe a military person assigned to film a classified event would be able to make duplicate reels without being noticed. Another unsettling point is the person who purchased the film for many tens of thousands of dollars has a reputation of being a bit of a shady showman. One interesting

positive point is, allegedly the film media was analyzed and found to be of the type used in the mid 1940's. Supposedly president Truman is seen in the film and it is said to show an autopsy in progress with the body covered with a sheet during the examination. This doesn't seem to be normal procedure. As Stanton Friedman said we must go slow on this one and do a thorough research job before celebrating the validation of the Roswell incident. There are indications this all may be an **elaborate hoax** designed to embarrass Roswell researchers. As some of you know **Stanton Friedman is one of our main speakers** at this years September conference. He is directly involved in trying to validate the film and evidence. **You can be sure** we will get a thorough briefing on this very interesting development at our conference. Stay tuned for further developments. If we get any more updates prior to our March state meeting I will be sure to pass the information along at that time. To quote Stanton Friedman "**It should be an interesting summer**".

Operation Right to Know is having another demonstration in Washington, DC. It will be at noon on March 29, 1995 in front of the US General Accounting Office, 441 G Street NW at 4th St. For more information call (202) 232-2410. The demonstration is in **support of Congressman Schiff** and the GAO inquiry. Congressman Schiff is trying to get information about the Roswell case released to his office for review. Operation Right to Know is also sponsoring a worldwide **petition signing** to

New UFO Case reporting procedure is now in effect by Walter H. Andrus, Jr. our international director. Due to the long delay involved from when a case is investigated to when it finally is reported in the Journal, Mr. Andrus has asked us to institute the following rules.

1. All members should mail UFO newspaper clippings of reported UFO sightings promptly to the headquarters office as potential leads on cases.
2. UFO sighting reports initially received by Mufon from all sources will be given to the **State Director** for each state for immediate assignment.
3. The State Director is expected to write a **short narrative report** on pertinent details and mail it to Mufon headquarters. The state directors now have a dedicated 800 phone number to relay these reports to headquarters.
4. The short narrative will be published in the journal "**Current Case Log**" with the designation of **under investigation or completed case**.
5. This new procedure is in addition to the normal reporting procedure and is designed to get current cases to the journal in a reasonable time.

CASE LOG

Date: Aug. 1956 - **Time:** 2200 Hrs.
Place: Jamestown, Colorado
Investigator: Robert W. Heslop
Description:

A woman was preparing for bed when she noticed what looked like the full moon but smaller. Suddenly it took off at a 45 degree angle at a high rate of speed.

Date: 15 Apr. 75 - **Time:** 2130 Hrs.
Place: Ent Berne, NY
Investigator: Robert W. Heslop
Description:

A man was driving home from school when he saw an extremely bright ball of light. He stopped the car and got out to get a better look at it. He observed a **saucer shaped object with many small lights** around the perimeter. It hovered about **200 feet** from him **not making a sound** then departed almost at the **speed of light**. The witness was shaking like a leaf when he arrived at home.

Date: 26 Sep. 76 - **Time:** 2315 Hrs.
Place: Manchester, MA.
Investigator: Dr. James B. Calvin
Description:

Three men on Manchester beach observed a red-orange ball of light high in the clear night sky. The object began to head toward them and stopped on the other side of a road over a field. It then changed from red-orange to brilliant white. A feeling of **communication** between one of the men and the object began when suddenly a police car rounded a corner put his blue lights on and proceeded toward a nearby carload of disorderly people. The officer apparently did not see the bright light across the field. As the police car approached the bright light changed back to red-orange and receded back toward the direction from which it had come. It then moved straight up to an altitude of about 4,000

feet, stopped, then moved out over the water where it joined two other objects, formed an "I" formation and left in a Easterly direction.

Date: 1979 - **Time:** 2100 Hrs.

Place: Bermuda

Description:

Two men were lying on the ground looking up at the sky. Without warning an object **materialized** out of air and flew overhead at an altitude of **20 to 30 yards**. The object was eight sided with a rectangular protrusion on the rear that glowed a light blue color. 4 red lights in a square pattern were on the bottom along with one white light. The protrusion seemed to be vibrating. It moved approximately 30 yards and **disappeared**.

Date: 79 or 80 - **Time:** Late PM

Place: Henniker, NH

Investigator: Robert W. Heslop

Description:

It should be noted that this was a **reluctant** witness and the investigator did well to get what little information we do have. A woman and her daughter were driving North on I- 89 when they saw a bright white light in the sky moving toward the WNW. They exited the interstate onto Rt. 9 heading toward Henniker. As they came to Keyser Pond they observed an **oval object hovering over the water**. It was at an altitude of **10 to 30 feet**. The witness did not stop and just drove on by.

Date: Fall 1981 - **Time:** 1800 Hrs.

Place: Stark, NH.

Description:

Two men returning from a hunting

trip observed a **triangle** shaped object with recessed white lights on the bottom. It was the **size of a house** and was accompanied by two lights nearby. The lights were the size of a small car and stayed close to the main object. One was red the other a transparent bluish color. It was observed at an altitude of 200 yards and slowly passed over a house as it moved out of sight. The only sound heard was a **whooshing noise** as it passed overhead.

Date: 3 Nov. 81 - **Time:** 1800 Hrs.

Place: Sutton, NH.

Description:

A man and his wife were driving North on I-89 when they noticed a bright white, and smaller pink light in the sky. These lights did not look like other stars. The whitelight seemed to be moving in a Northerly direction and getting closer to the highway. Soon the light was directly ahead, over the interstate and **coming directly toward them**. Suddenly the light went out. They stopped the car in the breakdown lane, rolled down their windows and looked up. The object was **nearly overhead**, completely dark and in the shape of a **trapezoid**. It was making a 180 degree turn to hover directly overhead. The altitude was estimated at 50 to 500 feet by the wife and 100 feet by the husband. **No sound was heard**. The object was very large and the edges hung well over the Northbound lanes. They estimated they were there for **twenty minutes** and noticed a friends car pass by who were going to the same function they were. The witnesses wondered why they didn't stop to see if they needed help. The object departed over the trees out of

sight and the couple **arrived twenty minutes late** for the function. During the function the friends who passed by asked **why** they were **stopped** on the side of the road. During the interview it was evident the couple has had strange encounters in the past possibly involving abduction experiences in the family. The husband is **not comfortable** discussing this aspect of their situation. Subsequent to this sighting the wife was working in her kitchen and observed a **huge disc** fly between her house and the Ham radio tower. **It was on edge as it passed the house** and out of sight.

Date: Jan 1982 - **Time:** 1730 Hrs.

Place: Ashland, NH.

Investigator: Dr. James B. Calvin

Description:

Two women driving south on I-93 noticed bright lights in the western sky. They pulled off at exit 23 and stopped the car. They observed a **disc** shaped object with a **dome** surrounded by **lighted windows**. The craft landed close to the car. They drove to the other side of I-93 to a gas station where they and the station attendant saw a **boomerang** shaped craft close enough to see **geometric** patterns on it. The women claim to have more than **two hours of missing time**. The two women claim to have had many other sightings including a sighting of the same looking domed craft in Meredith, NH. in April of 1994.

Date: 1984 - **Time:** 2100 Hrs.

Place: Concord, NH.

Investigator: Robert W. Heslop

Description:

Five young men drove to a place

where they could view a bright planet in the night sky. They had a couple of beers while watching what they **assumed** to be that **bright planet**. Suddenly the planet rose up and **flew directly toward them**. It passed over them at an altitude of between 40 and 120 feet. It made **no sound**, was **rectangular in shape** and estimated to be 100 yards long and 30 yards wide. There was an **intense bright light** on the front which obliterated any detail directly behind the light. It passed over the trees and out of sight.

Date: 9/ 88, 89 **Time:** 2030 Hrs

Place: Bradford, NH.

Investigator: Robert W. Heslop

Description:

Two men were walking along a dark country road when they heard a **tremendously loud constant noise**. They observed an object **larger than a house** moving from the South toward the North East. This object had many yellowish white lights. It passed over the tree line out of sight.

Date: Sep 1989 - **Time:** 20:00 Hrs.

Place: Bradford, NH.

Investigator: Robert W. Heslop

Description:

This sighting involves two couples approximately 2.2 miles apart on the **same day and time**. Couple #1 were relaxing in the back yard of their home. The man heard a very **strange noise**, turned toward the direction of the sound and saw an object approaching from the South West. He was startled as the object changed direction toward the East and then again toward the West. These direction changes took the object in a circle around

their home. At one point he observed several small objects with lights **exit** from the craft and fly off. The large primary craft departed in a westerly direction. His wife agrees on most of this except she saw it hover over the neighbors home and the small objects didn't come out of the craft. They **merged** with the craft. Exactly the opposite of her husband. Couple #2 were walking along the road near their home when they heard a **loud noise**. The husband describes it as sounding like a squadron of prop planes. A group of **twenty or more lights** were seen by the husband heading in an Easterly direction. It was too dark to get a good look at the outline as it departed over the trees and out of sight. The description of the object was **oval with a dome** and many lights around the edge.

Date: Fall 88-90. - **Time:** 0215 Hrs.

Place: Columbia, NH.

Investigator: Mike Leclercq

Description:

A woman had gone to bed around midnight. Around 2:30 am she woke to go to the rest room. Through her window she caught sight of a **bright light** in the Northeast. At first she thought it was a falling star. She watched as it erratically approached her cabin. Thinking it was a fireball she watched as the object **entered** the room through a closed window. **Three small beings** exited the ball of light. The woman now panicking and screaming heard a loud machine-like noise that hurt her ears. When she tried to cover her ears she realized her arms were **paralyzed**. One entity hovered close to her face and conveyed to her that she needn't be afraid. Another **stuck something**

into the end of her left ring finger. She has no memory of anything further that night. She had a **scar** on her finger for about ten days after. The next day she didn't wake at her normal time and had to be awakened by her son in late morning. When she got up she had a **very sore throat**. This woman has several people who testify to various parts of this event and all agree she is a stable person. She lives alone in a log cabin surrounded by woods on the edge of the Connecticut river.

Date: Mar. 1991 - **Time:** 1930 Hrs.

Place: Warner, NH.

Description:

A woman was driving Northbound on I-89 when she saw a bright white light going NW. It approached 3 stationary lights, **joined them, formed a triangle formation and headed South**. The witness saw a similar formation seven minutes later but it seemed to be at a higher altitude heading NW again.

Date: 23 May 91 **Time:** 2250 Hrs.

Place: No. Berwick, ME.

Investigators: Ken Foster, Greg Raymond, Ann Hebold of Maine Mufon.

Description:

A husband and wife observed a **large round object** with blue and white lights slowly moving over a lake. It then hovered over a house near the lake and then slowly moved out of sight. A **strange hum** was heard when the object was closest to the witnesses.

Date: 7 Oct. 92 - **Time:** 2000 Hrs.

Place: Bradford, NH.

Investigator: Robert W. Heslop

Description:

A call was made to Mr. Heslop by the NH Mufon state director informing him of a sighting in progress in his area. Mr. Heslop immediately drove to a good vantage point on Mt. Kearsarge thinking he might spot the object being seen. The night was very clear with unlimited visibility. He began to scan the entire horizon with a pair of 7X35 Binoculars. He spotted a light that seemed to be **brighter** than any others near the town of Bradford. Suddenly the light began to **flash** and began to **sweep over the landscape**. The light began to pulsate and then went out but appeared again **2000 - 2500 feet** in the air directly over the spot where it had previously been. It **hovered there motionless** for 5-10 minutes then began to move SSE. The light at this point was very intense and looked like it had rays coming out of it (**like a 4th of July sparkler**). It then slowly gained speed and left the area looking much like an ordinary twin engine aircraft except for the very bright light.

Date: 19 Dec. 92 - **Time:** 1900 Hrs.

Place: Tilton, NH.

Investigator: Robert W. Heslop

Description:

A woman riding in a car driven by her son saw two unusual lights in the sky. When the car stopped at a stop light she saw a **triangle shaped craft with multiple red lights** hovering over the power lines. They described the object as about the size of a standard car at about a distance of **twenty five**

feet. Her son couldn't understand why people in the other car **couldn't see it**. They immediately drove home. As they approached their house they saw another strange object hovering over their neighbor's house.

Date: 16 Feb. 93 - **Time:** 1800 Hrs.

Place: North Stratford, NH.

Investigators: Sandra Black, Kevin Eldred

Description:

A man was driving North on Rt. 3 when he noticed a light in the distance. His first thought was it was a snowmobile but as he got closer he noticed it was in the air. He then thought it was a plane in trouble as he saw **two large white lights** but realized a plane couldn't go that **slow and low** and remain airborne. He now became very curious and pulled his car off the road and got out for a better view. At this point he could make out other lights around it as it came closer. Another car pulled up and a man got out looking at the object. The craft slowed and **hovered over the river** for about three minutes. He estimates it was about a **quarter of a mile** away, about **500 feet** in the air and about **50 feet across**. It then turned side to side in a sweeping motion and moved slowly down river making no sound. The lights around it were mostly **red and yellow** with **two big white lights in front**. It appeared round with lights on the sides and the bottom. He made a remark to the other person who pulled up but got no response.

Date: March 93 - **Time:** 1900 Hrs.

Place: Bradford, NH.

Investigator: Robert W. Heslop

Description:

During the interview of the primary witnesses a State Trooper was present but **did not participate**. He was present during the sighting but refuses to be part of this investigation. The witnesses were outside their home when they heard a low **grumbling sound**. (It should be noted this family has had two previous sightings at their home.) This sound was like the sound heard previously. They became **very excited** as the object passed over their home. The craft was a **narrow triangle shape** with banks of white lights at each corner. A **blue light** was seen in the **center of the bottom**. As the craft headed toward Warner it shot a **white projectile** out of it's side. Two of the men jumped into a car and tried to follow it. They got as far as the Elementary School at the intersection of Old Warner road and Rt. 103 when the object returned to **hover over the School** and parking lot. The witnesses noticed the sodium vapor lights reflecting off the bottom of the craft. At some point they saw a white object being **absorbed** into the craft. A total of six witnesses observed this craft while at the home including a state trooper. It was also mentioned the craft seemed to change shape. Investigators note: A triangle shape rotated around an axis tip to tip will seem to change shape.

Date: 25 Mar. 93 **Time:** 2000 Hrs.

Place: Colebrook, NH.

Investigator: Sandra Black

Description:

A man was walking up a hill behind his apartment. He looked up to see an **object flying** low from the Northwest to the Southeast. It

made no sound. He called his mother - in - law out to see it. The craft was **half circle shaped** with a pink-reddish light blinking on the far right side and **white, red, and yellow lights around the edge**. His mother - in - law saw the craft but refused to admit what was seen. The object was moving slowly. This witness had a close encounter UFO event forty four days earlier in essentially the same place.

Date: 20 Sep. 93 - **Time:** 0530 Hrs.

Place: Colebrook, NH.

Investigators: Sandra Black, Mike Leclercq

Description:

A woman was taking her morning walk on Rt. 26 when she noticed what seemed to be a plane. The object turned toward her revealing a **large white blinking light in front and solid red lights on the sides** as it slowly moved toward her. The object was at **tree top level** as it passed overhead. It made no sound except for a **whooshing** sound when directly overhead. The shape was that of a **very large boomerang** 100 to 300 feet wide. There are three other witnesses to this event. Two other ladies also walking in the area that morning and one man riding in a car. All made reports depicting essentially the same type of craft. All four witnesses saw the craft at the **same time and in the same place**.

Date: Dec. 1993 - **Time:** 0400 Hrs.

Place: Clarksville, NH.

Investigators: Sandra Black, Mike Leclercq

Description:

A man got up at 4:00 AM to use the rest room. He noticed a very bright light from his bedroom win-

dow which faces the Northeast. The **light was moving all around**, up, down, side to side, in a circle etc. His wife also got up and saw the strange light. She thought the lights were flashing. As they viewed it they saw a diamond shape to the lights and suddenly **two beams of light** extended down. This beam effect lasted for about ten minutes. They viewed it for 45 minutes. This may have been a star. The witnesses said the light wasn't there the next night.

Date: 24 Dec. 93 **Time:** 0400 Hrs.

Place: Pittsburg, NH.

Investigators: Joanne St Pierre, Sandra Black

Description:

A woman who had a cold woke up and went downstairs unable to sleep. She observed through a picture window toward the Southwest a **flickering light** she took to be a shooting star. It started heading toward the house and became larger and larger to a size **larger than a car**. It was round and had white lights around it. The object passed over the top of trees on the south side of the home then changed direction toward the Northeast. She went back to bed where she told her husband what had happened and he confirmed he had seen white lights go by the window.

Date: 8 Feb. 94 - **Time:** 0416 Hrs.

Place: West Stewartstown, NH.

Investigator: Joanne St Pierre

Description:

A woman was driving her husband to work. As they drove down Bridge St. she noticed something about the size of a dime with red, white, and green lights strobing

randomly. It looked **saucer shaped** and was hovering in the Southeast sky. As she turned onto Rt. 3 she lost sight of it. As they approached the West Stewartstown dam she observed four strobing very bright lights. She estimated the lights took up 9 inches across the windshield. She thought the lights were **four separate objects** but said it could have been **one large object**. They lost sight of it as they drove out of view.

Date: 1 Mar. 94 - **Time:** 2130 Hrs.

Place: West Stewartstown, NH.

Investigator: Sandra Black

Description:

A man and woman were driving East on Main St. in W. Stewartstown. The two friends were discussing how clear the sky was when they observed a **bright white flash** over the rooftops to the East. They were discussing what they had seen when the lights started flashing again. The third time the lights flashed it seemed to outline a **large object low to the ground**. They drove in a direction to enhance their view but were unsuccessful. They estimate the object was 500 to 1000 feet from them. The woman saw what looked like a **dark outline** of an object but was unable to see a definite shape. It should be noted the witnesses are trained observers and were trying to get as much detail as possible.

Date: 1 Aug. 94 - **Time:** 0510 Hrs.

Place: Contoocook, NH.

Investigator: Robert W. Heslop

Description:

A woman was doing dishes in her home when she heard a **loud "Whooshing" noise** which made her

look up and out the window over the sink. She saw a **red orange beam of light** come straight down and then straight up as if it were a **solid object**. It encompassed a blue spruce tree just outside the window. There was a **rumbling noise so loud it shook the house**. Her husband came running from the bedroom asking "what was that". The electrical **power** to the home **flickered**. (**all the electronic clocks had to be reset**) The woman started **shaking and crying with a feeling of extreme happiness**. She is unable to explain this behavior because she is **not a crier**. During the investigation it was found a **neighbor also heard the loud rumbling**.

Date: 25 Aug 94 **Time:** 0008 Hrs.

Place: Colebrook, NH.

Investigator: Michael Leclercq

Description:

A man who had a previous sighting in the town of Colebrook was returning to his apartment late at night. He saw what looked like a small aircraft. As he watched the plane he had a feeling he should stay and watch the sky a little longer. In a short time he saw **four red lights** in a pattern similar to the big dipper. This pattern was much larger than the plane and appeared to **slowly rotate**. It was huge against the black starlit sky, about **four times the size of the moon**. As it rotated or rolled he was able to observe what looked like an arrow-head shaped protrusion on what may have been the front. It departed toward Dixville Notch with the witness trying to follow it East on Rt. 26. **No sound** was heard as it seemed to descend and move out of sight over the tree line. A second plane was sighted during the incident but it continued on its course.

Date: 4 Sep 1994 - **Time:** 2100 Hrs.

Place: Dalton, NH.

Investigators: Kathleen Marden, Paul Miller

Description:

A woman and her husband were banking their canoe on the shore of the Connecticut River with the help of her brother-in-law. As the men tended to the canoe she observed a **bright light moving rapidly** across the sky and then suddenly **stopping** over a power plant/paper mill in Gilman Vermont. The three adults were joined by a fourth adult and seven children. They all saw a steady white and red to light magenta pulsating lighted object. Over the next 30-45 minutes the object appeared to move in a slow south west to north east trajectory and then move rapidly back in the opposite direction. They also saw it ascend and descend during this time. A young girl in their party **shined a bright flashlight toward the object**. The response was a **beam of light projected** from the bottom of the object **toward the group**. The white beam crossed the river and **flashed across the witnesses**. The object remained silent throughout the encounter. It departed in a westerly direction and descended below the tree line out of sight. It should be noted that it was **very quiet** on the river that night. A dog's bark could be heard from the object.

Date: Oct. 1994 - **Time:** 0128Hrs.

Place: Sanbornton, NH

Description:

A woman was awakened from sleep by a bright light shining in her bedroom window. Her first thought was how bright the star was. She then realized it was much **to large to be a star** (the size of a golf ball at arms length). She got up and went to the

window and noticed the light went out completely. Then a smaller light appeared but further away. It too went out but the larger closer light came back on. The two light started flashing on and off **as if signalling each other**. The two lights then came on and stayed on with the smaller light moving to position itself directly over the larger light and both started **moving toward her home**. She opened the window to listen for noise but there was none. The lights continued to move toward her and **directly over the house**. She went to view them from another room on the other side of the house but they were gone.

Date: 17 Nov. 94 - **Time:** 2000Hrs.

Place: Warner, NH.

Investigator: Robert W. Heslop

Description:

It is a rare event when a trained investigator is called upon to investigate **his own sighting**. This is such a case. A man and his wife were taking their daily walk when the wife exclaimed with some excitement "**Look they're towing something ...No, what is that?**". They observed two large white lights connected with a thin line of **rectangular lights**. The lights were bent in a flat "**V**" shape with a **huge pulsing red light** on the bottom. This object was silently and rapidly moving across the sky **just below the treeline**. The distance is placed at 1 1/2 to 2 miles. Speed is estimated at 300 Knts. It was heading South West when it made a 45 degree turn to the South. It should be noted this observer is an **experienced pilot** and well aware of aircraft lights and configurations. The huge red light and bend in the rectangular lights

is not a normal light configuration.

Date: 30 Nov. 94 **Time:** 2005 Hrs.

Place: Nottingham, NH.

Investigator: Greg Raymond

Description:

A woman was driving on Rt. 156 when she suddenly saw a white ball of white light **pacing her car**. She lost track of it as a car approached from behind. A short time later she observed a **triangular or boomerang shaped object** with three red-orange lights at the corners and outlined by a white light.. It was high in the Northern sky as it passed directly over her car and out of sight. As soon as this happened another similar object appeared again in the Northern sky and remained in view until she reached her destination. She tried to get a friend to come out to view it but was unsuccessful.

Date: 10 Jan 95 - **Time:** 1850 Hrs.

Place: Bradford, NH

Investigator: Robert W. Heslop

Description:

This case involves several encounters in the same location by one witness. It is also an area where UFO activity has increased with several reports within a couple of miles. This report covers the most significant sighting. A man was home with his wife and child when he saw an object approaching from the west at an altitude of **300 to 400 feet**. There was **no sound** as it headed toward their home. A very bright white light shone in what is described as the window or the cockpit area. It was on the leading edge of a triangle shaped craft. This **window was a series of squares forming a wide rectangle** across the front. It should be noted that he could not see a distinct shape of the craft but was able to

approximate the shape and size from **stars the craft blacked out in a clear sky**. It passed directly over his home and departed in an easterly direction. Less than five minutes later he saw it again a short distance to the north heading in a westerly direction just below the tree line. The object then appeared on the same ground track as the first sighting that night, **heading right over the house again**. This time he walked to the end of his home, went outside, looked up and yelled as he gave it his traditional **one finger salute**. (He does not like low flying aircraft near his home) Just as he did this the object **started making a sound**. He said it sounded like "Turbo Fans." The object was moving very slowly (less than walking speed) but when it started making sound it accelerated and it passed directly overhead. This time he was outside to see what he described as **holes or cavities in the bottom** of a fifty to seventy five foot wide craft. He was able to **look up into these holes and see what appeared to be a ceiling**. Also on the bottom of the craft was a red beacon located between the holes. He called to his wife and son who came out and watched as it departed to the East. A check with local police revealed he is a respected member of the community and not subject to telling stories. As a side light to this sighting we find his older son had a UFO sighting in Milford, NH that same night. The son was driving along a secondary road when a **triangle shaped craft** passed over his car at a low altitude. He was able to see two white lights in front and red lights in each rear corner. The **corners of the triangle were rounded**. The time was about one hour after his father's sighting. ♦

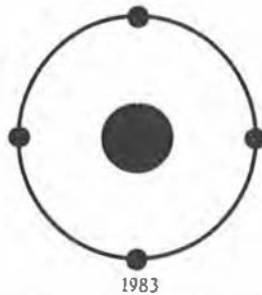

International Crop Circle Convention - Cancelled

It is with great disappointment and with many apologies that I have to inform you of the cancellation of the International Crop Circle Convention to have been held at Portsmouth, New Hampshire, USA on the 8th April 1995.

There were two primary reasons we organized the convention. The first was to give the American public and research community an opportunity to share the research findings and for the front line researchers themselves to present the best evidence available. The second was to raise funds for future research now that my own funds have been devoured by the last twelve years investigation.

Unfortunately a number of recent developments beyond our control would have seriously effected the quality of our advertised program and may have jeopardized even more the valuable funds beyond the \$4,000 loss that this cancellation has already cost.

Some of the factors which influenced my decision are as follows:

* A major 1994 hoaxing article written by George Wingfield and just published in the British Cerealogist, if true has serious ramifications and could place in jeopardy some of the scientific claims made by well known scientists.

George Wingfield falls well short of supplying conclusive evidence of his claims that numerous of the well known 1994 formations were man made. However the story must be carefully and urgently investigated.

* Two important speakers have developed health problems which could effect their attendance.

* Two large scale conferences have been planned to coincide with the Crop Circle Convention, including one in which George Wingfield is going to speak.

I therefor felt this was the prudent decision.

I wish to thank you very much for your support and I want to assure you that CPR will continue to reach for the truth surrounding the phenomenon and will keep you abreast of developments in the Newsletter, published quarterly (See details). We will include in the next issue, what was to have been said at the Convention by the senior British Ministry of Defence official.
