THE SAN LUIS VALLEY: UFOs, CATTLE MUTILATIONS, A CRYSTAL SKULL AND MORE... Christopher O'Brien and NM MUFON

Chris O'Brien spoke to NM MUFON on August 8, 1995 about his extensive research into the many anomalies found in the San Luis Valley of southern Colorado and northern New Mexico. Chris has completed the manuscript of a book entitled *Mysterious Valley*, which will be published by St. Martin's Press and available in late Spring, 1996.

Though Chris is a leading researcher of cattle mutilations and other anomalies, he stated that "I'm not an expert. I'm a diligent investigator and researcher. But if how confused you are is relative to expertise, then I guess I'm an expert," he said.

There has been a recent flowering of public interest in the paranormal, he says, but he has had to ponder what the nature of reality is. "Everyone sees things slightly differently, so you can't take perception at face value," he maintains.

But is the public interest in the paranormal media induced? There are many more TV programs now than there were three years ago.

Chris told us a little about himself. He grew up in Washington State and he had an experience when he was seven where he became lost and was later found dazed and walking in the wrong

direction. It might have involved aliens, he's not sure. But soon after the incident, he stared piano lessons which led to a professional carer in music.

He said he had a sighting of Bigfoot on Mt Shasta in California in 1979. In addition to seeing it, he heard it howl and could smell it, too!

Chris said he believes something is going on beyond our everyday Newtonian paradigm and that is what drives him.

The cattle mutilation phenomenon is misnamed, according to Chris. He says "I'm not an expert.

the term *cattle mutilation* is not accurate and is too sensational. He prefers UAD--unusual animal death, because it's not just cattle that are found. He feels that many UADs are misinterpreted or misidentified scavenger action. And some are media-induced hysteria, as Kenneth Rommel has said. "But there is a real phenomenon, a true mystery," he said. "Our job is to gather data and practice good science," he added, "And a veterinarian and a pathologist are needed in every case to get a definitive answer."

Chris said the best approach is to automatically assume a mundane explanation unless you see something unusual, like a cow in a tree, for instance!

Chris summarized the history of the phenomenon from the early 1970s to the present. He continued on page 2...

gave credit to Tom Adams of Paris, Texas, "the father of mutology," who he said has helped him immensely with this research. He also mentioned receiving help from Gary Massey and David Perkins, other well-known researchers.

Chris spoke of many suspicious elements in the cases that occurred through the years on or near the Taylor Ranch in the San Luis Valley. He said there is a good deal of evidence to suggest that Taylor was doing some stealing, shooting and mutilating of cattle himself. Why were certain ranchers singled out? Several were teachers at the same school. Chris's theory is that the mute phenomenon is partly explained by deliberate societal manipulation for certain political and social agendas. He says there are also some hoaxes and some copy-cat cases. But there is clearly a lot more going on that just predator action.

As in most research and investigation, one looks for patterns. "But in the mute phenomenon the patterns often raise more questions than answers," he noted. The mystery itself will supply data to support and negate the pattern. "When you think you've found a pattern it will change to the exact opposite and go into randomness," he said. For this reason, Chris thinks the mute phenomenon is reflexive—we are involved.

Chris related the story of "Old Scratch," a demon-like entity seen in New Mexico cantinas during Lent for many years. His opinion on this is that the (Catholic) subculture may co-create this manifestation. He noted that there is a rich tradition in the San Luis Valley of mystery hitchhikers, shape-shifters, weeping women, etc., as well. Chris suggested that maybe we are seeing the creation of mythos with all these phenomena, including the mute phenomenon, as Carl Jung postulated. "Maybe technology is stealing our myth and we're part of creating new myths," Chris offered.

Chris added that this could be a subtle process that has always gone on, has always been a mystery and all cultures have been subject to it. He concluded his talk with a reminder to always keep an open mind and try to look at things in new ways.

The Q&A period mostly involved the crystal skull which he said surfaced just as he was looking for an exciting ending for his book. Chris affirmed that the people who discovered it in a field near Crestone are credible and are not interested in money or publicity. The skull, 6½" x 3½", is asymmetrical, and is made of poured molten glass. Someone from the Museum of Natural History in Denver looked at it and found no microscopic evidence of a mold being used, and no seams have been found. Whatever it is, the artifact "is an

incredible work of art," Chris said. "And it seems to be designed to elicit a response from whoever views it," he added. People either are fascinated or repelled-by it. Unfortunately, he had brought along no pictures of it.

Someone asked about lights seen coming from the Great Sand Dunes in Colorado. Chris showed a photograph of huge shafts of light beaming into the sky from the dunes. Bigfoot tracks have been found there, and there are often strange aerial objects seen nearby. He told us that Dr. Altshuler (Denver pathologist who works with Linda Howe on mute cases) claims to have been abducted while on a visit there.

Chris discussed the NORAD incident (January 1994) near Greenie Mountain, Colorado. He has investigated this case and there are sychronistic parallels to another case which occurred exactly eleven years before near Gallup, NM. This earlier case was investigated by Tom Adams.

I know we all enjoyed Chris's presentation. It was refreshing to hear someone as articulate and enthusiastic as Chris is and we wish him all the best in the future.

DAN DeMAR ON ANCIENT EGYPT AND THE GREAT PYRAMID

Most of our local group know Dan DeMar as the NM MUFON State Director. Some of us know that he owns a successful insurance business and that he is a metallurgical engineer. But few people realize the depth of knowledge and expertise Dan has as an amateur Egyptologist.

Dan has been fascinated with Egypt since child-hood and has been studying the mysteries of Egypt and the Great Pyramid for many years. He has made two trips to Egypt, most recently in February, 1995 with the Association for Research and Enlightment (the international organization which studies the writings of Edgar Cayce, based in Virginia Beach, VA).

Dan addressed NM MUFON on August 24, 1995. It was a sweltering evening at the Sandia Center, but everyone was treated to an excellent lecture illustrated with many slides. Dan also showed rare video footage which he took *inside* the Great Pyramid.

He used many facts and figures to explain the geography of Egypt, the layout of Egyptian temples, the ancient Egyptian beliefs and myths, the pantheon of Egyptian gods and pharaohs, and some Biblical parallels.

Dan also gave a fascinating explanation of the composition of the blocks and stones which make up the Great Pyramid and other ancient structures. He believes that there is good evidence that the stones may have been "poured," that they may have been somehow cast rather than carved.

He mentioned that there is a contemporary process to do it now using geopolymers which harden better than cement. But how did the ancients do it? Did they have knowledge of zeolites and ionization? This is an amazing idea since those ancient stone blocks are extremely hard, even after more than 6,000 years.

It is a little known fact that harder stone and more primitive tools were used to produce finer workmanship in the early stages of Egyptian building. How can that be? Another method of construction (i.e., casting) seems to be the answer.

Dan spent some time discussing the Sphinx. He feels that water marks clearly show the Sphinx to be possibly *much* older than conventional Egyptologists say. The existence of a secret chamber, a hidden door and some mysterious knowledge may soon be revealed there, he speculated.

The idea that *transfiguration* was probably the goal and destiny of the ancient Egyptians seems to suggest that the Great Pyramid was not a burial chamber at all but a site where initiation and transformation took place.


Dan drew a diagram of the chambers and shafts inside the Great Pyramid and explained how it might have been a place where an initiate was obliged to go "out of his body" in order to complete the proscribed journey.

Dan said that he feels that OBEs are a key to understanding reality as well as what lies outside our everyday world. He feels certain that the ancient Egyptians knew much more than we do about the nature of life and death. The incomplete rituals and beliefs that evolved after early Egypt are all half-truths which attempt to bring about the original transformations.

Meditation, according to Dan, is a very important tool for accessing this greater reality. It may be the key to understanding the great mysteries and anomalies in the world. Who knows, it may be the key to understanding UFOs as well.

Haut doubts alien autopsy film is real

After viewing footage of a reported alien autopsy, Walter Haut said Thursday he wasn't convinced it was real.

There are too many big question marks in my mind, said Haut, the curator of the International UFO Museum and Research Center. "The way the autopsy went, it didn't look like what you'd expect an autopsy to be like. "I'm very skeptical," he added.

Haut saw the short film at his Roswell home with a fourmember film crew from Culver City, Calif. The crew interviewed Haut and shot footage for a Fox television special.

Executive Producer Robert Kiviat said he is investigating the footage he received when he contacted the film's owner Ray Santilli. Kiviat interviewed Haut about his experiences with the Roswell Incident.

Haut was the public affairs officer at Roswell Army Air Field and sent out the 1947 press release saying that a flying saucer had been recovered.

Kiviat is trying to determine if the film is real.

This is potentially the most important UFO-related breakthrough that has occurred in my five plus years doing network television shows," Kiviat said.

Aside from Haut, Kiviat has also spoken and shown the film to Stanton Friedman — a nuclear physicist in Fredericton, New Brunswick, Canada, and a Roswell Incident investigator — numerous other UFO investigators, pathologists and Eastman Kodak

"I want to cover the material as thoroughly as any journalistic news source would in the time that we have." Kiviat said.

"If it turns out to be a hoax, then our Fox special has basically lent a hand in unraveling it, and that would be a great service to the world at large and the UFO research community in general," he said.

"It could be the most important evidence of extraterestrial life, or the greatest hoax of the millennium," Kiviat

Some Roswell incident records missing

Government documents a New Mexico congressman says might have shed light on the Roswell incident 48 years ago were destroyed without explanation, according to a congressional investigation.

The Government Accounting Office reported Friday to Rep. Steve Schiff that it learned some government had been destroyed and others had not

Those destroyed included records between March 1945 and December 1949 and outgoing messages from October 1946 through December 1949.

The Roswell incident occurred in June 1947 when a rancher discovered what seemed to be crash debris on a neighbor's ranch. Initially the Air Force issued a press release claiming to have recovered a "flying disc," but that was retracted and officials said it was a weather balloon.

Since then the event has taken on a life of its own, with claims that debris of an alien spacecraft was recovered and even that the Air Force spirited away the bodies of alien beings.

Schiff recently watched a film that purports to be an au-

topsy of an alien, which he suggested looked authentic.

The GAO investigators did uncover some documents that refer to the incident. One report "noted the recovery of a 'flying disc' that was later determined by military officials to be a radar tracking balloon."

In 1994, after an exhaustive search of its records and interviews with scientists and private investigators, the Air Force said the evidence indicates that the Roswell crash debris came from a surveillance balloon - part of a secret project to spy on the Soviet Union's nuclear weapons research and testing.

"I have 10 pieces going in the show," Carolyn says. "They are all figures - and all have postage stamps. I consider (stamps) art, and I like working in miniature."

too) are all smaller than 8 inches by 10 inches. She sells them for \$225

"When I do models," she says, "I take a little traveling art studio with me. I do my sketches, then come home to finish them off. Also. I pick things up off the ground. Junk - pieces of paper." She laughs. "I'm basically a bag lady."

Carolyn and her husband, writer and attorney Jim Ashe, moved to New Mexico from Northern California in December 1991. Her career in art has been heading someplace for many years, and she believes it might have come home

She says she's been in some kind of art "all my life." Born in Utah and raised in Placerville, Calif., Carolyn found herself dancing in professional ballet at the age of 12. That sent her into serious dancing and to a bachelor's degree in ballet and theater at the University of

"In my 20s and 30s," she says, "I taught dance and performed. I had my own dance school for eight years in Paso Robles. I taught at Hancock College, then moved to San Francisco.

Then, when she was 38 years old. she contracted arthritis.

"I couldn't dance anymore or choreograph anymore," she says. "I'd always had an interest in art, so I started taking classes. I connected with some really good teachers and took classes for five years. I had to have some way of expressing myself."

These classes included independent study in Biot, France, and Siena, Italy.

Her work is sold in galleries in

San Francisco and San Luis Obispo, Calif.

"I've combined a number of elements that all suggest the theme," she explains, holding up what is called an artist's box. It is basically a small box with a clear plastic front so the viewer can see

"It lends itself to combining things. In music, it would be theme and variation. Basically, it's another thing to do if you're into miniatures'

She also does what she calls an artist's book, which consists of pasting comic book panels onto pages in a French book. There is alse a book of pop-ups (when you open the page, little boxes and shapes unfold in front of you).

If this weren't enough to keep Carolyn busy, she also edits two newsletters on UFOs, "The View From Hermit's Peak" and "NM MUFON News." The latter focuses heavily on the incident at Roswell.

"I like the mystery of it," Carelyn explains. "I'd like to be part of finding out the truth."

In the meantime, she asks the questions and concentrates on creating beauty.

"I think art functions as a reflection of society," she says, "so that's a way I can contribute. The environment is fragile and society's in flux, and maybe somewhere down the line all that will be left is a few pieces of art.

"Let's hope the art, the good art, will endure '

Subj: Dark Suckers - Revisited

Greetings to All-

At the request of some friends on the echos, I have re-posted this for your "enlightenment" er, your "endarkenment." It is not intended to offend anyone, but to bring some levity. Enjoy.

A LIGHT IN THE DARK DELL LABS PROVES THE EXISTENCE OF DARK SUCKERS

For years it has been believed that electric bulbs emitted light. However, recent information from Dell Labs has proven otherwise. Electric lights do not emit light, they suck light. Thus, they now call these bulbs Dark Suckers. The Dark Sucker Theory, according to a Bell Labs spokesperson, proves the existence of dark, and that dark has a mass heavier than that of light, and that dark is faster than light.

The basis of the Dark Sucker Theory is that electric light bulbs suck dark. Take for example the Dark Suckers in the room where you are now.
