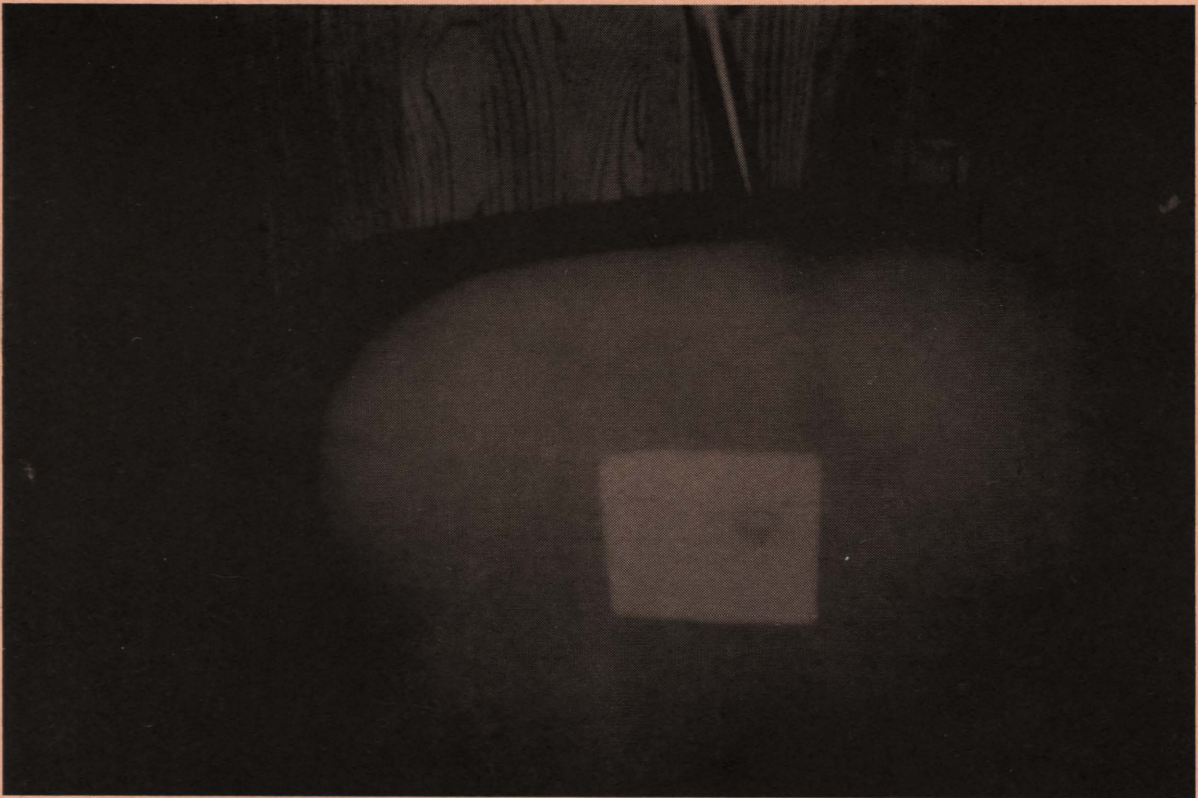

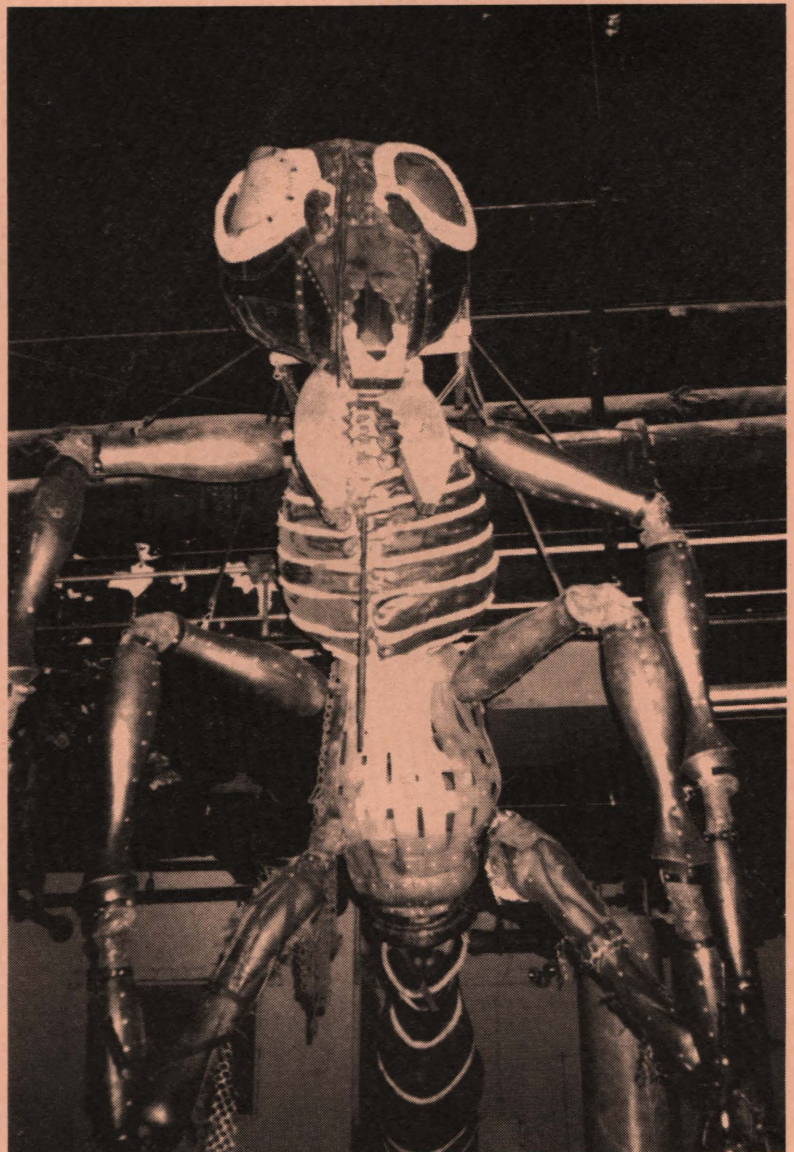

## EDITORIAL

In honor of All Fools Day, this April 1995 edition of the newsletter will not deal with the Roswell ufo crash which allegedly occurred in 1947. This is because the recent, clamorous focus on obtaining "fresh" evidence of an event which occurred fifty years ago in an open outdoor location is basically delusive.

According to a report by Donald M. Ware, Puerto Rican journalist Jorge Martin gave a talk at the 4th Annual International UFO Congress Convention which contained material on small "alien" creatures seen under various circumstances in 1993 in Puerto Rico. He showed the audience a photo of a preserved creature said to be an alien and two photos of what appear to be live aliens. As well as this photo display, Sr. Martin had collected numerous anecdotes from his area about UFOs which came up from under the surface of the water, the unusual; mutilation of goats and sheep and the transformation of balls of light into "beings" and images of aliens on a television screen.

There has been quite a bit of recent "ufo high strangeness" activity in locations other than Roswell, New Mexico. Whatever may actually be the source of Jorge Martin's "alien photos" and underwater ufo anecdotes (as one example), no one but an inner circle of ufologists has ever heard of them. Yet we incessantly have the red herring of "Roswell debris" taking up space in newsletters, journals and videos which purport to be

monitoring the vital signs of ufo research.

If anyone running a journal on current medical research featured only controversy related to the rival polio vaccines of fifty years ago, one might justifiably question the motives and sanity of this focus in an era when AIDS is the illness which is causing a public health emergency.

Perhaps the focus on the 1947 Roswell red herring is inadvertent. But perhaps it is not such an innocent diversion but is being encouraged by clandestine research interests which do not want attention paid to unexplained ufo activity in the waters near Puerto Rico and in other more obscure South American locations.

Obviously, the large metallic hornet seen on the page opposite this editorial is a stage prop. It seems ex cathedra as if the photos exhibited by Sr. Martin and others who claim in recent years to have caught glimpses of an alien presence on film must also be fakes. Yet how can we be sure of whether or not these photos are "genuine" unless we bring "high strangeness" artifacts and anecdotes forthrightly forward and examine them? In addition, when "evidence"--as in the Roswell case-- gets sufficiently damaged in handling, a true readout on related issues should also be declared to be damaged beyond retrieval, and investigative focus should be placed on other evidence which has some possibility of yielding solidly-documented positive (or discernibly negative) results relative to an enhanced understanding of the ufo reality.

April 1995

On March 26, 1995, the second episode of this year's ENCOUNTERS series on FOX made a very strong case for the existence of a military suppression of information on UFOs. A tape of this program is on file at the Magick Mirror office. The information given during the broadcast was mainly about radar and eyewitness sightings by pilots and meteorologists. There was a brief section about John Mack's research on abduction but this was minimized in favor of the testimony of professional eyewitnesses to the sighting of unidentified aerial objects.

On two subsequent Sundays, ENCOUNTERS was not broadcast.

On Monday, April 10, the editor of this newsletter telephoned the 800 number of the Berkeley Group and asked for Andy Schatzberg, who had co-ordinated the taping of various individuals scheduled to be on the new ENCOUNTERS series.

A receptionist at first denied knowing Mr. Schatzberg but then told this editor abruptly that Mr. Schatzberg no longer worked for that production company and that the ENCOUNTERS series had been canceled.

Although a section of the recent ENCOUNTERS episodes involving vampires was very poorly done, the "ufo cover-up" material was actually good documentation. It is obvious that we need not return fifty years into the past to experience a forceful "editing out" of material on UFOs by the "powers that be".

If you see a ufo, get your own documentation in the form of photos and on site taped statements from witnesses. Make copies of this evidence and hang on to the originals yourself. Remember that even broadcasting executives who deal with this material may be subject to confiscation of materials ufo witnesses have volunteered to them for purposes of documentation.

## BUILT IN CONTRADICTION

On the FOX program ENCOUNTERS aired March 26, 1995 various persons discussed the relationship between concepts of Darwinian evolution and the theory that extraterrestrial intelligence has been regularly tampering with the process of natural selection. At one point in the discussion, it was suggested that "alien" advanced intelligence was using genetic tampering to keep the human race at a lower level of evolutionary progress.

The fact that natural selection, if limited to a materialistic view of human cognition, actually gives an inadequate explanation of the advance of global civilization does not necessarily imply the negative intervention into human progress by extraterrestrials.

Possibly, beings active on other informational planes of this planet do regularly participate in the mundane progress of human life by inducting ideas which cannot be accounted for by a simple, material examination of the circumstances of the individual who is manifesting these ideas through the medium of diagrams or the printed word.

In standard, Darwinian evolutionary thought the neural center at the back of the neck is named the "reptilian brain". It is assumed that as the brain evolved from controlling an amphibian to controlling a mammalian body this rudimentary neural center the "brain" of snakes and lizards--was then surmounted by the larger mammalian brain contained within a bony skull..

If this is so, then we are--as we develop during the fetal gestation period which is said to mimic physical evolution--for a brief period of time all reptiles with a gill structure. But does fetal development actually mimic evolution away from the reptilian prototype or are we basically amphibian beings who have adapted to dwelling on the dry land?

If the human species is developed from a basically amphibian prototype, then the "reptilian aliens" described by "ufo contactees" may actually be a version of our own species attempting to contact us from past and/or future times. This possibility throws an entirely different light onto the "reptilian contact" claims.

Also, there exists a different idea of "evolution" from the linear, Darwinian (or non-Darwinian) model. This is basically the "evolution of patterning from a hierarchy of energy levels" described in various systems of mystical teleology, most notably the ancient Parsi teachings. This view of development can be most simply described as the "seed" theory. Within the seed is the program for development of an entire organic entity. This same entity will look and function differently at different stages of its natural development. The same can be said of the basic one-celled organic "seed" which results from the union of ovum and sperm. All of the "DNA" programming is there is the one-celled organism initially but this individual will look and function quite differently during different

phases of its larger developmental pattern.

Thinking of the human species as a larger entity composed of many different "individual cells", it can be understood that, in teleological terms, the concept of evolution "from" one species "into" another is quite deceptive.

This collection of individuals is always the same species, developing from the same shared "seed" prototype which can be considered at different phases of its entire development or by taking a topological view of its entire timespace patterning. At all phases of its development, an organism is potentially "aware" of itself and its proper functioning within the larger panorama.

A sapling "knows" it will grow larger and become a fully developed tree. In fact, that is why it exists: in order to grow. Perhaps the "lesson" of the "cropcircles" is simply that entire patterns may suddenly come to exist which have no linear developmental sequence but which embody as a whole some actively cognitive meaning.

On April 4, 1995, after a morning during which I was heavily afflicted by conflictive thoughts (see **VANISHING PUBLISHER**, page 9) concerning an unusual situation then being experienced by George Andrews in Europe, I discovered an odd, seed-like object which did not show up well in the photo on the cover of this issue.. It is a pink, brittle oval about 1/4 inch in length with a dark raised center the size of a poppy seed.

Just after noticing it on the office couch, I joked about the possibility that it was a "fairy subway token" or "fairy money" and decided to keep it. Perhaps money came to mind because I had noticed it beside my purse after returning from an errand during which I mailed off bills and transferred money at the bank.

Earlier in the day I had noticed a more ominous, perhaps humanly-constructed, talisman in the form of a red/green/purple striped rubber pompom on the floor of the lobby of my apartment building, and ( sensing a fey or bolexing intent behind this floor-decoration) had photographed it.

I do not claim to understand at the moment what all of this "talismanic" activity on April 4, 1995 might "mean" but I here record it as

a journalist because it may be that persons studying the ufo reality have overlooked significant hard data which "did not fit" pre-established paradigms of what "physical ufo evidence" might be. Maybe, as one example, the tiny embossed disk I found beside my purse is actually meant to indicate a "flying saucer".

Also, the fact that this small disk does not show up under the flash from a small camera whereas the nickel beside it does show up in recognizable form may indicate that energy fields associated with this disk are indeed unusual.

This is subtle. But other odd "cues" I have experienced recently are not so subtle.

#### YOYO DYNE

On Monday, April 10, as I was on my way back to the office after picking up the black and white photos featured in this issue at a local fast photo service, I was startled to notice that a man walking ahead of me down Sixth Avenue was wearing a white jacket emblazoned with the black letters: "YOYO DYNE PROPULSION COMPANY". The reason this startled me is that "Yoyo Dyne" is a humorous name from a little known novel by Thomas Pynchon entitled THE CRYING OF LOT 49. Very few people know about the content of this novel in any detail. But only a day before I had mentioned "Yoyo Dyne" to a technically-oriented person in the Magick Mirror office after he asked me what the actual meaning of the word "dyne" (which is a unit of electrical force) might be.

Applying the principle of Occam's razor, the simplest

explanation for my seeing a man provocatively wearing a YOYO DYNE jacket just one day after mentioning this obscure joke to a trustworthy person within the Magick Mirror office is that the place where I now write is bugged with electronic surveillance equipment by people who thought I might "follow" Mr. "Yoyo Dyne" either physically or mentally. But the people attempting to delude me made a crucial mistake. In Pynchon's novel, "Yoyo Dyne" is not a "propulsion" company. It is a parody of an "IBM-like" corporate organization. I recognized shortly after the "Mr. Yoyo Dyne" sighting that the word PROPULSION on the jacket might refer to Peter Moon's compulsive research into the death of rocket scientist Jack Parsons. I had, a few weeks previously, spoken to Moon on the telephone and we had agreed that he would show me a videotape he was vending about "men in black."

It is hard to imagine "why" anyone would take the trouble to pull off this strange charade based on a casual conversation about a parody of "black world" corporate possibilities (which is the basic theme of Pynchon's short novel) but it is also hard to imagine why anyone would invent the town of "Ong's Hat", New Jersey., which was mentioned in a previous issue of this newsletter as being an invisible community connected to clandestine Ivy League research into topics involving "mind control.". But, of course, I am aware that this all could be said to have been simple "synchronicity".



## ASHTAR

### A Book Review

A complimentary copy of ASHTAR compiled by Tuella was recently received at our offices. This is billed as "revealing the secret identity of the forces of light & their spiritual program for earth". Yet early in the volume the messengers of light are identified as warrior angels and likened to the Allied forces which fought under the direction of General Dwight D. Eisenhower during World War II.

Is the metaphysical reality of warrior angels being used in print for a limited purpose? Further, does the possible literal reality of etheric beings such as "Ashtar" also call into question accounts of "ufo crashes" involving physical vehicles which are dependent only upon contingencies of this particular four dimensional continuum?

In the information about the "Ashtar Command", it is stated that because of the etheric nature of the physical bodies of the beings who desire to assist the population of Earth they are able both to "shape shift" and to time travel in a way which is not possible for human beings incarnate in a material and/or astral body.

If this is true, then skepticism arises about the physical "capture" of an advanced etheric being after the crash of a ufo vehicle. Either the "alien" who was physically captured is not an advanced etheric being OR the tales about capture of small, gray alien beings mask some other complex reality, such as a disinformation and/or "mind control" project.

It cannot be overlooked that in the opening section of ASHTAR, which is published by Inner Light Publications, the etheric warriors of the interplanetary forces of light are limited in characterization by being likened only to Allied soldiers of diverse terrestrial nationalities.. In the final section of this book, originally published in 1984, the reader is urged to use meditation techniques before voting in the United States presidential elections, the better to make an enlightened individual decision.

It is stated elsewhere in this volume that the interplanetary "Ashtar Command" has a subtle way of assisting and protecting those good soldiers who listen telepathically to this particularly identified channel of advanced mental guidance. While this discussion of "etheric" beings who are trying to assist with the political and social evolution of this planet may very well contain a grain of truth, the context within which such encouragement is enunciated looks suspiciously partisan.

Is the "Ashtar Command" active only in terms of the United States political process and, if so: why? Or is a limited interest group "using" in print generic paradigms of behavioral guidance they have observed among UFO contactees and choosing to print only a very select "channeling" content which would tend to limit the scope of the ideas and issues possibly dealt with by "telepathic, etheric messengers"?



One of the original, genuine volumes of information from highly developed telepathic, etheric intelligences communicating through a human channel is entitled STEP BY STEP WE CLIMB and was received through the spirit medium identifying herself in print as "M.S.Princess". This individual was at one time resident in the Mount Shasta area of California and was visited by a diverse number of persons during the time she practiced there.

The following is a selection from the chapter "An Elohim Comes To Earth's Aid" as communicated by the extraterrestrial entity "Arcturus":  
*I HAVE BEEN TRAVELING FREELY IN THE ATMOSPHERE OF YOUR PLANET FOR SOME DAYS EXAMINING THE SITUATION WHICH EXISTS HERE...IN TRAVELING ABOUT YOUR PLANET, I HAVE OBSERVED MUCH CAUSE FOR DISCORD, MISUNDERSTANDING BETWEEN NATIONS, BETWEEN RACES, BETWEEN RELIGIONS AND CREEDS, BETWEEN MILITARY CLIQUES.... TOO LONG HAVE THERE BEEN DOUBTS HERE IN THE UNITED STATES OF AMERICA AS TO WHAT IS THE RIGHT COURSE AND WHAT IS THE WRONG COURSE... THE CRY OF THE PEOPLE OF EARTH, THE DESPAIRING WAIL THAT HAS COME UP FROM THIS PLANET, IS BEING ANSWERED BY THE GREAT WHITE BROTHERHOOD. (Historical note: "white" is used in this context as a term denoting the emanation of clear light .It is not intended to refer to skin*

*color or racial identity.) YES, WE WILL COME FORTH. IF NEED BE WEARING BRIGHT ARMOR AND CLAD SO THAT ALL MEN MAY KNOW US, SO THAT THIS WORLD MAY RISE TO ITS PREDESTINED PLACE OF PERFECTION AND THE UNIVERSE GO FORTH ON SCHEDULE...NOTE: ARCTURUS IS ONE OF THOSE GREAT COSMIC BEINGS KNOWN AS ELOHIM. THE ENTIRE HUMANITY OF THIS EARTH OWES HIM A GREAT DEAL...ARCTURUS IS THE MASTER IN CHARGE OF A GREAT SOLAR SYSTEM, WHICH SOLAR SYSTEM IS BEYOND THAT WHICH IS KNOWN TO US AS THE STAR ARCTURUS.... HE IS NOT A STAR. AS SUCH BUT RADIATES HIS CONTROL OVER THAT STAR AND THE PLANETS AROUND IT. THERE IS A RELATION BETWEEN THIS SOLAR SYSTEM AND THE SOLAR SYSTEM WHICH ARCTURUS REPRESENTS."*

The difference between the beings described in the recent book ASHTAR and the being Arcturus described in the book STEP BY STEP WE CLIMB , which was originally published in 1977, is that the being "Arcturus" gives us a definite forwarding address which is not within this solar system. Perhaps we should do some astronomical research to check out this location. (See page 12)

As to the very earthly and traceable "military" origins of the material on "allied" intergalactic legions found in the book ASHTAR, there is only one reason possible for the "use" of references to "etheric"

beings and effects by persons affiliated with government intelligence agencies.

This is simply that these "etheric" effects--shape-shifting and alteration of mass density--have actually been observed by trained individuals employed by the military and that therefore a certain interest group within the armed forces may want to severely limit the civilian interpretation of these observations.

However, the telepathic cat was out of the bag as early at 1977, and no thinking individual need worry that the Elohim are limited to the "Ashtar Command"



#### IMICH PRIZE CONTEST NO. 5

Dr. Alexander Imich is pleased to announce the final results of his contest No. 5 for papers contributing to the understanding of the interaction between the UFO phenomenon and humankind. The contest was sponsored by the Society for Enlightenment and Transformation of the United Nations. By the June 30, 1994 deadline, 84 entries had been received from Belgium, Canada, England, France, Ireland, Japan, Mexico, Panama, Russia, Switzerland, Ukraine and the United States. After reviewing the entries, the panel of judges composed of Antonio Huneeus, William P. LaParl, Dr. Bruce Maccabee and Jean Luc Rivera decided to divide the \$1,000

winner's prize between two contestants: Mr. Nicholas A. Reiter and Mr. Martin S. Kottmeyer.

Important, though dealing only with a technological element of the ufo phenomenon, was the entry of Dr. Harold Puthoff of the Institute of Advanced Studies. He stated that future technological developments might shorten the time required for interstellar travel without the violation of the apparent velocity of light limitation.

Ed. Note: This press release is printed verbatim. If Puthoff wishes to explain more clearly, he is welcome to send material to this journal.

The press release continues: Since the ontological reality of the UFOs is still not formally established, it may have been too difficult an assignment to explain the interaction between the UFO phenomena and humanity; none of the entries were able to master this task.

## VANISHING PUBLISHER

Author George C. Andrews has contacted the newsletter office with a strange tale which is here excerpted for the reader:

"About a week before I flew from St. Louis to Paris on December 11, 1994, Ron Bonds of Illuminet Press phoned me to say he had just received a letter from a French publisher wishing to publish a French edition of my book **EXTRATERRESTRIAL FRIENDS AND FOES**. As soon as I got to Paris, I went straight to Editions Ramuel at the address indicated, which turned out to be the apartment of Eric St. Clair and Francoise Burel. After about an hour of discussion on these matters, I felt that I was among friends, and signed the contract.

In January I put together a bundle of books and documents I thought might be helpful to them in promoting my book and brought it to them. They clearly understood that the material I left with them was a loan, not a gift, and offered to buy some of the books from me, difficult to find in France. I said we could discuss that later.

I think it was on February 10 or 11 of 1995 that I visited Eric and Francoise for the last time. I walked around town a bit with Eric, who seemed in normal health, certainly no athlete and maybe a little pale and high-strung, but functioning more or less as usual for a man who appeared to be in his early forties. He was aware of the danger involved in publishing such controversial material.

He had already contacted media people about this project. He

did not mention their names. The publishers were both all geared up and ready to go, encouraged that an interview I had done on February 7, 1995 for "Radio Active" based in Hyeres (a town in South France) had gone well. They did mention an intention to move from Paris to the country, without specifying when or where. We parted on the best of terms.

I think it was on February 22 or 23 that I phoned and Francoise asked me to phone back in a few days because Eric was sick. She didn't sound particularly alarmed. I assumed it was indigestion or a cold or flu. It could have been either February 25 or 26 that I phoned back and got Francoise in a state of total panic and despair. Eric was not only in the hospital, he was in the reanimation room of the hospital. He had already been declared clinically dead, but they had not yet given up trying to revive him. It didn't seem appropriate when she was in such a state of anguish to probe for details, so I just said I hoped they succeeded in reviving him, and if I could be of help in any way to let me know. I waited a couple of days and phoned again, but there was no answer. No matter how many times I phoned at all hours, still no answer. Then the phone no longer rang. Instead there was a taped message that this number "n'est pas attribue" (does not correspond to a subscriber). I went to their apartment but it was empty and their name was no longer on the door or the list of tenants for the building. There was no forwarding address."

This tale which George Andrews narrates is definitely a newsworthy occurrence. However, despite extensive written research into the ufo enigma he has done relatively little "hands on" investigative work on site. It did not occur to him in his initial description of this perplexing disappearance that the "publishers" he met in France might not have been simple human beings in difficulty but either MIB-like entities impersonating human beings OR human beings "overshadowed" by an interdimensional mental force which caused them to become ill and depart from their apartment without a forwarding address.

As it turned out, on April 20, 1995 it was discovered that publisher Eric St. Clair had actually been uncommunicative due to personal stress while relocating his business. If Andrews had followed his initial impression (as quoted) he might have taken extreme action damaging to himself and his French publisher.. The roots of this incident may lie in mind-bending negative telepathic techniques.

As Erich Aggen has pointed out in his Classified Communications for March 1995, the situation of the investigators into ufo and high strangeness situations being "grabbed" mentally by some aspect of their subject matter should be openly and straightforwardly discussed. There is no way to prevent this effect. But the true context of the investigator should be added to the data base of the high strangeness situation under consideration.

In April of 1994, while on the way back to his farm in Missouri from the Ozark UFO Conference in Eureka Springs, Arkansas the same George Andrews whose French publishers have just vanished from their apartment was involved in a "missing time" episode while investigating the "spook light" phenomenon near Joplin, Missouri.

He telephoned the Magick Mirror offices in New York in the early hours of the morning after returning to his farm, and described how he had been a passenger in a car following a ufo-spook light along a road in bright sunlight and then instantaneously found that the sky was dark and that an hour of time between afternoon and evening was "missing" from memory.

Subsequent to this "missing time" experience there was heated, emotional debate between Andrews, the other occupants of the car who had also experienced "missing time" and bystander witnesses who claimed that no time had actually been missing.

Perhaps the odd, intense reactivity generated by this "missing time" incident has origins within the original "spook light" experience and is not just a soap opera side effect. If this is so, the illness and emotional stress experienced by the publishers of "Editions Ramuel" may be in some way similar or related to the oddly accentuated emotional stress which was experienced after George Andrews and his fellow ufo buffs encountered a spook light. Maybe Missouri "spook lights" are as alchemical as Parisian publishers.

### **EAST HAMPTON UFO LIGHTS**

During January 1995 ufo lights were seen over the ocean near East Hampton, Long Island by a local homemaker, Karen S., who videotaped what appears to be an ameboid glob of light which changes size and divides itself rather than having a lateral aerial path or trajectory.

In a confidential interview with this newsletter, the witness revealed that her cue for first observing these lights, which were seen on at least two occasions, was not strictly visual but involved waking at a certain hour in the early morning under unusual circumstances.

Details of the witness' report are not given in this brief announcement in order to prevent "copycat" claims. The videotape, which was verified by psychologist Dr. Jean Mundy, is on file in the **MAGICK MIRROR-NYC MUFON** office.

### **COSMIC JOURNALISM**

**MAGICK MIRROR** attempts to show issues of high strangeness from various perspectives. No article, except sometimes the editorial, attempts to state only one dogmatic point of view. Rather, an inclusive, speculative approach is deliberately employed to deal with phenomena which are multi-faceted and cannot be discussed or explained within conventional journalistic constraints.

### **SOUTHERN UFO SIGHTINGS**

During March 1995 there has been a heavy incidence of ufo activity in Northern Arkansas, Southern Missouri and Tennessee.

According to Arkansas ufologist Lucius Farish, people in these states have been seeing both solid craft which appear to have a structure and "ufo lights". A large triangular object has been seen at a low altitude as well as disk-shaped craft at a low altitude.

Several groups of people, traveling cross country to attend the yearly **OZARK UFO CONFERENCE** which is held in early April have, in recent years, experienced episodes of "missing time". Persons traveling from Illinois to the Ozark conference of April 6, 1995 experienced time dilation at some point in their journey and discussed this experience when they arrived in Eureka Springs..

Robert Stone, a hypnotist from Florida, and his wife experienced an episode of "missing time" on their way to the Ozark Conference in 1991. They were later regressed by another hypnotist and Mr. Stone reports the experience of having stored childhood memories awakened in context of probing his "missing time" memories. It is Robert Stone's opinion that the vibrations around the ufo beings are so high that they alter the perceptual consciousness of the human beings who encounter them. For this reason, people may have conflictive, distorted or partial memories of genuine encounters with the advanced intelligence which is behind the ufo phenomenon.

## BEYOND ARCTURUS

Since the "extraterrestrial" consciousness "Arcturus" (see page 7) claims to be from a location beyond the star Arcturus, this interstellar address should be checked out by terrestrial intelligence. Arcturus is the 4th brightest star in the sky and is 36 light years from this solar system. It can be seen at the base of the kite-shaped constellation Bootes (called Nekkar in Arabic) which contains six other stars.

One of these other stars, Izar, is a triple star about 103 light years from this solar system. With the exception of the star Muphrid, which is 32 light years from this solar system, all other stars of the Bootes constellation are at least as distant as Izar.

"Arcturus" has stated that the interstellar beings now observing this solar system come from beyond Arcturus. Astronomers on Earth have detected that there is a "radio source" within the area of the constellation Bootes, designated 3C 295 in the Cambridge Catalogue of Radio Sources compiled by radio astronomers at Cambridge University in England under Sir Martin Rile. This source of non-visible radiation was located within about twenty seconds of arc and has an apparent size of a large planet rather than a star.

However, it has been discovered that 3C 295 has an extremely large red shift when photographed with conventional radio telescope techniques and appears to be receding at about 36 percent of the speed of light.

If this measurement is true, the discernible light from 3C 295 has been traveling toward this solar system for about five billion years. A being reaching this solar system from the area of 3C 295 would therefore have to utilize techniques of "time travel" we do not yet scientifically conceptualize, or be five billion years out of date at the time of arrival.

However, reversing this "light year" paradigm, it may be that this particular planet "Earth's" technological development is actually five billion years out of date. Possibly intelligent beings from other solar systems located in other galaxies do know how to utilize time-related energies in order to efficiently explore the cosmos.

"Synchrotron radiation" generated by the motion of electrons held in place by magnetic fields within a small particle accelerator was discovered by surprised technicians at the GE. Laboratory in Schenectady, N.Y. in 1946. This form of electromagnetic radiation does not have spectral lines and does not obey the rules of quantum behavior.

Do we, then, accurately map the timespace of the cosmos with instrumentation designed to detect basically spectral and/or polarized light frequencies? Is the structural energy released by the electron under torque in magnetic fields actually a trace of the "ether" which has been postulated as the multi-dimensional "patterning" energy which generates "gravitation" and areas of varying timespace density?
