#### Yellowstone Super Volcano Threat

Dr. Bruce Cornet and others are warning that an eruption of a volcano could occur. Volcanologists calculate that in parts of Yellowstone the ground has risen over seventy centimeters this century, and parts of the park are now off limits to tourists. Scientists have revealed that Yellowstone Park has been on a regular eruption cycle of 600,000 years. The last eruption was 640,000 years ago...so the next is overdue. The next eruption could be 2,500 times the size of the 1980 Mount St. Helens eruption. Fish are floating dead in the streams, and the lake is closed. There is a very strong smell of sulfur that is often a sign of the impending eruption of a volcano. Animals are migrating out of the area and new geysers and mud pots are springing up daily. ### **Ohio Flying Triangle Sighting**

SEAMAN, ADAMS COUNTY -- Kenny Young was contacted on the Cincinnati UFO Hotline to report a tremendously large object seen around midnight of September 13, 2003. Mandy, a 21-year old along with her mother, her sister and one of her friends saw a huge object off Route 32. They observed a triangular-shaped formation of lights on one large object. The lights flashed in sequence and would simultaneously alternate in color from pinkish-red, blue, white to yellow. There were 4 or 5 lights on the outer edges of the

triangle facing downward that flashed as a row of lights. The flashing effect was vastly different than the twinkling of a star. The colors would change in unison, all red or all yellow, etc., and would flash along the outer edge of the object in a slow sequence at first. Then the flashing sequence escalated in speed after several minutes into the sighting. The UFO was not quite as big as a full moon, and it hovered above Belfast for almost an hour at an elevation less than 45 degrees above the horizon. Mandy's mother, who is skeptical about UFOs, decided to have her report the object because it seemed to be so unusual. Both her sister and her friend are skeptical about UFOs, but could not identify the object. Coyotes were heard howling ridiculously loudly during the sighting, and also the previous evening. # Strangely Lighted Field

I received a report from a 72-year old male from Columbus, Ohio, regarding a very peculiar event he experienced on Sunday morning, December 02, 2003, at 06:40 am while deer hunting. He had just arrived at his deer stand for bow hunting, somewhere east of Columbus, when a nearby 20 or so-acre of field lit up like it was daylight! He stood and watched the light for several minutes, and then he noted two other lights "roaming" around the field!! He assumed that the land owner, a friend of the witness, had illuminated the field with a spot light, but a subsequent query to the landowner by a sheriff deputy ruled that out. Also, the witness checked the perimeter of the field on foot, and then on a 4-wheel vehicle, and he found no traces of footprints or tire tracks.

This gentleman said that as he was in his deer stand suddenly a light shined down on this large field of 20 plus acres of corn stalks. He said the light had a pinkish tone to it. Along with this light were 2 orbs of light the size of baseballs that he first thought were lights from quad runners. However, he was no more than 50 yards away and he soon realized it was not any type of vehicle. There was no sound and nothing attached to theses lights. The lights roamed up and down along the perimeter of the field about three feet from the ground and acted as if they were looking for something. All this time the one main bright light still shined on the field. The farmer was not in the light. The event went on for approximately 10 minutes. The orbs moved on out of view and the main light shut off. The farmer said he was not frightened by all this but now he wishes he had looked up at the sky to see where the main light source was coming from.
