P4 has placed him in safehouse somewhere near Edwards. I don't even know the exact location. No transfer will be approved until Phase I in NPP. CAP-3 not ready to receive EBE-2. Don't even know if they have facilities available for holding. CLASS YY-II only available at Kirtland or Los Alamos. Must make decision before Jan 15. No other options open.

NORAD not cooperating with MJ4 on D-SITE studies. We may have to contact KERW-302 personnel and have them conduct study. NORAD still operating on old system. The big problem is only a few of NORAD's personnel are clear for SONG-DANCE info.
