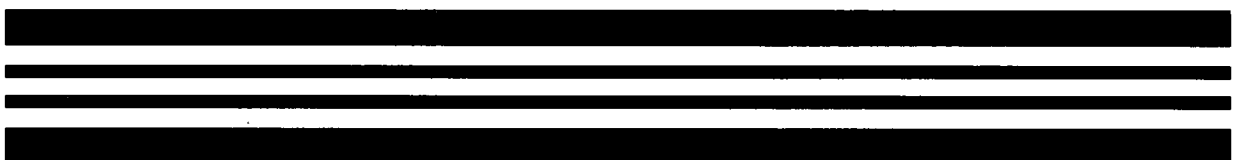

ROSWELL INVESTIGATION

The Hynek Center For U.F.O. Studies (CUFOS) is currently conducting a new inquiry of the possible crash and retrieval of one or more of the Roswell, New Mexico in 1947.

SETI MJ II: MORE THAN MEETS THE EYE!

In my last Newsletter I began the story of a government project called SETI/MJ which is currently active at the AMERICAN INSTITUTE OF PHYSICS at one or more of their locations.

AIP has one well-known, and two not so well known, locations. I, initially, found SETI/MJ to be active at one of the not so well known locations. AIP is, basically, a publisher of physics journals, but it is a well-known fact (on Long Island) that they are also involved in sensitive research for the U.S. Government. Of course, if you ask them they will deny this fact.

Although this investigation is moving slow, I have uncovered some interesting facts. Although I will not reveal the exact location where I found AIP to be working on SETI/MJ, I will mention another which might be the main installation for this project.

A.I.P. has a facility resembling a large office building at 255 Executive Drive in Plainview (coincidentally, at the base of Mount Misery!). A Technical Informant told me that there is an ultra-secret facility located beneath this building where most of AIP's sensitive work is either performed or based. explained. A scientist or government official might give me a simple explanation, relating to common earthly things or phenomena; but it would prove nothing to me. One keeps on wondering.

How far have I gone into "studying" about "UFOs"? The most recently made film I saw was "2001". Otherwise, no interest. TV series like "Star Trek" and similar fiction I never watch; to me, it's trash.

MOORE & MJ PROVEN FRAUD?

It would appear that the final nail has been driven into the proverbial coffin of Bill Moore. Bill Knell of the Long Island Skywatch announced Wednesday, September 27th, that he and his investigators have finally cracked the SETI/MJ riddle, and the answers aren't quite what Moore would have us believe.

During UFINET's hour long monthly radio show, Knell announced that his group found that SETI/MJ was not an organization of twelve men as current UFOlogy legend would have us believe, but rather, a sophisticated communications network designed to monitor UFO investigators and supposed Contactees. Knell went on to explain that while one of his "Technical Informants" was doing work on a computer system, he accidentally accessed a program that dealt with SETI/MJ in great detail, and that none of the detail showed any reference to Moore's twelve scientist or a government body who's specific purpose was alien relations, or possible agreements or treaties.

Knell however, did not discount the possibility that the government was aware of aliens (of an extra-terrestrial nature), and that perhaps it had alien artifacts, bodies, and other related material in its possession.

However, he does believe that the material that Moore has been presenting is fraudulent.

In order to present a factual account of Knell's investigation, he has agreed to submit to UFINET a record of the investigation and whatever evidence he

has to support his claims. "The Pegasus" will present this evidence in its next edition.

With this additional revelation concerning SETI/MJ, it would appear that the roof is finally and completely coming down around Bill Moore's head, and that he can no longer hold up the beams of controversy that have surrounded him for so long.

In all fairness to Bill Moore however, we are printing a letter that was supposed to have been sent to Bill English. Oddly enough, this letter was never received by English through the mails, and this was a copy of the letter that was supposed to have been sent to him. Apparently Moore sent a copy to Bill Knell of the LIS group in a letter to him.

In a conversation between English and Knell, Knell stated that several days later he received another letter from Moore stating that he, Moore, received a letter from English, in response to Moore's letter to English.

Things become curiouser and curiouser.....English wrote Moore a letter shortly there after stating that he didn't know what Moore was trying to do but that Moore should stop immediately. English has yet to receive a reply from Moore.

Dear Bill:

Thank you for sending me a copy of "Pegasus". Aside from the material about me on page one, I was most interested in the pledges you make in your "policy Statement" which appears on page three—especially those you make about using "factual information" and "not allow(ing) character assassination."

I do not know why you seem to harbor so many negative feelings about me, or what I may have done to offend you. Whatever it is, you certainly seem to be very hot under the collar about it.

However, I did note in listening to a tape of your Las Vegas speech that you made a distinct call for unity and an end to the in-fighting in the UFO field. You will recall that I made a similar statement in my presentation. On the strength of that, added to the fact (as least as I recall it) we once got along quite well, I would
