



We have Project Grudge Status Reports 1 through 12. A report numbered 13 has not been located among these files.

We have not located any references to "Document B-55207/76", or "DC-5C", "Project Sigma", "Project Massey", or "Project Snowbird" among the records of Project Blue Book in our custody. A United States Air Force memorandum dated January 11, 1955," on "Exercise Snow Bird" that related to joint training in the employment of Army and Air Force units under artic conditions was found among the records of the Joint Chiefs of Staff in our custody.
